Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of National Beef Represented Employees Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the National Beef Represented Employees Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan was a defined contribution plan sponsored by National Beef Packing Company, LLC (the "Company") for the benefit of all employees who had been employed for 12 months in which 1,000 hours or more were worked and who were subject to a collective bargaining agreement which provided for coverage under the Plan. Participating employers of the Plan were National Beef California, LP, National Carriers, Inc., and National Beef Leathers, LLC. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was administered by the Company's Employee Benefits Committee (the "Committee"). The Committee had overall responsibility for the operation and administration of the Plan. The Committee determined the appropriateness of the Plan's investment offerings and monitored investment performance.

Plan restatement - Effective February 18, 2022, the Plan was restated in accordance with the Internal Revenue Service ("IRS") cycle 3 restatement window. The IRS determined that the pre-approved plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and informed FMR LLC (an affiliate of the trustee) of such in a letter dated June 30, 2020. The plan administrator adopted the preapproved plan and believed that the Plan and related trust were operated in compliance with the applicable requirements of the IRC.

Contributions - Each year, participants could contribute up to 100% of eligible compensation as pre-tax or Roth contributions, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who were making contributions to the Plan, were allowed to make catch-up contributions as defined in the Plan. Participants directed the investment of contributions into various investment options offered by the Plan. In the absence of participant direction, contributions were invested in age appropriate default funds. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. The deferral rate for such participants was 4% of eligible compensation. For the years ending December 31, 2023 and 2022, the Company matched 50% of deferrals up to 4% of eligible compensation. The Company may, but is not required to, make a discretionary nonelective employer contribution in an amount determined by the Board of Directors. For the years ended December 31, 2023 and 2022, the Company did not make a discretionary nonelective employer contribution on behalf of employees. Contributions were subject to certain IRC limitations.

Participant investment account options - The Plan offered various pooled separate accounts and a stable value common collective trust as investment options for participants. Each investment option had its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants could change their investment options at any time.

(1) Description of plan (continued)

Participant accounts - Each participant's account was credited with the participant's contribution and allocations of (a) the Company's matching contribution, as well as the discretionary nonelective employer contributions, if any, and (b) plan earnings (losses), and (c) charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting - Participant's contributions plus actual earnings were 100% vested immediately. Employer contributions were subject to the following vesting schedule:

Notes receivable from participants - Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bear interest at rates which were commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions.

Payment of benefits - On termination of service for any reason, a participant could elect to receive a distribution from the Plan in either a lump sum amount equal to the value of the participant's vested interest in the participant's account or a partial withdrawal. The Plan also allowed for in-service withdrawals in the case of hardships or attainment of age 59 ½.

Forfeited accounts - At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0 and \$4,627, respectively. These accounts were used to reduce future employer contributions or pay administrative expenses. If any forfeitures remain, such forfeitures were to be reallocated to participants. For the years ended December 31, 2023 and 2022, employer contributions were reduced by \$4,507 and \$792, respectively, from forfeited nonvested accounts. Plan expenses of \$131 and \$23 were paid using forfeitures for the years ended December 31, 2023 and 2022, respectively.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(2) Summary of significant accounting policies (continued)

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

(3) Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Cash in transit
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Pooled separate accounts: Valued at the Net Asset Value ("NAV") of units of the separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Stable value common collective trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

In accordance with Subtopic 820-10, the pooled separate accounts and the stable value common collective trust were measured using the net asset value per share (or its equivalent) practical expedient and have not been classified within the fair value hierarchy.

(a) Withdrawals from the fund for benefit payments and participant transfers to noncompeting options will be paid to plan participants within thirty days after written notification has been received and are considered as made immediately after the next valuation date subsequent to the trustee's approval. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require a twelve-month advance written notice.

(5) Related party transactions and party-in-interest transactions

Certain Plan investments were units of pooled separate accounts and a stable value common collective trust managed by Principal. Principal was the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services were included in net appreciation (depreciation) in fair value of the investments, as they were paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator of \$29,145 and \$21,809 for the years ended December 31, 2023 and 2022, respectively, which were not covered by revenue sharing. The Plan Sponsor paid directly any other fees related to the Plan's operations.

(6) Plan merger

The Company approved a plan merger effective at the close of business December 31, 2023. The Plan was merged into the National Beef Union 401(k) Plan (formerly NBP Workplace Savings Plan – Represented Employees (the "NBP Workplace Plan")) and as of the date of the merger, the Plan ceased to exist.

(7) Tax status

The IRS has determined that the prototype nonstandardized profit sharing plan was designed in accordance with applicable sections of the IRC and informed trustee of such in a letter dated March 31, 2014. The plan administrator adopted the prototype plan and believed that the Plan was operated in compliance with the applicable requirements of the IRC.

(7) Tax status (continued)

Effective February 18, 2022, the Plan was restated in accordance with the IRS cycle 3 restatement window. The IRS determined that the pre-approved plan was designed in accordance with applicable sections of the IRC and informed FMR LLC (an affiliate of the trustee) of such in a letter dated June 30, 2020. The plan administrator adopted the preapproved plan and believed that the Plan and related trust were operated in compliance with the applicable requirements of the IRC.

The IRS has determined that the pre-approved plan was designed in accordance with applicable sections of the IRC and informed FMR LLC (an affiliate of the trustee) of such in a letter dated June 30, 2020. The plan administrator adopted the preapproved plan and believe that the Plan and related trust were operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

(8) Risks, uncertainties and concentrations

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risk. Market risks included global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2022, approximately 21%, of the Plan's investments were invested in the Principal LifeTime 2055 Separate Account.

(9) Transfer Out

Effective December 31, 2023, at the close business, the Plan merged with the NBP Workplace Plan. As a result, participant accounts totaling \$2,216,637 transferred from the Plan to NBP Workplace Plan. At December 31, 2023, this amount is presented as a liability in the statement of net assets available for benefits.

(10) Subsequent events

The Plan has evaluated subsequent events through September 13, 2024, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
