To Whom It May Concern,

I received a notice this week from the IRS stating that the IRS had not received the 2022 filing for the 5500 SF Plan 001 for D&K Sportswear Inc EIN 68-0623685. I was the plan administrator at the time, but the business was closed 9 years ago in June of 2015. In 2021, 2 participants remained on the plan. Since the company no longer existed, Paychex (the 3rd party who helped with the filings for the plan) said they would contact the 2 remaining participants to remove them from the plan so the filings would no longer be needed. I authorized them to do that, so they made the needed contacts and took the last 2 participants off the plan.

Paychex didn't tell me that I needed to file a final 2022 5500 SF return, so I assumed they took care of it. I only found out when I received the notice from the IRS this week that Paychex had filled out but not filed the last return. Since the business has been closed for over 9 years and there are no assets for the company, any imposed penalties would be a financial hardship. I am filing the 2022 5500 SF for D&K Sportswear Inc today (9-20-24) to satisfy the IRS requirements. Can you please not apply or remove any penalties from the IRS for this misunderstanding?
