Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of A. H. Management Group, Inc. Employees' Profit Sharing Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the statement of net assets available for benefits for the year ended December 31, 2022 (on going) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of A. H. Management Group, Inc. Employees' Profit Sharing Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis of Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of A. H. Management Group, Inc. Employees' Profit Sharing Trust and to meet our other ethical responsibilities in

accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a) (3) (C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note C to the financial statements, the governing body of A. H. Management Group, Inc. Employees' Profit Sharing Trust approved a plan of liquidation on December 1, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a) (3) (C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTE A – DESCRIPTION OF PLAN AND TRUST

The following description of A.H. Management Group Inc. Employees' Profit Sharing Trust ("the Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions:

1. General

The Plan is a defined contribution plan covering eligible employees of A.H. Management Group, Inc. (the "Company") and Awesome Hand Services LLC, a controlled group, who have completed one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

2. Enrollment

The Plan has an automatic enrollment (contribution) program. The program provides for new participants to automatically be enrolled at a contribution rate of 3% of compensation unless the eligible participant elects otherwise.

3. Contributions

Each year, participants may contribute up to maximum allowed by law of pre-tax gross compensation, as defined in the Plan. Eligible participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Eligible participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may elect to make discretionary contributions to the Plan, which is determined on an annual basis. Discretionary contributions made for the years ended December 31, 2023 and 2022 amounted to \$500,038 and \$200,000 respectively. Participants direct the investments of all their above-mentioned contributions in a variety of investment choices fully described in the Plan's guide. Participants may change their investment options at any time. Contributions are subject to certain limitations as designated by the Internal Revenue Code (IRC).

4. Participants' Accounts

Participants' accounts are credited with their contributions, an allocation of the Company discretionary contribution, if any, and plan net income. The Company's discretionary contribution is allocated based upon each participant's compensation or account balance, as defined in the Plan. Plan earnings are allocated based on participants' account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's employer discretionary contribution portion of their accounts is based on the following table:

Less than 1 year	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

A participant becomes fully vested upon death, total and permanent disability or early retirement date.

6. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by 50% of the participant's benefits under the Plan and bears interest 4.25% to 9.00%, which are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions for a time period of not more than 5 years. Participant notes receivable are valued at their outstanding principal balance plus accrued and unpaid interest. As of December 31, 2023 and 2022, the Plan had outstanding notes to participants with principal balances totaling \$97,599 and \$131,969, respectively.

7. Payment of Benefits

Upon termination of service due to death, total and permanent disability, or early retirement, a participant will receive a lump sum distribution equal to 100% in his or her account regardless of the vesting schedule. For termination of service due to other reasons, the participant will receive a lump sum distribution in accordance with the vesting schedule. If they have attained age 59 1/2, participants may withdraw part or all of their account as defined in the plan document. Under certain conditions, participants may receive a hardship distribution.

8. Forfeited Accounts

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$19,321 and \$18,997, respectively. These accounts may not be used to reduce plan expenses.

9. Certification

The Plan custodian is Ascensus Trust Company. The Plan Custodian has certified to the accuracy of the investment transactions, recognition of income, expenses, and assets held as of December 31, 2023.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements have been prepared using the liquidation basis of accounting for year ended December 31, 2023 and the accrual method of accounting for year ended December 31, 2022. The trustee reports assets at liquidation value for year ended December 31, 2023 and fair market value for the year ended December 31, 2022 but report distributions and receipts on a cash basis.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles general accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan’s investments are reported at liquidation value at December 31, 2023 and at fair value at December 31, 2022. Liquidation value and fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisers and trustee. See Note G for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s accounts and are included in fees when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participants loan to be in default the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. There were no amounts due from related parties included in notes receivable from participants at December 31, 2023 and 2022.

5. Payment of Benefits

Benefits are recorded when paid.

6. Administrative Expenses

Certain expenses are absorbed by the Plan Sponsor, including audit fees, and are excluded from these financial statements. Custodian and transaction fees are paid out of the Plan’s assets and included in administrative fees.

7. Date of Management’s Review

Subsequent events were evaluated through August 28, 2024, which is the date the financial statements were available to be issued.

NOTE C – PLAN TERMINATION

The governing body of A. H. Management Group, Inc. Employees’ Profit Sharing Trust approved a plan of liquidation on December 1, 2023, and management determined liquidation is imminent. Final distributions will be determined based on all participants being 100% vested, and will be made as soon as possible after the termination date. As a result, the Plan has changed its basis of account from the ongoing basis used in presenting the December 31, 2022 financial statements to the liquidation basis used in presenting the December 31, 2023 financial statements. As of April 10, 2024 all funds have been distributed from the Plan.

NOTE D – FEDERAL INCOME TAX STATUS

The Plan Sponsor has received, from the Internal Revenue Service (IRS), an opinion letter dated March 31, 2015, stating that the written form of the prototype plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and that any employer adopting this form of the Plan will be considered to have a plan qualified under Sections 401(a) of the Code. The Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving this letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset for any uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The plan administrator has analyzed the tax positions that would require recognition of a liability or asset or disclosure in the financial statements and has determined that there are no unrecognized tax benefits at December 31, 2023 or 2022. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE F – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by the Custodian, which included total investments and notes receivables from participants as of December 31, 2023 and 2022, the total investment income for the year ended December 31, 2022, and all information included in the supplemental schedule H, line 4i-schedule of assets (held at end of year).

NOTE G – LIQUIDATION VALUE/FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"> • Quoted prices for similar assets or liabilities in active markets; • Quoted prices for identical or similar assets or liabilities in inactive markets; • Inputs other than quoted prices that are observable for the asset or liability; and • Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's liquidation value/fair value measurement level within the liquidation value/fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at liquidation value/fair value. The Plan used the liquidation value methodology at December 31, 2023 and the fair value methodology at December 31, 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE H – RELATED-PARTY/PARTY-IN-INTEREST TRANSACTIONS

Certain plan investment are shares of mutual funds managed by American Funds. Ascensus LLC is the record keeper and Ascensus Trust Company is the custodian of the Plan and, these transactions are party-in-interest transactions: however, are exempt from the prohibited transaction rules under ERISA. Fees paid by the Plan for record management services amounted to \$25,663 and \$30,393 for the year ended December 31, 2023 and 2022, respectively.

NOTE I – COVID RESPONSE

On March 11, 2020, the World Health Organization characterized an outbreak of novel strain of the coronavirus (COVID-19) as a pandemic. Due to the COVID-19 outbreak in the United States, as of March 27, 2020, Congress passed the CARES Act that included numerous employee benefit plan provisions to assist plan sponsors and participants. The Plan Sponsor intends to amend the Plan for all features impacting retirement programs. This includes COVID-19 related distributions, COVID-19 related participant loans and required minimum distributions (RMD's) affecting participants impacted by COVID-19. The Plan Sponsor, together with Ascensus Trust Company, the custodian of the Plan, is still in the process of amending the Plan for these provisions. The amendments for these provisions are required to be adopted by the Plan by December 31, 2025.

NOTE J – SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both requires and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's December 31, 2023 financial statements.
