Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Crème De La Crème Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 28, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 to February 28, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Crème De La Crème Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the two months ended February 28, 2023, and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

1. Plan Description

The following description of Crème De La Crème Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement is effective December 25, 2022.

General

The Plan was established June 1, 2004, as a defined contribution plan covering all employees of CDLC, Inc. and participating Employers (the Employer), except for nonresident aliens and residents of Puerto Rico. Employees are eligible for all contribution types after completing one year of service in which they complete 1,000 hours of service and attainment of at least 21 years of age. Employees may begin participating on the first day of the month after becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees the governance of the Plan.

The Plan is a single-employer plan that includes a controlled group of employers based on geographical location. The eligibility requirements are uniform across participants of each Employer.

Contributions

Participants 21 years of age and older with at least one year and 1,000 hours of service may contribute up to 15 percent of annual compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code. Pre-tax contribution is permitted to the plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Employer may make discretionary matching contributions each year. The Company made no matching contributions for the two months ended February 28, 2023 or for the year ended December 31, 2022.

Effective December 25, 2022, the plan was frozen, and contributions were no longer permitted.

Participant Accounts

Each participant account is credited with the participant's contribution and allocations of the Employer's contributions, Plan earnings (losses), and charged with an allocation of administrative expenses, when applicable. Allocations are based on participant earnings or account balances, as defined by the Plan documents. Participants may direct the investment of their accounts into various investments offered through Reliance Trust Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description, continued

Notes Receivable from Participants

Participants are permitted to borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at the "prime rate" plus 2 percent which remains in effect for the duration of the loan. Principal and interest will be repaid ratably through monthly payroll deductions over a reasonable period of time, not to exceed five years.

Effective December 25, 2022, the plan was frozen, therefore new loans were not permitted.

Notes Receivable from Participants, continued

Loans for the purchase of a primary residence can be repaid over a period equal to the lesser of 30 years or the repayment period. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Vesting

Participants are fully vested in their account at all times.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum, substantially equal installments, and partial withdrawals. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service withdrawals are allowed at age 59½ from all accounts that are fully vested. In addition, in-service distributions are permitted in the event of a hardship event subject to certain conditions. Hardship distributions may be made from all vested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of February 28, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid from Plan assets. Administrative expenses may also be paid by the Employer; such expenses are excluded from these financial statements. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participants' accounts.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards of Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value Measurements, continued

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at February 28, 2023 and December 31, 2022.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. All mutual funds held by the Plan are open-ended funds registered with the SEC and are deemed to be actively traded and have a readily determinable fair value. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Common/collective trusts: Units held in the common/collective trusts are valued using the net asset value (NAV) of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the common/collective trust measured at NAV have not been classified in the fair value hierarchy. All common/collective trust investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as December 31, 2022. As of February 28, 2023, there were no net assets available for benefits due to the plan termination discussed in Note 4.

4. Plan Termination

The Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Effective December 25, 2022, the plan was frozen, and no contributions or new loans were permitted. Participants in the Plan became participants in the KinderCare Education Savings and Investment Plan (KCE Plan) on January 1, 2023, the date on which the Plan officially merged with the KCE Plan.

All participant account balances and plan assets were transferred to the KCE Plan prior to February 28, 2023.

5. Tax Status

The Plan was created under a prototype plan through execution of an adoption agreement. The prototype plan adopted is the Non-Standardized Pre-Approved Profit Sharing Plan. ADP, LLC, the sponsor of the plan, has received an opinion letter dated October 6, 2020, stating that the Plan was designed in accordance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the opinion letter. However, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan provides for various investment options that have different investment strategies. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations of Reporting and Disclosure under ERISA.
