1. DESCRIPTION OF PLAN

The following description of CONSTRUCTION & REALTY SAFETY GROUP INC 401(k) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all full-time employees who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

Each year, participants may contribute up to 100 percent of pre-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make up catch up contributions. The Company may elect to contribute an employer profit sharing contribution at its discretion.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's deferred compensation, as defined, and the allocation of (a) the Company's contribution, and (b) Plan earnings. Allocations are based on participants' earnings or account balances, as defined. As a participant-directed plan each participant's investments determine his or her share or earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting is as follows:

PAYMENT OF BENEFITS

On termination of service, as defined, a participant receives a lump-sum amount equal to the vested value of his or her account.

FORFEITURES

The Plan does not have forfeitures as all participants are 100% vested.

INVESTMENT OPTIONS

All participants may direct employee contributions in either of two investment options with Nationwide Life Insurance Company:

Advisor – A variable return group annuity contract which consisting of numerous investment options with a range of investment objectives. These pooled separate accounts invest in a variety of underlying funds.

BOA Fixed – A guaranteed return contract which is not fully benefit-responsive. Daily Interest credits are based upon single A rated corporate bonds. The yield for the year ended December 31, 2023 is 1.03%.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

DATE OF MANAGEMENT'S REVIEW

Subsequent events were evaluated through August 22, 2024, which is the date the financial statements were available to be issued.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully-benefit response investment contracts. Contract value is the is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Statement of Net Assets Available for Benefits presents the fair value of the fixed investment contract because this Investment contract is not fully benefit-responsive.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Sponsor determines the Plan's valuation policies. See Note 3 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

PLAN ADMINISTRATIVE EXPENSES

Certain administrative functions are performed by employees of the Employer. No such employee receives compensation from the Plan. The employer has absorbed all Plan administrative expenses that are not related to investments.

3. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs- are quoted prices in active markets for identical assets the Plan has the ability to access at the measurement date and have the highest priority.

Level 2 inputs - are inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs are those that reflect the assumptions market participants would use in pricing the asset developed on market date obtained from sources independent of the plan.

Level 3 inputs- are unobservable inputs for the asset. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions the market participants would use in pricing the asset, developed based on the best information available in the circumstances. Level 3 has the lowest priority.

FAIR VALUE MEASUREMENTS (continued)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they general provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2019.

Level 2 Fair Value Measurements

The fair value of the variable return annuity contract for which a quoted market price is not available is valued at the net asset value (NAV) of shares of the underlying mutual funds held by the annuity.

Level 3 Fixed Select

A fixed return product with quarterly interest rate guarantees . Deposits are guaranteed in both principal and interest by Nationwide Life Insurance Company. Amounts are held in Nationwide Life Insurance Company's general account and are credited on a net daily basis at annual effective rates. This contract is fully benefit responsive and is reported at contract value. The fair market value is equal to the contract value less any Contingent Deferred Sales Charge (CDSC), if applicable, and Market Value Adjustment . Due to the valuation process used, this contract is within Level 3 of the Fair Value Hierarchy under FASB Statement No. 157.

**4. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into an investment contract with Nationwide Life Insurance Company (Nationwide). There are two underlying contracts- a Variable Return Annuity Contract and a Guaranteed Return Contract.

The Variable Return Annuity Contract is fully benefit responsive and is reported at fair market value which equals contract value. Funds are maintained in pooled separate accounts. The accounts are credited with earnings on the underlying investments and reduced for Plan withdrawals and administrative expenses charged by Nationwide.

The Guaranteed Return Contract is not fully benefit-responsive, and therefore is reported at fair value with no adjustment to contract value. The crediting interest rate was fixed at 1.03 % for 2023.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of funds managed by an affiliate of the Custodian. Administrative expenses are paid to the Custodian and its affiliate who acts as the record-keeper of the Plan. These transactions with the Custodian and its affiliates qualify as party-in-interest transactions. The above transactions are not, however, considered prohibited transactions under CFR 408(b) of the ERISA regulations.

**7. TERMINATION OF THE PLAN**

Although it has not expressed an interest to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100 % vested in their accounts.

**8. TAX STATUS**

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2023, there were no uncertain positions taken that had an effect on the Plans financial statement or that required disclosure.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associate with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
