**NOTE 1 DESCRIPTION OF PLAN**

The following description of the COBOCO INC. 401(K) PROFIT SHARING PLAN AND TRUST (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan which includes a salary reduction feature that meets the requirements of Section 401(k) of the Internal Revenue code covering all full-time employees of Coboco, Inc.; Collins Brothers Corporation; and Future Management Corporation (collectively referred to as the "Company") who have reached age twenty-one or older and have completed six months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Each year, participants may elect to contribute up to a certain percentage of eligible compensation, as defined in the Plan. The Plan also allows participants to designate a portion or all of the deferral contribution at the time the deferral election is made as a Roth deferral contribution. The employee's total deferral may not exceed a certain dollar limit which is set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Additional amounts may be contributed by the Company at the option of the Board of Directors for employees who have satisfied certain service requirements. Currently, this match is equal to 50 cents for each \$1 deferred by an employee up to 4% of compensation for participants in the plan who have completed twelve months of service. During the year ended December 31, 2023, the Company made \$103,274 in discretionary match contributions.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants** - Participants may borrow from their fund up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer from the investment fund to the Participant Notes fund. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. The interest rates range from 4.25 to 9.50 percent. Principal and interest are paid ratably through payroll deductions.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Investment Options** - Upon enrollment in the Plan, an eligible participant may direct employee contributions in various investment options. Participants may change their investment options as they deem necessary.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits** - Upon termination of service, death, disability or retirement at age 59 1/2, a participant, or their beneficiary, may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or in installments.

**Forfeitures** - Forfeitures are created when participants terminate employment before becoming fully vested. For the year ended December 31, 2023, there was \$2,090 in forfeited non-vested accounts which was used to reduce the Employer's matching contributions. There were \$23 of forfeitures available at December 31, 2023 and 2022.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefits are recorded when paid.

**Risks and Uncertainties** - The Plan's invested assets ultimately consist of investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded monthly. No allowance for credit losses has been recorded at December 31, 2023 and 2022. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**NOTE 3 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 4 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The net assets available for benefits per the financial statements agree with the net assets available for benefits per the Form 5500.

There are no reconciling differences between benefits paid to participants between the financial statement and the Form 5500. Amounts allocated to withdrawing participants are recorded on the Form 5500 for benefit claims that have been processed and approved for payment prior to December 31, 2023, but not yet paid as of that date. No approved benefit claims existed at December 31, 2023, which were not paid.

**NOTE 5 TAX STATUS**

The Company has adopted the Plan based on a volume submitter plan document sponsored by ADP. ADP has received an opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, that states that the form of the volume submitter plan is acceptable under Section 401 of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, the trustee of the Plan, as complete and accurate, except for comparing such information certified by the trustee to information included in the Plan’s financial statements and supplemental schedule.

**NOTE 7 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

ADP Retirement Services provides certain administrative services to the Plan pursuant to a Master Plan Service Agreement (“MSA”) between the Company and ADP Retirement Services. ADP Retirement Services receives revenue from mutual fund service providers for services ADP Retirement Services provides to the funds. This revenue is used to offset certain amounts owed to ADP Retirement Services for its administrative services to the Plan.

If the revenue received by ADP Retirement Services from such mutual fund service providers exceeds the amount owed under the MSA, ADP Retirement Services remits the excess to the Plan’s trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2023, there were no excess amounts. The Plan or Plan Sponsor may make a payment to ADP Retirement Services for administrative expenses not covered by revenue sharing.

Certain Plan investments are shares of mutual funds managed by ADP Retirement Services who is also the investment recordkeeper, as defined by the Plan, and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management fees and services amounted to \$13,347 for the year ended December 31, 2023.

**NOTE 8 FAIR VALUE MEASUREMENTS**

The Plan has established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

**Basis of Fair Value Measurement**

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

***Mutual Funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Common Collective Trust:*** Valued based on the share prices/net asset values ("NAV") reported on the plan summary reports for collective trust funds which are obtained directly from the fund house or other investment provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value as of December 31, 2023 and 2022. As required, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.
