We have performed audits of the accompanying financial statements of the Lauren International, Ltd. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lauren International, Ltd. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

1. Description of The Plan

The following description of the Lauren International, Ltd. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement and the summary plan description for hourly and salary employees for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all salary and hourly employees of Lauren International, Ltd. (Company and Plan Sponsor) and participating employers whose employees have worked one month out of twelve months during a year. Participating employers are as follows:

- Lauren AgriSystems, Ltd.,
- Flite Test, LLC,
- Retail Product Solutions, LLC,
- Ampersand Technologies, LLC,
- Valv-Trol, LLC,
- WJER, LLC (beginning on June 1, 2022),
- Nurtured Pets, LLC (ceased on June 1, 2022), and
- LMI Custom Mixing, LLC (ceased on December 31, 2022)

Contributions

Effective June 1, 2023, the Plan was amended to reduce the service requirement from three months to one month to be eligible to make elective deferrals/voluntary contribution, employer match & non-elective contributions. Each year participants may contribute up to 100% of their pre-tax annual compensation, subject to the maximum amount allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also accepts Roth elective deferrals. All participants can rollover into the Plan amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan provides for an automatic enrollment deferral percentage of 3% of compensation for newly eligible participants. The new participant may affirmatively elect a different percentage or elect not to make an elective deferral contribution.

The Plan also provides for employer matching contributions. The employer matching contributions are as follows:

- The Plan has elected safe harbor provisions. In accordance with the provisions, the Company will contribute a safe harbor matching contribution to participant's accounts in an amount equal to 100% of the participant's elective deferrals that are not in excess of 3% of the participant's plan compensation plus 50% of the participant's elective deferrals that exceed 3% of the participant's plan compensation but that do not exceed 5% of the participant's plan compensation.
- During the year ended December 31, 2023, the Company also made separate discretionary employer contributions to the Plan to all plan participants, excluding the highly compensated, based upon their attaining 5 years of service milestones. In accordance with this service award to honor the late Dale Lauren Foland, founder of Lauren, the Company will make a \$50 discretionary contribution to the participant's account for 5 years of service increasing \$50 for each additional 5-year milestone attained. The discretionary employer contributions made during the year ended December 31, 2023, were \$50.

Notes to Financial Statements

Vesting

Participants are immediately vested in their contributions (including rollover contributions) plus actual earnings thereon. Vesting in Company matching contributions and additional contribution portions of their accounts plus actual earnings thereon is based on years of service, as defined. Participants vest in the Company's contributions gradually over six years beginning at 20% after two years and an additional 20% in each of the following years becoming 100% vested after six years. Participants are immediately vested in the Company's safe harbor matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions including elective deferrals and rollover contributions, allocations of the Company's contributions and Plan earnings, net of expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All investments of the Plan are fully participant directed.

Payment of Benefits

On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account, or upon death, disability or retirement, may elect to receive annual installments over a defined period of time not extending beyond the life expectancy of the participant or the joint and last survivor expectancy using the attained age of the participant and the participant's designated beneficiary. Non-terminated employees may make withdrawals from their vested account balance as a hardship withdrawal. Hardship withdrawals are subject to additional rules and conditions as outlined in the Plan agreement.

Forfeitures

The Plan provides that all forfeitures may be used to pay administrative expenses under the Plan that would otherwise be paid by the employer or to reduce the earliest employer contributions made after forfeitures are determined. Forfeitures shall be determined at least once during each taxable year of the employer. During the year ended December 31, 2023, \$4,102 was transferred into the forfeiture account and forfeitures totaling \$4,102 were used to reduce employer contributions. There were no unallocated forfeitures available to pay administrative expenses or reduce future contributions as of December 31, 2023 and 2022.

Subsequent Events

The Company has evaluated subsequent events through July 17, 2024, which is the date the financial statements were available to be issued.

2. Summary of Significant Accounting Policies

Adoption of New Accounting Standard

Effective January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13, Financial Instruments - Credit Losses (Topic 326). This standard replaced the incurred loss methodology with an expected methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of credit losses using historical experience, current conditions, and reasonable and supportable forecasts and generally applies to financial assets measured at amortized cost. Financial assets measured at amortized cost will be presented at the net amount expected to be collected by using an allowance for credit losses.

The Plan adopted Accounting Standards Codification (ASC) 326 and all related subsequent amendments thereto effective January 1, 2023, using the modified retrospective approach for all financial assets measured at amortized cost which did not have a material impact on the financial statements.

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Management to make estimates that affect reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Certain investment management and other fees are paid directly by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Information Prepared and Certified by the Custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2023 and 2022, and investment income (loss), net appreciation (depreciation) in fair value of investments and benefit payments for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian.

4. Fair Value Measurements

The authoritative accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative accounting guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs include quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 or 2022.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All assets measured at fair value as of December 31, 2023 and 2022, were pooled separate accounts that are valued at NAV and therefore not included in the fair value hierarchy in accordance with authoritative guidance.

5. Fully Benefit-Responsive Investment Contract

The Plan offers the Voya Fixed Account, which is a group annuity contract issued by Voya Retirement Insurance and Annuity Company as custodian. The Voya Fixed Account is a traditional investment contract guaranteed by Voya Retirement Insurance and Annuity Company that guarantees a minimum rate of interest that will be credited to participant accounts. This contract meets the fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals and administrative expenses. Due to the nature of the contract, there are no specific underlying assets assigned. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract. In accordance with the terms of the existing contract, the crediting interest rate is reset on a monthly basis. The crediting interest rate is net of administrative expenses.

The contract is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of the issuer and not on the value of the securities within the insurer's general account. Key factors that could influence future crediting interest rates include mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

The Voya Fixed Account contract does not have a maturity date. The provisions do not provide for a distribution at some specified future date. A contract holder can request a lump-sum distribution with a market value adjustment, or an installment payout over a period of years. The Voya Fixed Account contract continues in force until all assets have been distributed, or no further payments are due. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the plan participants are probable of occurring. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the contract terms, (2) bankruptcy of the Sponsor, (3) sixty day-notice of termination provided by the issuer without cause. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in the employer contributions.

During the year ended December 31, 2022, the Plan Sponsor terminated all employees of LMI Custom Mixing, LLC as a result of the transfer of ownership to an unrelated entity. In aggregate, the termination represented a partial termination of the Plan. As a result of this partial termination, all participant account balances of affected employees were fully vested as of December 31, 2022, the date on which the employees were terminated.

7. Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Transactions with Parties-in-Interest

The Plan's custodian, Voya Retirement Insurance and Annuity Company, is a party-in-interest of the Plan as defined by ERISA Section 3 (14) and accordingly, investment transactions in the respective funds are parties-in-interest transactions. Certain legal and accounting fees and certain administrative expenses relating to the maintenance of participant eligibility records are absorbed by the Company. Other than as described above, or pursuant to a trust agreement, the Plan has no agreements or transactions with any parties-in-interest.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Delinquent Participant Contributions

The Plan Sponsor made late participant contributions to the Plan for the year ended December 31, 2023, for participants of the Plan. The Plan Sponsor contributed the late amounts totaling \$898, including lost earnings, in 2024 for payroll dates in 2023.

Of the prohibited transactions described herein, \$57 are pending correction as of the report date and \$898 have been corrected as of the report date.
