**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Kool Chevrolet, Inc. Savings & Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of DK Leasing, Inc and Freedom Chevrolet, Inc. (together, the “Company”), the Plan sponsor. Employees become eligible to participate in the Plan on the first day of the calendar quarter following completion of three months of employment and are at least 20 years of age. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA). The Plan has been restated effective July 1, 2022 to comply with current laws and regulations.

**Contributions**

Participants may elect to make contributions to the Plan through payroll deductions from each participant’s compensation, as defined, subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows participants to transfer funds from other employer qualified plans into the Plan.

Upon reaching eligibility, an employee will be automatically enrolled to defer 8% of eligible compensation unless the employee elects otherwise. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants. Contributions are automatically invested in a designated target date mutual fund until changed by the participant.

Unless an eligible employee affirmatively elects otherwise after receiving appropriate notice, contributions for each active participant having automatic enrollment contributions made on their behalf shall be increased annually by 1% of eligible compensation capped at an annual maximum of 10% of eligible compensation.

The Company may make a discretionary matching contribution to the Plan on behalf of each participant that contributes to the Plan. For the 2023 Plan year, the contributions were equal to 25% of the first 8% of a participant’s contribution to the Plan, up to a maximum of 2% of their compensation.

**Contributions (continued)**

The Company may make a discretionary contribution to the Plan in an amount determined by management. Discretionary contributions are allocated on a ratio of each participant's compensation to total compensation. There was no such contribution for 2023.

**Plan Operations**

The Company has appointed Principal Trust Company (Trustee) to act as Trustee and the Company to act as Plan administrator. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions and making distributions to participants. The Plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose, as listed in the accompanying Schedule of Assets Held at End of Year.

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer matching contribution accounts is based on years of continuous service, as follows:

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed or upon attainment of normal retirement age.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 5.25-10.50 percent, which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In-service and hardship withdrawals are permitted pursuant to the terms of the Plan.

**Forfeited Accounts**

At December 31, 2023 and 2022, there was \$4,220 and \$915, respectively, in forfeited non-vested accounts. These accounts are used to reduce employer contributions or pay plan expenses. In 2023, employer contributions were reduced by \$13,365 from forfeited non-vested accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. While management believes it has consistently applied its best judgment in those areas requiring estimates, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

For the year ended December 31, 2023, Plan management has evaluated subsequent events for potential recognition and disclosure through August 27, 2024, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS AND DISCLOSURES**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The mutual funds have been valued using unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Using unadjusted quoted prices for identical investments in an active market is defined as a level 1 measurement method.

The stable value fund is comprised of fully benefit-responsive investment contracts that are valued at the net asset value of the underlying investments. The net asset value is used as a practical expedient to estimate fair value. In order to ensure all investments categorized in the fair value hierarchy are classified using a consistent approach, these investments are not categorized in the fair value hierarchy. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 60 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 4 - RELATED-PARTY TRANSACTIONS**

Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to the third-party administrator of \$31,734 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE 5 - TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7 - INCOME TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
