The failure to file this Form 5500 on a timely basis was inadvertent and due to circumstances beyond the control of the Plan sponsor. The Plan administrator completed the filing for submission as soon as reasonably practicable following the realization that the filing was required.

The information provided in line 1(c), "Effective date of plan," is based upon best information available to the third-party consultant to the plan administrator. For the period of the Plan's operation between March 1, 2013 and February 29, 2016 (if applicable), Plan records indicate that the Plan had fewer than 100 participants *and* was funded using insurance and the general assets of the sponsor rather than insurance and a trust (as indicated in item 9a of this Form); consequently, BrightStar Holdings, Inc., along with the third-party recordkeeper, take a reasonable position that the Plan was not required to file a Form 5500 with respect to the Plan until the Plan year beginning March 1, 2016.

The information provided in lines 5 and 6(a)(1), (a)(2), and 6d is based upon best information available to the third-party consultant to the plan administrator. For the period of the Plan's operation between March 1, 2016 and February 28, 2018 (if applicable), the consultant does not have specific information regarding the number of participants in the Plan, so the numbers indicated in the lines referenced above represent an estimate of Plan participants for the relevant year based on the total number of lives covered under the applicable Aetna insurance policy, as indicated on Schedule A for the relevant year, divided by the total number of employers participating in the trust being used to fund the Plan (as indicated in item 9a of this Form) for the relevant year and rounding down to the nearest whole person.

The information provided in lines 2(a)(1), (a)(2), (d), (e), and (j) is based upon best information available to the third-party consultant to the plan administrator. The numbers indicated in the lines referenced above represent an estimate of Plan contributions for the relevant year based on allocating the total premiums paid under each applicable insurance policy, as indicated on Schedule A for the relevant year, among the employers participating in the trust being used to fund the Plan (as indicated in item 9a of this Form) for the relevant year according to each employer's share of the total number of lives covered under the applicable insurance policy for the relevant year, assuming that half of the premium was funded by employee contributions and half funded by employer contributions.
