## **1. Description of Plan**

The following description of The SEFA Group, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants may refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan was a defined contribution plan for the benefit of eligible employees of The SEFA Group, Inc. and SEFA Transportation, Inc. (collectively referred to as the “Company” or the “Sponsor”). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### **Plan Merger**

During 2023, the Sponsor was acquired and the Plan merged with another qualified plan effective December 31, 2023. All plan assets were transferred to the other qualified plan in 2023.

### **Eligibility**

In order for employees to have been eligible to make employee elective salary deferral contributions, they had to be age twenty-one and could enter the Plan on the first day of the calendar month immediately following or coinciding with such employee’s completion of three months of service. In order for employees to have been eligible to receive safe harbor nonelective and discretionary profit sharing employer contributions, the employee must have completed one year of service with the Company in which the employee must have completed at least 1,000 hours of service. For safe harbor nonelective and discretionary profit sharing employer contributions, participating employees entered the Plan on January 1st and July 1st of the Plan year.

### **Contributions**

Eligible participants could contribute up to 90% of their pre-tax compensation to the 401(k) portion of the Plan, subject to contribution limitations specified by applicable laws and regulations. The Plan also allowed Roth 401(k) contributions of after-tax amounts subject to contribution limits specified by applicable laws and regulations. The Company, at the discretion of its management, annually determined the amount of its contribution, if any, to the Plan. For the years ended December 31, 2023 and 2022, the Company made safe harbor contributions to the profit sharing portion of the Plan equal to 3% of eligible participants’ gross earnings, subject to contribution limitations specified by applicable laws and regulations.

**1. Description of Plan (continued)**

**Participant Accounts**

Each participant's account was credited with the participant's deferral contributions, allocation of the Company's contributions, if any, Plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Allocations were based on participant earnings or account balances, as defined. Participants elected to direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Vesting**

Participants were immediately vested in their salary deferrals and safe harbor nonelective contributions, and actual earnings or losses thereon. Vesting in the Company's discretionary profit sharing employer contributions was based on continuous years of service and were at a rate of 20% per year beginning with the second year of service through the sixth year of service, at which time they would become fully vested. A participant's account was 100% vested under the Plan upon death or disability of the participant regardless of years of service.

**Forfeitures**

Forfeitures attributable to discretionary profit sharing employer contributions were allocated among the accounts of participants otherwise eligible to have received an allocation of non-safe harbor profit sharing contributions. At December 31, 2023 and 2022, there were no unallocated forfeited accounts. No forfeitures were reallocated to remaining participant accounts for the years ended December 31, 2023 and 2022.

**Administrative Expenses**

The Plan paid custodial, recordkeeping, and certain professional and administration fees. The Company paid for certain other professional and administrative fees.

**Payment of Benefits**

Upon termination of service due to retirement, disability, death, or termination of employment, participants could elect to receive either a lump sum amount or installments equal to the value of their vested account. Distributions could be made at the participant's election on or after the valuation date following the employee's termination of service.

**2. Basis of Presentation and Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States (“US GAAP”).

**Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for plan benefits during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**3. Investment Certifications**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2023 and 2022, related to investments, net appreciation (depreciation) in fair value of investments, and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company (“FTMC”), the trustee of the Plan.

#### **4. Fair Value Measurements**

The Plan's investments are reported at fair values in the accompanying statements of net assets available for plan benefits. US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair values. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. When available, the Plan measures fair values using Level 1 inputs because they generally provide the most reliable evidence of fair values. All of the Plan's mutual funds are valued using Level 1 inputs, based on quoted net asset values of shares held by the Plan.

The Plan's investments include the Wells Fargo Stable Return Fund M, a collective trust that invests in Wells Fargo Stable Return Fund G, a collective trust that invests in a variety of fully benefit-responsive investment contracts. Wells Fargo Stable Return Fund M is valued at the net asset value (the "NAV") of units of the trust. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held less the trust's liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

#### **5. Income Tax Status**

The Plan was a volume submitter plan, provided by FTMC, and designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Internal Revenue Service ("IRS") has determined and informed FTMC, by a letter dated June 30, 2020, that the volume submitter plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has amended since the date of the most recent letter, Plan management believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. As a result, Plan management believes that the Plan was qualified and the related trust was tax-exempt.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified at December 31, 2023 and 2022. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Party-in-Interest Transactions**

Certain Plan investments were shares of mutual funds managed by FTMC and its affiliates. All transactions with FTMC and its affiliates qualify as party-in-interest transactions. Fees paid by the Plan to FTMC and its affiliates for trustee, recordkeeping, and investment advisory services amounted to approximately \$42,000, annually, for the years ended December 31, 2023 and 2022. The Company paid all other fees on behalf of the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**7. Unallocated Assets**

The safe harbor employer contribution receivable for 2023 totaling approximately \$1,084,000, which was transferred as part of the plan merger discussed in Note 1, had not yet been allocated to participants as of December 31, 2023. As of December 31, 2022, approximately \$932,000 of Plan assets had not yet been allocated to participants.
