### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of American National Bank and Trust Company Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of American National Bank and Trust Company Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Principal Trust Company as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of American National Bank and Trust Company Employee Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about American National Bank and Trust Company Employee Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

Note 1. Significant Accounting Policies

Basis of accounting:

The financial statements and accompanying notes are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Accordingly, actual results could vary from the estimates that were used.

Securities transactions:

Purchases and sales of securities are reflected on a trade-date basis. Gain or loss on disposition of investments is based on average cost for assets acquired during the year and average current value for assets on hand at the beginning of the year.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Shares of mutual funds and common stock are valued based on published market prices; common/collective trust funds are presented at the net asset value ("NAV") of shares held by the Plan at the end of a given year. Interest-bearing cash is valued at the deposited balance. The Plan presents net changes in the fair value, which consists of realized gains and losses, unrealized appreciation or depreciation, and any income or capital gain distributions from investments, in the statement of changes in net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties:

The Plan invests in registered investment companies and a common collective trust which invests in various securities including U.S. Government securities, corporate debt instruments, and corporate stocks, which in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with these securities, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the amounts reported in the financial statements.

Note 1. Significant Accounting Policies (Continued)

Benefits paid to participants:

Distributions from the Plan are recorded in the period in which they are paid to participants.

Administrative expenses:

Investment-related and recordkeeping expenses are paid from the Plan's assets. Certain investment-related expenses are recorded as a reduction of net investment income and are not identifiable on the financial statements. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no cost to the Plan.

Note 2. Plan Description

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of the Company who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional pre-tax or Roth 401(k) catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company has a safe harbor match in which the Company contributes 100 percent of participant's compensation deferrals that do not exceed 3 percent of compensation, plus 50 percent of participant's compensation deferrals that exceed 3 percent of compensation but do not exceed 6 percent of compensation. Additional amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations.

The Plan includes an auto enrollment feature whereby all newly eligible employees shall be automatically enrolled at 6% and enter the Plan the first day of the month following one month of service.

Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions are immediately vested.

Note 2. Plan Description (Continued)

Payment of benefits:

On termination of service due to retirement, death, or disability, a participant or beneficiary will be paid in the form of a lump-sum distribution. In-service distributions from the Plan are allowed only if the participant has attained the age 59-1/2 or has incurred a disability. Hardship distributions are permitted from the participants pre-tax elective deferral account.

Participant-directed investments in funds:

Each participant may direct how his/her account balance and future contributions are invested by choosing between the available investment funds offered by the Plan. Any such investment direction remains effective until changed by a new election. The right to direct the investment continues at termination or retirement of the participant until the distribution of the entire account balance.

Note 3. Tax Status

The Plan adopted the trustee's volume submitter profit sharing plan document, which received a favorable opinion letter from the Internal Revenue Service, dated March 31, 2014, stating that it is qualified under the applicable requirements of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws.

Note 4. Funding Policy

Contributions are determined annually by the Company's Board of Directors.

The Employer may reimburse the Plan for any administrative expenses incurred. Administrative expense reimbursements are not considered as Employer contributions.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6. Information Prepared and Certified by Trustee

Note 7. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1 Fair Value Measurements*

Unadjusted quoted prices in active markets for identical assets or liabilities.

*Level 2 Fair Value Measurements*

Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

*Level 3 Fair Value Measurements*

Unobservable inputs reflecting management's assumptions about the inputs used in pricing the asset or liability.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs to minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Common/collective trust*

Valued at NAV per share as a practical expedient. In accordance with GAAP, since the common/collective trust is measured using the NAV per share practical expedient, this fund is not classified in the fair value hierarchy.

*Mutual funds*

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. All mutual funds are classified within Level 1 of the valuation hierarchy.

The preceding described methods may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
