Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the **Benefitfocus.com, Inc. 401(k) Profit Sharing Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 29, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Management has obtained certification from a qualified institution as of December 29, 2023, and December 31, 2022, and for the years ended December 29, 2023, and December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the **Benefitfocus.com, Inc. 401(k) Profit Sharing Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 29, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certification from a qualified institution as of December 29, 2023, and December 31, 2022, and for the years ended December 29, 2023, and December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of the Plan

The following description of the Benefitfocus.com, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information about the Plan through December 29, 2023. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Merger

In September 2023, the Plan Sponsor elected to merge the Plan with Voya effective December 29, 2023. As of the legal merger date of December 29, 2023, the net assets available for benefits totaling \$124,684,894 were transferred to the Voya Plan. As of the date of the merger all participants became fully vested in their accounts.

General

The Plan is a defined contribution plan covering all employees of Benefitfocus.com, Inc. (the Company and the Employer), who meet the Plan's eligibility requirements. The Plan was originally effective January 1, 2002, and amended and restated effective January 1, 2009. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan and Investment Committee oversee the governance of the Plan, including determining the appropriateness of the investment offerings and monitoring investment performance.

Eligibility

An employee is eligible to participate in the Plan when he or she completes one hour of service. Participants are eligible to enter the Plan on the same date that eligibility requirements are met.

Contributions

Each year participants may contribute up to 100% of their annual compensation, as defined in the Plan, subject to the limitations as defined in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan has an automatic enrollment feature so that newly eligible participants begin making salary deferral contributions to the Plan, unless they elect not to do so, with a default deferral rate of 6% of eligible compensation. Additionally, the automatic enrollment contributions made on his behalf shall be increased annually by 1% of compensation, limited to 15% of compensation. Contributions are automatically invested in a balanced fund until changed by the participant.

The Employer makes matching contributions at its discretion. Matching contributions for 2023 and 2022 were the lesser of 50% of employee deferrals or 50% of the first 6% of an eligible participant's compensation. The Plan permits the Employer to make additional contributions and to designate all or any portion of such discretionary contributions as Internal Revenue Code Section 401(k) contributions at the time it makes the contributions. No such additional discretionary contributions were made in 2023 and 2022.

Participant accounts

Individual accounts are maintained for each plan participant to reflect the participant's contributions and related Company contributions. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

All participants' funds are self-directed into their investment choices. The Plan offers several choices of shares of registered investment companies (mutual funds) as investment options from which participants may choose. A participant may change his investment allocations at any time.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Employer matching and discretionary contributions and earnings thereon are subject to a 20% per year vesting schedule based on years of credited service. A participant also becomes 100% vested if, while still employed by the Company, he attains age 65, becomes permanently disabled, or dies. An employee must work 1,000 hours to be credited with a year of service. The vesting schedule is as follows:

<u>Years of Vesting Service</u>	<u>Percentage Vested</u>
1 Year of Service	20%
2 Years of Service	40%
3 Years of Service	60%
4 Years of Service	80%
5 Years of Service	100%

Payment of benefits

On termination of service due to death, disability, or retirement, if a participant's vested account balance does not exceed \$1,000 (excluding rollover contributions and earnings thereon), the Plan will automatically distribute the participant's vested account balance in a lump sum. If his or her vested account balance exceeds \$1,000 but is less than \$5,000 (excluding rollover contributions and earnings thereon), a participant may elect to receive a single lump sum or roll over the vested balance into an individual retirement account (IRA) or another qualified plan; however, if no election is made by the participant, the Plan will automatically roll over the vested balance into an IRA with an affiliate of the Plan's recordkeeper. If his or her balance exceeds \$5,000 (excluding rollover contributions and earnings thereon), the normal form of benefit payment is a joint or survivor annuity. However, a participant may elect to receive the value of his or her vested interest in the account in the form of a single lump sum, installment payments (annually, quarterly, or monthly) over a specified period of time, part lump sum and part installments, or roll over the vested balance into an IRA or another qualified plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or an IRA rollover at his or her discretion.

Forfeitures

Forfeited nonvested amounts are used by the Employer to pay administrative expenses or to reduce its matching contributions. Forfeitures of \$281,175 were used to reduce Company matching contributions and \$32,685 were used to pay plan fees in the year ended December 29, 2023. Forfeitures of \$1,741,193 were used to reduce Company matching contributions and \$51,476 were used to pay plan fees in the year ended December 31, 2022. Forfeitures available for future use were \$0 and \$124,685 in 2023 and 2022, respectively.

Participant notes receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in participant accounts and accrue interest at 4.25% to 9.25%, which represents rates similar to the rates charged for loans made under similar circumstances by persons in the business of lending money. Only one loan may be outstanding at any given time. Principal and interest are to be paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Employee contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

Company contributions are accrued and paid based on amounts to be funded for each year under the Plan provisions and the applicable requirements of the IRC.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reported as a reduction of investment returns for such investments.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of December 29, 2023, and December 31, 2022. If a participant ceases to make repayments and the plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Plan expenses

Personnel within the Company perform many administrative duties of the Plan, including maintenance of personnel files and reconciliation of payroll records. The payroll and related overhead costs associated with these services are not included as Plan expenses. Other administrative costs, including recordkeeping fees and investment fees, are charged to the individual participants' accounts. Any costs not paid by the Plan may be paid by the Company.

Note 3. Information Certified by the Plan's Trustee

Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 29, 2023, and December 31, 2022, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan) for the years ended December 29, 2023 and December 31, 2022.

Note 4. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 29, 2023 and December 31, 2022.

Shares of registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Party-in-Interest Transactions

Vanguard Fiduciary Trust Company, the third-party administrator for the Plan, assists the Company with selecting investments and monitoring investment results. Therefore, investment transactions qualify as party-in-interest transactions. Recordkeeping and investment fees paid by the Plan to Vanguard Fiduciary Trust Company were \$161,269 and \$118,709 for the years ended December 29, 2023, and December 31, 2022, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6. Income Tax Status

The Plan obtained its latest determination letter on June 30, 2010, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 29, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Delinquent Contributions

Due to administrative errors, the Company did not remit certain participant contributions and loan repayments of \$287,215, in a timely manner as defined by ERISA during 2023. These contributions are considered non-exempt party-in-interest transactions which may result on an imposition of a 15% excise tax on the amount of the transaction. The accompanying financial statements do not include any adjustments or accruals related to the potential liability for excise tax or lost earnings.

Note 10. Subsequent Events

The Plan has evaluated subsequent events through September 19, 2024, the date the financial statements were available to be issued. There were no material subsequent events requiring disclosure as of this date.
