NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Gastrointestinal and Liver Specialists of Tidewater, P.L.L.C. (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan investments were transferred to The 401(k) Plan of PE Gastro Management, LLC on January 11, 2023. The remaining assets of the Plan were transferred in December 2023. Plan participants are subject to the vesting provisions of the Gastrointestinal and Liver Specialists of Tidewater, P.L.L.C. 401(k) Profit Sharing Plan for the Company contribution portion of their accounts.

General: The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of ERISA. The Company’s Board of Managers (“Board”) is responsible for oversight of the Plan. The Plan Trustee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Board.

Contributions: Prior to 2023, participants could contribute up to the maximum allowed by law of their pretax annual compensation, as defined in the Plan. Participants could elect to designate all or a portion of their elective deferrals as Roth contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company made a non-elective safe harbor contribution equal to three percent of annual compensation to eligible participants. The Company could also make profit-sharing contributions to eligible participants. Participants directed the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant accounts: Each participant's account is credited with the participant’s contributions and Company safe harbor contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are vested immediately in their contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company’s profit-sharing contribution portion of their account is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

Notes receivable from participants: Prior to 2023, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loan interest rates were set at two percent above the prime rate, as defined. Principal and interest was paid ratably through payroll deductions.

Payment of benefits: On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or installments. In-service withdrawals are permitted for participants who have attained age 59 ½ or for a qualified financial hardship.

Forfeited accounts: At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0 and \$27,394, respectively. No forfeitures were used in 2023. Forfeited nonvested accounts were transferred to The 401(k) Plan of PE Gastro Management, LLC during 2023.

2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustee determines the Plan's valuation policies utilizing information provided by the investment adviser, Empower Retirement, LLC ("Empower") and Charles Schwab. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are deducted from loan proceeds. No allowance for credit losses has been recorded as of December 31, 2022.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping, the administration of notes receivable, and benefits

paid are charged to the participant's account and are included in administrative expenses. Investment-related expenses paid indirectly through revenue sharing arrangements are included in net appreciation of fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through September 13, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan had no investments at December 31, 2023.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage assets: At December 31, 2022, the self-directed brokerage accounts consisted of interest-bearing cash.

Interest-bearing cash: Valued at the carrying amount, which approximates fair value.

Guaranteed investment contract: The fair value of the non-fully benefit-responsive guaranteed investment contract is derived by Empower Annuity Insurance Company of America from the contract provisions. Fair value approximates contract value.

4. Related-Party Transactions and Party-in-Interest Transactions

Empower provides recordkeeping services to the Plan. Empower Trust Company, LLC provides custodial services for the Plan. Empower Annuity Insurance Company of America sponsors the Plan’s guaranteed investment contract. Charles Schwab provides brokerage services for the Plan’s self-directed brokerage accounts. As described in Note 2, the Plan paid expenses related to plan operations and investment activity. These transactions qualify as exempt party-in-interest transactions under ERISA.

5. Tax Status

The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020, that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan has been amended since receiving the advisory opinion letter, the Plan administrator and the pre-approved plan sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022, and net appreciation in fair value, dividends and interest for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively "Empower").

The certification mentioned above excludes certain Plan assets that were not held by Empower. A summary of the Plan's financial information which has not been certified is presented as follows:
