Commonwealth Care Alliance 403(b) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2023 Financial Statements

We have performed an audit of the financial statements of Commonwealth Care Alliance 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits in liquidation as of December 29, 2023, and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2023 to December 29, 2023, and the related notes to the financial statements (2023 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of Commonwealth Care Alliance 403(b) Plan's 2023 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 29, 2023, and for the period from January 1, 2023 to December 29, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2023 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2023 Financial Statements section

- the amounts and disclosures in the accompanying 2023 Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2023 Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2023 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2023 Financial Statements section of our report. We are required to be independent of Commonwealth Care Alliance 403(b) Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Use of Liquidation Basis of Accounting

As further discussed in Note 1a of the financial statements, the Plan's Retirement Plan Oversight Committee voted to terminate the Plan on December 30, 2022, and determined that liquidation is imminent. All plan assets have been distributed as of December 29, 2023. In accordance with accounting principles generally accepted in the United States of America, Commonwealth Care Alliance 403(b) Plan will be presented on the liquidation basis of accounting in the financial statements for the years ended December 29, 2023 and December 31, 2022, and period from January 1, 2023 to December 29, 2023. Our opinion is not modified in respect to this matter.

Responsibilities of Management for the 2023 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2023 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2023 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Commonwealth Care Alliance 403(b) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2023 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Auditor's Responsibilities for the Audit of the 2023 Financial Statements (Continued)

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Auditor's Report on the 2022 Financial Statements

Predecessor auditors performed an audit of the 2022 financial statements of Commonwealth Care Alliance 403(b) Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated October 3, 2023, indicated that (a) the amounts and disclosures in the 2022 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2022 supplemental schedule, other than the information in the 2022 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2022 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN

The following description of Commonwealth Care Alliance 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. Significant plan provisions which were in force prior to terminating the Plan are summarized below.

a. General

Prior to adopting a plan of liquidation, the Plan was a defined contribution 403(b) plan sponsored by Commonwealth Care Alliance (the Plan Sponsor) (the Organization). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Oversight Committee is charged with governance and oversight of the Plan, determining the appropriateness of investment offerings, and monitoring investment performance.

During 2022, the Organization acquired Reliance Healthcare and Vitality Health Plan of California. As a part of the evaluation of the retirement plan structure post acquisitions, the Organization decided, effective December 30, 2022, to terminate the Plan and create a new 401(k) plan. The Plan Sponsor instructed the third-party administrator to amend the Plan to provide for such termination and be liquidated in accordance with the terms and conditions of the Plan, including any rules or regulations promulgated by the Internal Revenue Service (IRS). Liquidation of the assets in the Plan occurred on December 29, 2023.

b. Eligibility

All employees of the Organization, regardless of age, were eligible to participate in the Plan and receive discretionary matching contribution upon their date of hire. Participants must have worked one year of service, 1,000 hours of service in the plan year, and be employed on the last day of the plan year to receive any discretionary non-elective contributions.

c. Contributions

Eligible participants could contribute through salary reductions up to 65% of eligible pre-tax annual compensation, as defined, limited to the maximum amount allowable under the provisions of the Internal Revenue Code (IRC). The Plan allowed for catch-up contributions for participants who had attained age fifty by the end of the plan year. The Plan allowed for participants to make after-tax (Roth) contributions. Participants could also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants directed the investment of their contributions into various investment options offered by the Plan. Participants were automatically enrolled into the Plan at 6% of eligible compensation as defined in the plan document. Upon December 30, 2022, the effective date of the termination of the Plan, participants were no longer able to make contributions into the Plan.

The Organization may make a discretionary matching contribution on elective deferrals and a discretionary non-elective contribution as determined each year by the Board of Directors. For the period ended December 29, 2023, no discretionary matching contributions or discretionary non-elective contributions were made by the Organization.

d. Participant Accounts

Each participant's account was credited with the participant's contributions, employer discretionary matching or non-elective contributions and plan earnings, and charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant's earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled to was the benefit that could be provided from the participant's vested account.

e. Vesting

Participants were immediately vested in their voluntary contributions, discretionary non-elective contributions, and actual earnings thereon. Discretionary matching contributions vested 20% after one year of service, 40% after two years of service, and 100% after three years of service. Upon death or disability, participants become 100% vested in their discretionary matching contributions. All participants were fully vested effective December 30, 2022, due to the plan being terminated.

f. Notes Receivable from Participants

Participants loans were not permitted by the Plan.

g. Payment of Benefits

Upon attaining normal retirement age of 65 or termination of services, a participant may have elected to receive a lump-sum distribution equal to the value of the participant's vested account balance, or leave their balance in the Plan if the balance exceeded \$5,000. The Plan required balances of \$5,000 or less to be paid out to participants upon termination of employment. There were also retirement benefits available upon disability or death. As a result of the plan termination, all participant accounts were distributed as of December 29, 2023.

The Plan allowed in-service withdrawals upon attainment of age 59½. A participant may have also requested a withdrawal upon demonstration to the Plan Administrator that they were suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of the Treasury or their delegate.

h. Forfeitures

Forfeitures represented non-vested Plan Sponsor discretionary matching contributions of participants who terminated their employment or who withdrew from the Plan. Forfeitures were retained by the Plan and were used to reduce Organization contributions or to pay plan expenses. As of December 31, 2022, the balance in the forfeiture account was \$506,973. There were no unallocated forfeitures as of December 29, 2023. During 2023, \$525,000 of forfeitures were allocated to participants as part of the 2022 discretionary matching contributions and \$69,485 of forfeitures were used to pay plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Basis of Presentation (Continued)

The 2023 and 2022 financial statements are presented on the liquidation basis of accounting due to the Plan Sponsor voting to terminate the Plan, management determining liquidation was imminent, and the Plan's asset being fully distributed as of December 29, 2023 (see Note 1a).

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. The difference between assets measured under the liquidation basis of accounting and fair value is immaterial to the financial statements, references to fair value are synonymous to liquidation basis.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments, including the non-benefit responsive contract, were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institution. See Note 4 for discussions of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from plan participants and discretionary matching contributions from the Organization are recorded in the year in which the participant contributions are withheld from compensation. The Organization's discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan administrative expenses may have been paid by the assets of the Plan, while certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions were charged directly to the participant's account. Investment-related expenses are included in net appreciation of investments.

Subsequent Events

Subsequent events have been evaluated through September 18, 2024, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition for disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits in liquidation as of December 29, 2023 and December 31, 2022, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits in liquidation for the period from January 1, 2023 to December 29, 2023.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. Fair Value Measurement establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENT (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value:

Money market fund: Valued at the daily closing price reported by the fund from an actively traded exchange.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed annuity contract: Valued based on discounted cash flows using a risk-based market discount rate.

Self-directed brokerage accounts: Consist of mutual funds and a money market fund valued as stated above.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All plan assets were liquidated as part of the plan termination. Accordingly, there are no investments held as of December 29, 2023.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Master Services Agreement (MSA). The Plan receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (Continued)

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. The Plan or the Organization may make a payment to Fidelity for administrative expenses not covered by revenue sharing. During 2023, the Plan paid the qualified institution and investment advisor administrative expenses totaling \$126,848, which is presented net of \$1,030 of the revenue sharing credit in the accompanying statement of changes in net assets available for benefits in liquidation.

6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated August 7, 2017, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan was operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits in liquidation.

8. PLAN TERMINATION

As discussed in Note 1a, the Plan was terminated during 2023. As of the effective date of the termination, all participants were 100% vested. All assets of the Plan were distributed as of December 29, 2023.
