## REPORT OF INDEPENDENT AUDITORS

To the Investment Committee and Management of the  
Lhoist North America 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Lhoist North America 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor’s Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2023 and 2022**

#### **A. Description of the Plan**

##### **General**

The following brief description of the Lhoist North America 401(k) Plan (the “Plan”) is provided for general information purposes only. The Plan is sponsored by Lhoist North America, Inc. (the “Company”). Participants should refer to the Plan document for more complete information.

The Plan was effective December 4, 1986, restated most recently effective January 1, 2021, and is a defined contribution plan available to all eligible employees of the Company. Eligible employees may enter the Plan immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The purpose of the Plan is to encourage the Company’s employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

##### **Contributions**

Each year, eligible participants may make pre-tax or Roth contributions (or a combination of both), from 1% to 50% of their eligible compensation, as defined by the Plan. In addition, participants may contribute up to 10% of annual compensation as designated after-tax contributions. The Plan also allows for in-plan Roth conversions of vested amounts. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan document. Eligible participants may make rollover contributions to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the year may make catch-up contributions in accordance with, and subject to, the limitations imposed by the Code.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at five percent of eligible compensation and their contributions invested in a designated target date fund until changed by the participants. The Plan also includes an auto-increase provision whereby all participants are subject to a one percent annual increase in deferral rate up to a maximum of ten percent unless they affirmatively elect not to participate in the auto-increase feature.

The Company offers safe harbor matching contributions for employees who are eligible in the amount of 100% of the first 3% of eligible participant compensation and 50% on the next 2% of eligible participant compensation. The Plan allows for matching on after-tax contributions in addition to pre-tax contributions, as defined in the Plan document.

**Contributions – continued**

The Company also contributes a supplemental employer contribution in addition to those previously discussed for all eligible non-bargaining employees (who are still employed on the last day of the Plan quarter) based on the eligible participants' earned base salaries and years of service per the below schedule. These contributions are deposited in participants' accounts quarterly.

The Company makes quarterly supplemental contributions to eligible bargaining employees as defined in the respective collective bargaining agreement and as defined by the Plan document.

**Participant Accounts**

Each participant's account is credited with his or her contributions, an allocation of the Company's contributions, as applicable, and Plan earnings (losses). Participant accounts are charged applicable participant loan maintenance fees. Allocations are based on the participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions, safe harbor employer matching contributions, and actual earnings thereon. Vesting of supplemental employer contributions is based on completion of the number years of service under the following schedule:

**A. Description of the Plan – continued**

**Participant Loans**

Participants may borrow from their accounts up to 50% of their vested account balances, not to exceed \$50,000. Loan terms range up to five years or longer for the purchase of a primary residence. The loans are secured by the balances in the participants' accounts, bear interest at rates determined by the Company, and are for terms not to exceed fifteen years. As of December 31, 2023, interest rates range from 4.25% to 9.50%. As of December 31, 2022, interest rates range from 4.25% to 8.50%. Principal and interest are paid ratably through payroll deductions. Participant loans are classified as notes receivable from participants in the Plan's financial statements.

**Benefit Payments**

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balances. Benefits are distributed in the form of rollovers, lump-sum payments, or in installments for a period not to exceed the life expectancy of the participant (or the joint life and last survivor expectancy of the participant and his or her beneficiary). If withdrawing participants are not entitled to their entire account balances, the amounts not received are forfeited.

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of his or her vested account balance while employed after reaching age 59 ½. A participant may receive a hardship distribution from salary deferral contributions if the hardship distribution is: (1) on account of uninsured medical expenses incurred by the participant, his or her spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from his or her principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) for payment of burial or funeral expenses for the participant's parent, spouse, or dependents; or, (6) for expenses to repair the participant's primary residence that qualify for the casualty deduction under the Code.

The Plan's hardship withdrawal provisions were updated in connection with the Bipartisan Budget Act. Participant deferral contributions will no longer be suspended after receipt of a hardship withdrawal, and earnings on elective deferral contributions in a participant's account will be included as part of a hardship withdrawal. The reasons for heavy financial need were also expanded to include certain disaster events and casualty losses not associated with disasters.

**A. Description of the Plan – continued**

**Forfeitures**

Plan forfeitures are used to pay administrative expenses of the Plan and supplemental employer contributions, and any remaining forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. For the years ended December 31, 2023 and 2022, approximately \$410,000 and \$240,000 of forfeitures were used to offset employer contributions. Additionally, there were no significant unallocated forfeitures at December 31, 2023 or 2022. There were no significant forfeitures allocated to participants during the years ended December 31, 2023 or 2022.

**Investment Options**

Upon enrollment in the Plan, a participant may direct all contribution sources into any of the Plan's investment options.

**B. Summary of Significant Accounting Policies**

**Plan Expenses**

Employees of the Company perform certain administrative functions with no compensation from the Plan. All significant administrative expenses are paid by the Plan and are reflected in the accompanying financial statements.

**Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

**Contributions**

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

**B. Summary of Significant Accounting Policies – continued**

**Investment Valuation and Income**

The investments of the Plan are stated at fair value as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and requires disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year-end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances.

**Payment of Benefits**

Benefits are recorded when paid.

**C. Fair Value Measurements**

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 – observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 – observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 – inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

**C. Fair Value Measurements – continued**

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- Money market funds are valued based on the short-term cash component as of the measurement date and classified within Level 1 of the valuation hierarchy.
- Mutual funds are valued at the published per share net asset value (“NAV”) of shares held by the Plan and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at NAV.
- The T. Rowe Price Stable Value Common Trust Fund, a common collective trust, is measured using the fair value reported by the Plan's third-party trustee and is classified within Level 2 of the valuation hierarchy as of December 31, 2023 and 2022. Additionally, the common collective trust is composed primarily of fully benefit-responsive investment contracts and is valued at the daily published NAV of \$1.00 per unit of the common collective trust. There are no significant restrictions on redeeming this investment at NAV.
- The T. Rowe Price Retirement Dated Trusts Series, common collective trusts, are measured using NAV (or equivalent) as a practical expedient to determine the fair value and are excluded from the valuation hierarchy as of December 31, 2023 and 2022. Additionally, the common collective trusts are valued based on the fair value of the underlying investments held by the fund less their liabilities. There are no significant restrictions on redeeming this investment at NAV.

**D. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (the trustee of the Plan).

**E. Tax Status**

Effective January 1, 2021, the Plan adopted a T. Rowe Price Retirement Plan Services, Inc. non-standardized pre-approved plan document, which has an advisory letter from the Internal Revenue Service (“IRS”) dated August 19, 2020, which may be relied upon by the plan administrator.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since submitting the application for the most recent determination letter; however, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

GAAP requires the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Plan participants have the option of selecting investments offered by affiliates of the trustee. These transactions qualify as party-in-interest transactions. Transactions in such investments are exempt from the prohibited transaction rules. Loans to participants qualify as party-in-interest transactions and are also exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

**F. Party-in-Interest Transactions – continued**

T. Rowe Price provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (“MSA”) between the Company and T. Rowe Price. T. Rowe Price received revenue from mutual fund service providers for services T. Rowe Price provides to the funds. This revenue is used to offset certain amounts owed to T. Rowe Price for its administrative services to the Plan.

If the revenue received by T. Rowe Price from such mutual fund service providers exceeds the amount owed under the MSA, T. Rowe Price credits the excess to the Plan’s administrative budget on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated as directed by the named fiduciary. During 2023 and 2022, approximately \$113,000 and \$112,000, respectively, of excess was used to pay Plan expenses. The Plan or plan sponsor may make a payment to T. Rowe Price for administrative expenses not covered by revenue sharing.

**G. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of complete or partial Plan termination, participants will become 100% vested in their accounts.

**H. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
