## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Celebrity Home Loans, LLC 401(k) Profit Sharing Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Celebrity Home Loans, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### *Opinion*

As further discussed in Note 9 to the financial statements, the Board of Directors of the Celebrity Home Loans, LLC 401(k) Profit Sharing Plan, the Plan's sponsor, terminated the Plan effective March 31, 2023. As a result, the Plan uses the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. ## NOTES TO FINANCIAL STATEMENTS

### 1. PLAN DESCRIPTION

The following description of the Celebrity Home Loans, LLC 401(k) Profit Sharing Plan (the “Plan”), formerly named the Midwest Equity Mortgage 401(k) Profit Sharing Plan, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan was terminated effective March 31, 2023. Accordingly, the descriptions below are provisions of the Plan prior to termination. See Note 9 for additional information.

#### General

The Plan is a defined contribution plan with a 401(k) feature sponsored by Celebrity Home Loans, LLC (the “Company”) covering all employees who have completed two months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Reliance Trust Company serves as the Plan custodian.

#### Contributions

Each year, participants may contribute an amount equal to a percentage of compensation (1% to 90%) not to exceed the maximum limitation set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions among any or all of the investment options offered by the Plan.

The Plan includes an automatic deferral feature. The Company will automatically withhold 5% of the participant’s compensation and contribute that amount to the Plan as a pre-tax 401(k) deferral unless the participant makes a contrary election.

The Company contributions are made at the option of management. The Company may make a discretionary matching contribution equal to a percentage of a participant’s salary deferrals. In addition, the Company may also make other discretionary non-matching contributions. Such contributions, if any, are allocated on the basis of the ratio of participant’s compensation to all participants’ compensation.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution, if any, and allocations of (a) the Company’s contribution, if any, (b) certain administrative expenses, as applicable, and (c) plan earnings, net of investment fees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### 1. PLAN DESCRIPTION (Continued)

#### Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings is based on years of continuous service. Participants are 100% vested after three years of credited service. In addition, a participant became 100% vested upon death, total and permanent disability by the Plan, or upon reaching normal retirement age.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to \$50,000 or 50% of their vested account balance, whichever is less. The maximum number of loans outstanding at any one time is two. Loan terms generally range from two to five years, but may be extended for the purchase of a primary residence. The loans are secured by the participant's vested account balance and bear an interest rate equal to the prime lending rate plus 1%. Principal and interest is paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service, a participant is eligible to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. An eligible rollover distribution is also permitted. If the value of a participant's account does not exceed \$5,000, the distribution is made in the form of a lump-sum payment. If the value of a participant's account exceeds \$5,000, the distribution can be made in the form of a lump-sum payment, installments over a period of not more than life expectancy, or partial withdrawals.

In-service withdrawals from fully vested accounts may be made at the participant's election prior to termination upon attainment of age 59 ½. The Plan also allows for financial hardship withdrawals of all or part of the participant's deferral contributions if the participant can prove financial hardship.

#### Forfeited Accounts

Forfeited amounts are to be used to pay plan expenses or reduce amounts otherwise required to be contributed to the Plan. At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$304, respectively.

#### Basis of Accounting

As described in Note 9, the financial statements of the Plan are prepared on the liquidation basis of accounting.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in fair value of investments includes reinvested dividend and interest income, and the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses, charged to participant accounts, and expensed when paid. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Distribution and loan fees are charged to the individual participant's account incurring the distribution or loan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### Subsequent Events

The Company has evaluated subsequent events through September 25, 2024, the date the financial statements were available to be issued.

### 3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements, including the fair value of investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years ended December 31, 2023 and 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1                      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2                      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Mutual fund shares are valued at quoted market prices in an exchange and active market, which represent the net asset value of shares held by the Plan at year end and are classified as Level 1 investments.

*Common/collective trust:* Valued at the net asset value (NAV) of units held at year end. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is calculated by the fund based on net assets, which includes fully benefit responsive contracts at contract value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. PLAN MERGER

In July 2022, Celebrity Home Loans, LLC acquired Apex Home Loans, Inc. in Rockville, MD. The Apex Home Loans, Inc 401(k) Profit Sharing Plan was merged into the Celebrity Home Loans, LLC 401(k) Profit Sharing Plan during the year ended December 31, 2022. An aggregate of \$11,554,761 was transferred and is included in transfers to the plan on the statement of changes in net assets available for benefits; this consisted of \$11,401,646 of plan assets and \$153,115 of loans transferred in July 2022.

### 6. TAX STATUS

The Internal Revenue Service has determined and informed the pre-approved plan provider, by a letter dated October 6, 2020, that the Plan, as then designed, is in accordance with applicable requirements of the Internal Revenue Code (IRC). The pre-approved plan provider has informed the Plan's administrator that the Plan was restated since receiving the determination letter. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in values of investment securities would occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

### 8. PARTY-IN-INTEREST TRANSACTIONS

The Plan paid certain expenses related to general administration and record keeping to various service providers. These transactions are party-in-interest transactions under ERISA. In addition, the Plan Sponsor pays a portion of these expenses and certain accounting and auditing fees related to the Plan.

### 9. PLAN TERMINATION

Effective March 31, 2023 the plan sponsor resolved to terminate the Plan. The Plan adopted the liquidation basis of accounting based on the approval of the board resolution. Upon termination, all participants with an account balance as of the date of termination became 100% vested. Participants with account balances were provided with notification of the termination and were provided instructions for processing distribution of their account balance. As of December 31, 2023, all Plan assets have been distributed to all participants.
