Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bennett Aerospace 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bennett Aerospace 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter – Plan Merger

As further discussed in Note 1 to the financial statements, the plan was merged with Old Harbor Profit Sharing 401(K) Plan. All assets of the Plan were transferred on December 29, 2023 and the Plan ceased operations.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Bennett Aerospace 401(K) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. 1. DESCRIPTION OF PLAN

The following description of Bennett Aerospace 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- a. Plan Merger – On December 29, 2023, the Plan was merged with and into the Old Harbor Profit Sharing 401(K) Plan. Following the merger, benefit payments will be provided under the Old Harbor Profit Sharing 401(K) Plan.
- b. General – The Plan is a defined contribution plan established on October 1, 2012. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of Bennett Aerospace, Inc. (the "Company" and "Plan Sponsor") are eligible to participate in the Plan. Plan management is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance upon the direction of the Plan Trustee, Fidelity Management Trust Company.
- c. Contributions – Upon employment, participants may contribute up to the maximum amount allowed by law of pretax and or after tax annual compensation each year, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan document provides for a discretionary matching contribution by the Company based on business units.

The Company has two defined business units, professional and non-professional. The professional unit includes employees in management, subject matter experts and employees providing science, engineering and technology assistance. Whereas, the non-professional unit consists of data and management analyst and administrative support employees. The Company elected to contribute 50% of the first 6% contributed to the Plan for its professional unit and 50% of the first 3% contributed to the Plan for its non-professional unit. The Plan document also provides for discretionary profit sharing and prevailing wage contributions. The Company did not make a discretionary profit sharing contribution for 2023.

Prevailing wage contributions are made for Participants who perform services for the Company under prevailing wage contracts. The prevailing wage contribution is not subject to any age or service requirement. Participants direct the investment of all contributions made on their behalf into various investment options offered by the Plan. Contributions are subject to annual limits established by the Internal Revenue Service. In December 2018, the Plan was amended, effective January 1, 2019, to require one year of service to participate in discretionary matching contributions by the Company; the one year of service requirement to participate in any discretionary profit sharing contributions by the Company remained unchanged.

- d. Participant Accounts – Each participant's account is credited with (1) the participant's contribution, (2) the company's contributions, and (3) allocation of (a) plan earnings and (b) administrative expenses that are paid by the Plan. Allocations are based on participant's plan compensation or participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

- e. Vesting – Participants are vested immediately in their elective and prevailing wage contributions plus actual earnings thereon. Vesting of the Company’s matching and discretionary profit sharing contributions portion of their accounts is based on the following schedule:

Participants will automatically become 100% vested upon attainment of normal retirement age (65) or retirement due to disability or death.

- f. Cash and cash equivalents – Cash and cash equivalents includes monies held in an interest bearing money market account at December 31, 2023 and 2022.
- g. Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A Participant may only have one outstanding loan from the Plan at a time. The loans are secured by the balance in the participant’s account and bear interest at prime plus 1.00% at the date of the loan issuance. Interest rates on the outstanding loans as of December 31, 2022, range from 4.25% to 8.00% and these loans mature at varying dates from 2023 through 2031. Loans must be repaid within 5 years except for loans for the purpose of acquiring a principal residence whose term shall be determined by the Plan administrator. Generally, principal and interest is paid ratably through biweekly payroll deductions.
- h. Payment of Benefits – Upon termination of service due to death, disability, retirement, or any other reason, the participant or beneficiary may elect to receive a lump-sum payment equal to the value of the participant’s vested interest in his or her account. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive a required minimum distribution under IRS Code Section 401(a) (9). In addition, during active service, a participant can take hardship distributions if certain conditions are satisfied, and a participant upon the attainment of age 59 1/2 can take in-service distributions from their accounts in which they are vested.
- i. Forfeited Accounts – Forfeitures of terminated participants' non-vested accounts are held in an interest bearing money market account by the trustee at December 31, 2023 and 2022. At December 31, 2023 and 2022 there were \$0 and \$49,863, respectively, held in the interest bearing cash account of which \$0 and \$1,795, respectively, represented forfeited non-vested accounts. Forfeitures are used to reduce employer contributions or pay Plan expenses. In 2023, \$20,122 in forfeitures were used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the insurance company and trustee. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued on the accrual basis. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document and loan agreement.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants in 2023. There were no excess contributions in 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation or depreciation of fair value of investments.

3. FAIR VALUE MEASUREMENTS

The Plan follows FASB ASC 820, *Fair Value Measurements*, which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

FASB ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The categorization of each investment type within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

FASB ASC 820 established three levels of inputs that may be used to measure fair value. Level 1: Quoted prices in active markets for identical assets or liabilities at the measurement date; Level 2: Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active market for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or Level 3: Unobservable inputs that are supported by little or no market activity and that reflect the Plan's own assumptions about market participants and prices.

Investment Valuation

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company, a qualified institution, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

6. TAX STATUS

On March 31, 2014, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401 of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held in mutual fund accounts held by the trustee. Fidelity Management Trust Company is the trustee for the Plan's assets; therefore, transactions between the Plan and trustee qualify as party-in-interest transactions. For the year ended December 31, 2023 Fidelity Management Trust Company was paid \$24,295 for plan administration and commissions.

Kestra Advisory Services (Kestra) is the investment broker for the Plan and Gallagher Fiduciary Advisors (Gallagher) is the plan advisor; therefore, transactions between the Plan and the investment broker and advisor qualify as party-in-interest transactions. For the year ended December 31, 2023, Kestra and Gallagher were paid direct compensation of \$13,427 for such services.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (Continued)

Strategic Advisors, Inc. is the investment manager for the Plan; therefore, transactions between the Plan and the investment manager qualify as party-in-interest transactions. For the year ended December 31, 2023, Strategic Advisors, Inc. was paid direct compensation of \$2,967 for such services.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

9. CONCENTRATIONS

At December 31, 2022, 13%, 13%, 13%, 10% and 12% were held in Fidelity Freedom Index 2025, Fidelity Freedom Index 2030, Fidelity Freedom Index 2035, Fidelity Freedom Index 2050, and Fidelity 500 Index, mutual fund accounts, respectively.

10. CARES ACT

During 2020, as allowed by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) the following Plan operations were adopted without formal amendment:

- Participants may take a coronavirus-related distribution of up to \$100,000 (not to exceed the participant's vested account balance) without a 10% early withdrawal penalty. Eligible distributions can be taken up to December 31, 2020. Coronavirus-related distributions may be repaid within three years. The plan administrator may rely on an employee's certification that the employee satisfies the conditions for a coronavirus-related distribution.
- Required minimum distributions are suspended for 2020.

11. SUBSEQUENT EVENTS

The Plan has evaluated events and transactions that occurred between December 31, 2023 and September 26, 2024 which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.
