
Business Name and Types: TLBF LLC dba: Marco's Pizza

I'll do my best to keep this short. PayChex is and has been our payroll provider for approximately 12 years dating back to when we started our Marco's Pizza Franchise business. During the height of the Covid Pandemic 2020, and in an attempt to keep our business alive, to retain and attract employees, PayChex made an offering to develop a "401-K Plan" and be our Plan Administrator. Unfortunately, the PayChex employee we were working with to develop "The Plan" implemented/started/initiated "The Plan" prematurely. We weren't ready and had not given our full consent to begin. We were still identifying eligible full-time employees, ineligible minor employees, et, et... The cascading affect was of course awful.

Subsequently, we immediately forced the "Plan" termination. PayChex had already pulled some monies from employee pay checks and put the monies into "The TLBF LLC 401-K Plan". I think "The Plan" was in affect for maybe two months? Most unfortunately, it took Paychex more than a year to finally resolve everything pushing it into the 2022 fiscal year. Everyone's monies were made whole and correct. Fiscal years 2020 & 2021 PayChex filed the appropriate IRS forms/information. It was our understanding that PayChex would file the Final 2022 Form 5500SF with the IRS? And that's where it went sideways. Again, everyone involved was made whole and everything was corrected, except the Final Form 5500SF for 2022 wasn't filed.

We apologize for this crazy and unfortunate situation. We are a very small business and hope that the IRS can see the way through all of this and not impose any fines, penalties or interest? This would cause us great financial distress to our business. You can see our previous tax returns for additional perspective. Post Covid has been extremely difficult with increased costs and decreased sales.
