Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kanes Furniture, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended March 31, 2023, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Kanes Furniture, LLC (Company) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on October 1, 1960. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Through October 31, 2018 the Plan was a defined contribution plan covering all regular full-time employees of the Company who had one year of service and had obtained the age of twenty years old. The Plan was amended and restated November 1, 2018 to add a 401(k) provision and to change the Plan name from Kane Furniture Corporation Profit Sharing Retirement Plan and Trust to Kane Furniture Corporation 401(k) Profit Sharing Plan. Effective January 1, 2022 the name was changed to Kanes Furniture, LLC 401(k) Profit Sharing Plan. Effective January 1, 2019 the Plan was amended to add an automatic employee deferral feature for all eligible employees hired after the effective date, unless the employee opts out of the deferral. Eligible employees must be at least age 20 and have 90 days service with the Company.

Contributions

Each year, the Company may contribute to the plan, at the discretion of the Company's board of directors, an amount not to exceed 15% of total participant compensation. For the year ended March 31, 2023, the Company's contribution was 1.5% of total participant compensation. Contributions are based on an eligible participant's W-2 wages for 2022.

Each year, participants may contribute up to 100% of pretax annual compensation not to exceed \$20,500, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make up to \$6,500 of catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts 50% of their vested account balance to a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates of 4.25% to 8.75%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her accounts in either a lump-sum amount, or by one of several types of annuity contracts. Participants must begin receiving payment of retirement benefits no later than the April 1st after the end of the calendar year in which the age 70-1/2 is attained.

Vesting

Vesting in the accounts is based on years of continuous service. A participant is 100% vested after 6 years of accredited service.

Forfeited Accounts

Forfeitures, representing the non-vested portion of terminated participants' non-contributory account balances in the Plan, are available to pay Plan expenses. As of March 31, 2023 there were \$21,673 of available forfeitures.

Participants' Rights upon Termination

In the event the Plan is terminated, participants have a non-forfeitable right to the vested balances in their accounts. Any funds remaining after the distribution of vested account balances will be prorated to participants in the ratio of their remaining non-vested account balances.

Plan Amendments

The Plan had been amended in 1983, 1984, 1986, 1989, 1993, 1994, 1996, 1997, 2004, 2015, 2016, 2018 and 2019. The primary purpose for these amendments, other than those described above, were to comply with various law changes. As a result, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable income tax provisions including The Tax Equity and Fiscal Responsibility Act of 1982; The Deficit Reduction Act of 1984; The Retirement Equity Act of 1984; The Tax Reform Act of 1986; The Revenue Act of 1987; The Technical and Miscellaneous Reform Act of 1988; The Omnibus Budget Reconciliation Act of 1993; The Economic Growth and Tax Relief Reconciliation Act of 2001; and The American Job Creations Act of 2004.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Except for loan origination fees associated with notes receivable from participants, all administrative expenses of maintaining the plan are paid by the Plan. The Plan sponsor paid \$8,500 of the Plan's administrative expenses during 2023.

Subsequent Events

The Plan has evaluated subsequent events through July 23, 2024, the date the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

For the year ended March 31, 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) depreciated in value by \$625,701.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

- Level 2 Inputs to the valuation method include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2023 and 2022.

The fair value of pooled separate accounts is based on quoted net asset values of the shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the Company contribution portion of their account.

NOTE 6 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated September 16, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision has been made for income taxes.

NOTE 7 - VESTED ACCOUNT BALANCES DUE TO WITHDRAWN PARTICIPANTS

As of March 31, 2023 there were no account balances with vested benefits allocated to persons who had elected to withdraw from the Plan that had not been paid.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
