### Report on the Audit of the Financial Statements

#### **Opinion**

We have audited the financial statements of Advisor 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of April 10, 2024 (in liquidation) and December 31, 2023 and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the period and years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Advisor 401(k) Retirement Plan as of April 10, 2024 (in liquidation), December 31, 2023 and 2022 (ongoing), and the changes in its net assets available for benefits for the period and years then ended, in accordance with accounting principles generally accepted in the United States of America.

#### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. As described in Note 1 to the financial statements, the Organization approved a plan of liquidation effective April 9, 2024, and management determined liquidation is imminent during the period ended April 10, 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 and 2022 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

***Supplemental Schedules Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) as of December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

# ADVISOR 401(k) RETIREMENT PLAN

## Notes to Financial Statements

### (1) Plan Description

The following brief description of Advisor 401(k) Retirement Plan (the Plan) was provided for general informational purposes. Participants should refer to the Plan document for more complete information. The Plan, although not subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), operated in compliance with ERISA.

The Plan was a defined contribution savings and retirement plan sponsored by Minnesota Life Insurance Company (the Company) for the benefit of its agents. On April 9, 2024, the Company's board of directors approved the termination of the Plan. The Plan was liquidated on April 10, 2024. There were no material adjustments between termination date and liquidation date.

On August 10, 2023, Securian Financial Group, Inc. (the Company's parent company), sold its retail wealth management business, including all active agents of the Company. Upon completion of the sale, there were no further salary or matching contributions made to the plan. Prior to August 10, 2023, active agents who were at least 21 years old were eligible to make salary reduction contributions and received employer matching contributions.

The Plan allowed Plan participants to elect to voluntarily contribute from their compensation an amount up to the maximum allowed by law which was limited to \$23,000, \$22,500 and \$20,500 in 2024, 2023, and 2022 respectively. Participants were 100% vested in their voluntary contributions.

The Plan allowed the Company to make a matching contribution on behalf of each eligible active Plan participant. The matching contribution was contributed on a per pay period basis equal to 100% of the participant's voluntary contributions not to exceed 3% of the participant's compensation and 50% of the participant's voluntary contributions that exceed 3% but do not exceed 5% of the participant's compensation. Participant's compensation represented total compensation paid to the participant by the Company including contributions provided to the agent pursuant to a salary reduction agreement. Matching contributions were 100% vested and non-forfeitable at all times.

Participants could elect to make Roth Salary Savings (Roth(k)) contributions in addition to or in place of traditional 401(k) contributions. The Roth(k) contributions were separately accounted for, as were gains and losses attributable to those Roth(k) contributions, in a Roth(k) account. Participants were 100% vested in their voluntary contributions.

Plan earnings and administrative expenses were allocated to participants' accounts based on account balances.

The Plan allowed for rollover transfers to be made to the Plan by participants with the consent of the Company. These rollover transfers were lump-sum distributions from other tax-qualified plans of previous employers that participants elected to have invested in the Plan within sixty days of receipt.

Contributions were automatically deferred and/or distributed as provided by the Plan upon retirement, disability, or termination of employment of a participant. Plan participants could elect to withdraw vested amounts if the participant had attained age 60 within ten years of vesting services or had attained age 55 with fifteen years of vesting service.

Forfeitures were used to reduce employer matching contributions and management fees and other plan expenses. Forfeiture amounts used during 2024, 2023 and 2022 were \$0. Unallocated forfeiture account balances at April 10, 2024, December 31, 2023 and 2022 were \$0.

### (1) Plan Description (Continued)

Participants could request a loan not to exceed the lesser of the participant's deferral and rollover balance and such participant's Roth salary reductions contributions or rollover accounts, 50% of the participant's vested balance or \$50,000. The minimum loan amount was \$1,000 for 2024, 2023 and 2022, respectively. New loans (including refinances) incurred a one-time fee of \$150. Interest charges on such loans were calculated monthly by averaging CD rates available at local financial institutions, which ranged from 6.58% to 6.62% in 2024, 6.23% to 6.73% in 2023 and 4.62% to 6.10% in 2022. Principal and interest were paid ratably by monthly payroll deductions or other methods of payments. Participants' loans were referred to as notes receivable from participants in the statement of net assets available for benefits.

### (2) Summary of Significant Accounting Policies

#### Basis of Presentation

As a result of the termination effective April 9, 2024, Plan management determined liquidation of the Plan is imminent. In accordance with accounting principles generally accepted in the United States of America (GAAP), the Plan changed its basis of accounting from the accrual basis used in presenting the 2023 and 2022 financial statements to the liquidation basis used in presenting the 2024 financial statements. The application of liquidation basis did not have a material impact on the Plan's financial statements. GAAP requires management to make certain estimates and assumptions that affect reported amounts of net assets available for benefits and changes therein and disclosure of contingent net assets and liabilities at the date of the financial statements. Actual results could vary from those estimates.

#### Plan Assets

Assets of the Plan were deposited under a group annuity contract with the Company. The deposits were maintained in either the general account or in pooled separate accounts of the Company.

Deposits in the general account were non benefit-responsive and were stated at cost plus accrued interest, which represents fair value. Pooled separate account deposits were stated at the underlying fair value of the pooled separate account investments, which consisted primarily of mutual funds, fixed maturity securities, equity securities and cash and cash equivalents. The estimated fair value of pooled separate accounts were based on the fair value of the underlying assets owned by the pooled separate account and were generally based on observable inputs. Purchases, transfers, and withdrawals of units of the pooled separate accounts were based on the fair value of the accounts at the date of purchase, transfer, or withdrawal. Purchases and sales of securities were recorded on a trade date basis.

Net appreciation (depreciation) of pooled separate accounts were comprised of realized gains (losses) on sales of separate account investments and changes in unrealized appreciation (depreciation) in the fair value of separate account investments based on published security prices.

#### Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable were reclassified as taxable distributions based upon the terms of the Plan Document. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, a taxable distribution was recorded.

#### Administrative Expenses

A portion of the administrative expenses of the Plan were paid by the Company.

Notes to Financial Statements (Continued)

**(2) Summary of Significant Accounting Policies (Continued)**

Benefit Payments

Benefits were recorded when paid. The benefit payments of \$1,942,973 were a result of the Plan termination. The payments were made to participants or to a trust if an affirmative distribution election was not made.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 28, 2024, the date the financial statements were available to be issued.

**(3) Risks**

The Plan's financial statements were based on estimates and assumptions that were subject to significant business and economic risks and uncertainties, many of which were beyond management's control or were subject to change. As such, actual results could differ from the estimates used in the Plan's financial statements and the value of the Plan's investments and net assets available for benefits could be adversely affected. The following risks and uncertainties, among others, may have such an effect:

- Economic environment and capital markets-related risks such as those related to interest rates, equity markets and credit spreads.
- Investment-related risks such as those related to valuation.
- Business and operational-related risks such as those related to cyber or other information security, fraud, and overall risk management.
- Catastrophic and pandemic event-related risks that may impact volatility in financial markets and economic activity, and operations.
- Regulatory and legal risks such as those related to changes in tax, fiscal and other legislation, the regulatory environment impact to the Plan and accounting standards.

Management actively monitored and managed risks and uncertainties through a variety of policies and procedures in an effort to mitigate or minimize the adverse impact of any exposures impacting the Plan's financial statements.

**(4) Fair Value of Financial Instruments**

The fair value of the Plan's financial assets and financial liabilities has been determined by the Company using available market information as of December 31, 2023 and 2022. Although the Company was not aware of any factors that would significantly affect the fair value of financial assets and financial liabilities, such amounts have not been comprehensively revalued since those dates. Therefore, estimates of fair value subsequent to the valuation dates may differ significantly from the amounts presented herein. Considerable judgment was required to interpret market data to develop the estimates of fair value. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value amounts.

#### Financial Assets and Financial Liabilities Reported at Fair Value

For reporting purposes, current value was equal to fair value.

Fair value was defined as the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. In determining fair value, the Company primarily used the market approach which utilized prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities. To a lesser extent, the Company also used the income approach which used discounted cash flows to determine fair value. When applying either approach, the Company maximized the use of observable inputs and minimized the use of unobservable inputs. Observable inputs reflected the assumptions market participants would use in valuing a financial instrument based on market data obtained from sources independent of the Company. Unobservable inputs reflected the Company's estimates about the assumptions market participants would use in valuing financial assets and financial liabilities based on the best information available in the circumstances.

The Plan was required to categorize its financial assets and financial liabilities recorded in the statements of net assets available for benefits according to a three-level hierarchy. A level was assigned to each financial asset and financial liability based on the lowest level input that was significant to the fair value measurement in its entirety. The levels of fair value hierarchy were as follows:

Level 1 – Fair value was based on unadjusted quoted prices for identical assets or liabilities in an active market.

Level 2 – Fair value was based on significant inputs, other than quoted prices included in Level 1, that were observable in active markets for identical or similar assets and liabilities.

Level 3 – Fair value was based on at least one or more significant unobservable inputs. These inputs reflected the Company's assumptions about the inputs market participants would use in pricing the assets or liabilities.

The Company used prices and inputs that were current as of the measurement date. In periods of market disruption, the ability to observe prices and inputs may be reduced, which could cause an asset or liability to be reclassified to a lower level.

### (5) Party-In-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a party-in-interest were prohibited under ERISA unless a specific exemption applies. The Company was a party-in-interest as defined by ERISA and received deposits under the Plan in accordance with the group annuity contract issued to the Plan Trustees. These transactions were covered by an exemption from the “prohibited transactions” provisions of ERISA and the Internal Revenue Code (the Code).

The Company charged the Plan contract management fees and other plan expenses of \$340, \$5,262 and \$36,989 for the period from January 1, 2024 to April 10, 2024, and years ended December 31, 2023 and 2022, respectively.

### (6) Federal Income Taxes

The Plan had adopted a prototype plan that had received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the Plan was designed in compliance with the applicable sections of the Code. The Plan had been amended since receiving the opinion letter. However, the Plan sponsor and the Plan’s legal counsel believe the Plan was being operated in compliance with the applicable provisions of the Code. Therefore, no provision for income taxes had been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America required plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods.
