Opinion

1. DESCRIPTION OF PLAN:

The following description of the Rhinegeist Brewery 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering certain employees of Rhinegeist Holdings, LLC, Inc. and its wholly owned subsidiaries (collectively the "Company" or "Employer"). The Plan provides for participation after the age of 21 for all employees, other than employees covered by a collective bargaining agreement and non-resident aliens who received no earned income for services performed within the United States. In 2022, the Plan was amended and restated to include Rhinegeist Holding Company, Inc. as an affiliated service group. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On December 8, 2023, the Company entered into a participating employer agreement with Total PEP Solutions, which is a pooled employer plan. On December 13, 2023, the Plan merged and all assets were transferred to Total PEP Solutions.

Contributions

Participants may elect to make pre-tax and/or after-tax contributions through regular payroll deductions of an amount up to 100% of eligible compensation, subject to Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company match is discretionary. In 2023, the Company match was 25% of participant contributions, up to 4% of a participant's annual compensation.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings and losses thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their 401(k) contributions, catch-up contributions, and rollover contributions, as adjusted for earnings and losses thereon. Participants are vested in Employer matching contributions based on years of continuous service. A participant is 100% vested after completing three years of credited service.

Payment of benefits

Distributions may generally be made to a participant upon the participant's retirement, death, disability, or termination of employment with the Company. Benefits shall be paid to participants in the form of a lump sum amount equal to the value of the participant's vested interest in his or her account.

In conditions of “financial hardship”, a participant may apply to the plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the IRC.

Forfeited accounts

At December 13, 2023 and 2022 forfeited non-vested accounts amounted to \$0 and \$1,508, respectively. Forfeitures may be used to pay administrative expenses of the Plan or reduce future Employer matching contributions. During the period ended December 13, 2023, the Plan applied \$1,841 in forfeitures to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 20, 2024, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted

quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 13, 2023 and December 31, 2022.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

In 2023, the Plan liquidated its investments by merging into another Plan. Therefore, there is no balance as of December 13, 2023. The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are shares of mutual funds and a money market fund managed by American Funds. American Funds is an entity related by common ownership to the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

5. TAX STATUS:

The Plan elected to adopt a non-standardized pre-approved profit sharing plan document which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the volume submitter plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.
