The IRS has confirmed that church plans that do not make a Code section 410(d) election are not required to file the annual Form 5500. See IRS Announcement 82-146, 1982-47 I.R.B. 55.

Because Lutheran Services Florida, will be sponsoring a church plan for which the election under Code section 410(d) has not been made, the 2023 Form 5500 is the final filing for the Plan.
