Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Visiting Nurse Association and Hospice of Vermont and New Hampshire, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Visiting Nurse Association and Hospice of Vermont and New Hampshire, Inc. 403(b) merged into the Dartmouth-Hitchcock Employee Investment Plan on December 31, 2023. As a result, the Visiting Nurse Association and Hospice of Vermont and New Hampshire, Inc. 403(b) Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from

fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan:

The following brief description of the Visiting Nurse Association and Hospice of Vermont and New Hampshire, Inc. 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General – The Plan is a defined contribution plan covering all employees of Visiting Nurse and Hospice of Vermont and New Hampshire, Inc. (the Organization). All employees are allowed to make elective deferrals. Employees who have completed one year of eligible service are also eligible for Organization discretionary contributions. Eligible service is defined in the Plan document as 1,000 hours of service during the Plan year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination – On December 19, 2023, the Plan merged into the Dartmouth-Hitchcock Clinic and Mary Hitchcock Memorial Hospital sponsored Dartmouth-Hitchcock Employee Investment Plan. Effective December 31, 2023, participant activity ceased, the Plan was liquidated, and all Plan assets were transferred to Vanguard, the trustee, custodian and recordkeeper of the Dartmouth-Hitchcock Employee Investment Plan. The net assets transferred comprised of \$4,907,774 in investments, \$74,182 in employer contributions receivable, and \$124,173 in participant loans, for a total transferred of \$5,106,129.

Contributions – Participants may elect to defer from one percent (1%) up to one hundred percent (100%) of pre-tax annual compensation, subject to annual dollar limitations established by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, and participants that are 50 years old or older could make additional “catch-up” contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers several mutual funds and annuities as investment options for participants. The Organization may contribute a discretionary matching amount.

Participant Accounts – Each participant’s account is credited with the participant’s voluntary contribution, the Organization’s discretionary matching contribution (if such is made), and investment income. Allocations of Plan earnings are based on a participant’s account balance relative to the total account balance of all participants in the same investment. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan.

Payment of Benefits – Participants may not make withdrawals from their Participant’s Elective Account except for:

- (1) Normal retirement – the later of age 65 or the fifth anniversary of employment;
- (2) Total and permanent disability;
- (3) Death;
- (4) Termination of employment;
- (5) Attainment of age 59½; or
- (6) Financial hardship

Distributions will be paid as soon as possible following termination date, except for financial hardship withdrawals which are payable immediately. Distributions are paid to participants in a lump sum or in installments for a specified term.

1. Description of the Plan (continued):

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 (not to exceed 50% of the participant's vested account balance). Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. Loan terms range from 3 to 5 years and up to a reasonable period commensurate with the repayment period permitted by commercial lenders for similar loans by commercial lenders for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably. Participants also have the option to repay the loan at any time during the term in a lump-sum payment.

Vesting – Participants are fully vested upon entering the Plan.

Forfeitures – Participants are at all times 100% vested in their accounts, including the employer discretionary contribution, normally resulting in no forfeitures in the Plan. Forfeitures may be used to reduce the Organization's contributions to the Plan or to pay plan expenses. During the year ended December 31, 2023, forfeitures used to offset employer contributions and pay plan expenses were \$5,295. As of December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$5,270, respectively.

2. Summary of Significant Accounting Policies:

Basis of Presentation – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld.

2. Summary of Significant Accounting Policies (continued):

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

Benefit Payments – Benefit payments to participants are recorded upon distribution.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through September 25, 2024, the date the financial statements were available to be issued.

3. Tax Status:

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan should the IRS open such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Risks and Uncertainties:

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

5. Information Prepared and Certified by Custodian:

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Variable Annuity Life Insurance Company (VALIC) served as the Plan's custodian. They have provided the Plan administrator with certifications as to the completeness and accuracy of cash, investment balances, interest and dividend income, realized gains (losses) on the sale of investments and unrealized appreciation (depreciation) of investments in accordance with the Department of Labor Regulations. The employer contributions receivable totaling \$0 and \$85,621 as of December 31, 2023 and 2022, respectively, has not been certified by the trustee.

6. Contract With Insurance Company:

On December 20, 1991, and as amended through October 14, 2000, the Organization entered into an unallocated deposit administration (DA) insurance contract with VALIC. Monies in the account are commingled with other assets of the insurance company. The general account, Fixed Account Plus, is credited with at least 3% interest per year. Variable investment options are available within Separate Account A consisting of various mutual funds. Each mutual fund has a different investment objective. Investment returns on variable investment options may be positive or negative.

7. Investments, at Contract Value:

The participant's investment options include a benefit-responsive investment contract with VALIC. VALIC maintains the contributions in a Fixed Account Plus and a Short-Term Fixed Account. The contract is included in the financial statements at contract value as reported to the Plan by VALIC. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contracts held by the Plan participants are guaranteed investment contracts. VALIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3 percent. Such interest rates are reviewed on a monthly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contraction obligations may be affected by future economic and regulatory developments.

7. Investments, at Contract Value (continued):

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial termination or merger with another plan); (2) changes to the Plan's prohibition competing investment options or deleting of equity wash provisions; (3) bankruptcy of the Plan sponsor or other cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the Plan's ability to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

8. Fair Value Measurements:

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; and Inputs other than quoted prices that is observable for the asset or liability. Inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

8. Fair Value Measurements (continued):

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds are held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of the different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Related Party and Party-in-Interest Transactions:

The Organization provides certain accounting and administrative services to the Plan for which no fees are charged. The employees that provide these services are also contributing participants in the Plan. These transactions qualify as party-in-interest transactions.

Plan investments are managed by VALIC. VALIC is the custodian and recordkeeper for the Plan and, therefore, transactions with VALIC qualify as party-in-interest transactions.
