### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have audited the financial statements of AC Corporation 401(k) Employee Savings and Protection Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1, 2023 to October 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AC Corporation 401(k) Employee Savings and Protection Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

As further discussed in Note 1 to the financial statements, on September 30, 2023, Plan management elected to merge the AC Corporation 401(k) Employee Savings and Protection Plan into the Crete Mechanical Group, Inc. 401(k) Plan. All net assets available for benefits were transferred effective as of October 31, 2023. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1 - DESCRIPTION OF PLAN

The following description of the AC Corporation 401(k) Employee Savings and Protection Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible classes of employees of AC Corporation, (the "Company") who attain 18 years of age and one month of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Retirement Committee of the Board of Directors determined the appropriateness of the Plan's investment offerings, monitors investment performance and reported to the Plan administrator.

**Plan Merger**

On August 16, 2022, AC Corporation was purchased by Crete Mechanical Group, Inc. Subsequent to the purchase of AC Corporation, Plan management adopted a resolution to merge the Plan into the Crete Mechanical Group, Inc. 401(k) Plan as of September 30, 2023. The transferred net assets have been recognized in the accounts of the Crete Mechanical Group, Inc. 401(k) Plan as of October 31, 2023, at their balances as previously carried in the accounts of the Plan in the amount of \$29,513,084. The Crete Mechanical Group, Inc. 401(k) was restated to allow for the addition of the Plan and to take ownership of the transferred net assets of the Plan.

**Contributions**

Prior to the merger, participants were able to contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation and would increase annually by an increment of 2%, up to a maximum deferral of 12% of eligible compensation, unless otherwise elected by the participant. Contributions were invested in the Plan's default investment alternatives established under the Plan until changed by the participant. The Plan offered a money market account, various mutual funds and a stable value collective investment funds as investment options for participants.

Prior to the merger, the Company made discretionary matching contributions up to a percentage of employee contributions. For the Plan years ended October 31, 2023 and December 31, 2022 the Company contributed matching contributions of 50% of the first 5% of eligible compensation that a participant contributed to the Plan. Contributions were subject to certain limitations as determined by the Internal Revenue Code ("IRC").

**Participant Accounts**

Prior to the merger, each participant's account was credited with the participant's contributions, including amounts rolled over from other qualified plans, and Company discretionary matching contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

**Vesting**

Prior to the merger, participants were vested immediately in their contributions, including amounts rolled over from other qualified plans, plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of participant accounts was based on years of continuous service. Under these vesting provisions, a year of service was determined based on time elapsed since the date of employment with the Company. Participants become vested in Company's discretionary matching contribution on a graded 6-year schedule if hired before December 15, 2012 and a 2-year schedule if hired after December 15, 2012, as defined by the Plan.

**Notes Receivable from Participants**

Prior to the merger, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant could have one outstanding loan at a time. The loans were secured by the balance in the participant's account and bear interest at prime rate plus 1%, which was commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest were paid ratably through regular payroll deductions.

**Payment of Benefits**

Prior to the merger, the Plan permitted withdrawals when a participant terminated employment, reached normal retirement age or became disabled or deceased. Upon termination, participant consent was not required for distributions of an account balance less than \$5,000. In-service withdrawals were also permitted for certain financial hardships or when a participant attained age 59 1/2. Benefits were payable in lump-sum payments.

**Forfeited Accounts**

At October 31, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$-0- and \$13,894, respectively. These accounts were used to pay administrative expenses and any remaining would be used to reduce future employer contributions. During 2023, the Company used \$20,832 to reduce administrative expenses and employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management and the Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and were expensed when they were incurred. A loan becomes immediately due and payable upon a participant's termination of employment or death. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of October 31, 2023 and December 31, 2022.

**Contributions**

Contributions from Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Certain investment related expenses were paid using the Plan's assets and were either included in net appreciation of fair value of investments or were allocated among participants in the Plan. Certain expenses relating to specific transactions, such as loan set up, loan maintenance and express mail services, were paid directly by the participant and were included in administrative expenses.

NOTE 3 - INFORMATION CERTIFIED BY QUALIFIED INSTITUTION (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at October 31, 2023 and December 31, 2022, and net appreciation and net depreciation in fair value of investments, and interest and dividends for the period January 1, 2023 to October 31, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity").

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 - *Fair Value Measurement* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that were observable for the asset or liability; and
- Inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at October 31, 2023 and December 31, 2022.

*Money market and mutual funds:* Valued at the daily closing price as reported by the fund. The money market and mutual funds held by the Plan were open-end funds that were registered with the U.S. Securities and Exchange Commission ("SEC"). These funds were required to publish their daily net asset value ("NAV") and to transact at that price. The money market and mutual funds held by the Plan were deemed to be actively traded.

*Stable value collective investment fund:* Valued using the net asset value ("NAV"), provided by the administrator of the trust. The NAV is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### NOTE 5 - INVESTMENTS MEASURED USING THE NET ASSET VALUE PER SHARE PRACTICAL EXPEDIENT

There were certain participant redemption restrictions for the investment with respect to exchanges in investment options. Transferred investment funds must be held in a non-competing investment option for 90 days before subsequent transfer to a competing fund can occur.

There were no participant redemption restrictions over withdrawals for this investment; the redemption notice period is applicable only to the Plan.

#### NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan recordkeeping, transaction processing and loan maintenance services were provided by Fidelity Management Trust Company, subsidiaries and affiliates, therefore, fees associated with these services qualify as party-in-interest transactions. Investment advisory services were provided by MMA Securities and LPL Financial, LLC. Fees associated with these services qualify as party-in-interest transactions. The Plan may receive revenue sharing payments from mutual fund service providers, which offset fees paid by the Plan. Fees in excess of the revenue sharing amount were allocated to participant accounts and expensed.

#### NOTE 7 - PLAN TERMINATION

The Plan merged into Crete Mechanical Group, Inc. 401(k) Plan (see Note 1). Prior to the merger, although it did not express any intent to do so, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would have become 100% vested in their Company contributions.

#### NOTE 8 - TAX STATUS

The Plan had a prototype plan sponsored by FRM LLC. The Internal Revenue Service issued an opinion letter to FRM LLC dated June 30, 2020, that the prototype and related trust were designed in accordance with applicable sections of the IRC. Although the Plan has been amended since adopting the prototype plan, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and was currently being operated in compliance with the applicable requirements of the IRC.

NOTE 8 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
