Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Genesis Health System Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate to the best of their knowledge and belief.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

As described in Note 10 to the financial statements, the Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 10 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statements of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America (U.S. GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

Emphasis of Matter

As discussed in Note 2 to the financial statements, the Board of Directors of the Plan Sponsor, authorized the transfer of sponsorship of the Plan to Trinity Health effective October 1, 2024, as well as the freeze of participation and contributions in the Plan effective December 31, 2024 and also approved of the Plan to merge into the Trinity Health Corporation ERISA 403(b) Retirement Savings Plan effective as of July 1, 2025 or such other date as determined by Trinity Health in its sole discretion. Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to, and we do not express an opinion on the supplemental schedule referred to above.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Genesis Health System Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a contributory defined contribution 403(b) plan covering all employees of Genesis Health System (Employer or Plan Sponsor), except for those specifically excluded as listed in the Plan's adoption agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: An employee is immediately eligible to participate in the Plan for the purpose of elective deferral contributions. The employee shall become a participant effective the first day of the pay period coinciding with or immediately following the date of hire. The Plan's eligible participants receive employer match contributions under the terms of the Genesis Employer Contribution Plan.

Funding policy: Participants may contribute up to the maximum percentage of compensation or dollar amount permissible under Section 402(g) of Internal Revenue Code (Code), not to exceed certain limits of other Code Sections. All employees are automatically enrolled in the Plan when they become eligible with a deferral contribution rate equal to 4% of eligible compensation unless they make another election or specifically opt out. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). There are currently no employer contributions made to the Plan, but the Plan did receive employer contributions in 2013 and prior years.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of plan earnings and charged with an allocation of plan administrative expenses. Allocations of plan administrative expenses and earnings are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows each participant to choose their own investment mix. Participants can change their investment mix daily.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon.

Vesting of employer matching contributions for the period of January 1, 2012 to August 1, 2013, and earnings thereon, is 20% after two years of service and then 20% per year thereafter. Participants are 100% vested after six years of service. Prior to January 1, 2012, participants were immediately vested in all Plan contributions plus actual earnings thereon except for those participants who elected to continue receiving their employer match contributions under the formula used by a tax deferred annuity plan formerly sponsored by Illini Hospital (Illini Plan). For those who elected the Illini Plan match contribution formula, their employer contributions are vested on a five-year graded schedule.

Forfeitures and revenue sharing: Forfeitures of terminated participant accounts and amounts received from revenue sharing contracts are used to pay plan expenses or may be reallocated to participants. Forfeitures and revenue sharing of \$4,128 and \$5,365 were used to pay plan expenses for the years ended December 31, 2023 and 2022, respectively. No amounts were reallocated to participants for the years ended December 31, 2023 and 2022. Unallocated forfeitures and revenue sharing of \$91,907 and \$94,224 are included in net assets as of December 31, 2023 and 2022, respectively.

Notes receivable from participants: Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000. The loans are secured with the participant's vested account balance and bear interest at a rate commensurate with the prime daily rate plus 1%. Principal and interest are paid directly to the third-party administrator, Transamerica Retirement Solutions, LLC, over a maximum five-year period for personal loans and a 10-year period for primary home purchases. Total participant loans in default as of December 31, 2023 and 2022 were \$982,767 and \$1,019,875, respectively.

Note 1. Plan Description (Continued)

Payment of benefits: Effective November 1, 2009, participants receive a lump-sum amount equal to the value of his or her vested account. Prior to November 1, 2009, a participant could elect to receive a lump-sum amount equal to the value of his or her vested account, a single life, term certain, or joint and survivor annuity, or monthly installments over the life expectancy of the participant or beneficiary or any specific period of time upon termination of service.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, Part IV, Line 4i—Schedule of assets (held at end of year).

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses related to plan investments are paid from the assets of the Plan and are netted with investment income (loss) on the statements of changes in net assets available for benefits. The Plan also pays third-party administrator, investment consultant and annual audit fees. All other plan expenses are paid by Genesis Health System.

Note 2. Summary of Accounting Policies (Continued)

Subsequent events: The Plan Administrator has evaluated subsequent events through September 25, 2024, the date the financial statements were available to be issued.

In August 2024, the Board of Directors of the Plan Sponsor, authorized the transfer of sponsorship of the Plan to Trinity Health effective October 1, 2024, as well as the freeze of participation and contributions in the Plan effective December 31, 2024, and also approved of the Plan to merge into the Trinity Health Corporation ERISA 403(b) Retirement Savings Plan effective as of July 1, 2025, or such other date as determined by Trinity Health in its sole discretion.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 4. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Code. The Plan has been amended since adopting the preapproved plan document. However, the Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the Code and therefore, believes the Plan is qualified.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Benefit-Responsive Investment Contract

The Plan holds a traditional investment contract with Transamerica Life Insurance Company (TLIC). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.20%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

Note 5. Benefit-Responsive Investment Contract (Continued)

The Plan's ability to receive amounts due in accordance with a fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its contractual obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 403(b) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 7. Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued based on quoted prices in the active markets on which they are traded.

Personal choice retirement account: Self-directed brokerage accounts primarily consisting of mutual funds that are valued based on quoted prices in the active markets on which they are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8. Risks and Uncertainties

The investments of the Plan are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risks in the near term could materially affect investment balances and the amounts reported in the financial statements.

Note 9. Related-Party and Party-in-Interest Transactions

Plan investments in a fixed fund and certain mutual funds are managed by TLIC, a Plan custodian, and therefore transactions within these investments qualify as party-in-interest transactions.

Note 10. Plan Merger and Investments Excluded from the Financial Statements

The Plan was amended as of January 1, 2020, to merge the Genesis Health System Tax Sheltered Annuity Plan (Genesis TSA Plan) into the Plan effective January 1, 2020.

As a result of the merger of the Genesis TSA Plan, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to current and former employees, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statements of changes in net assets available for benefits. Under accounting principles generally accepted in the United States of America, these accounts and the related income and distributions should have been included in the accompanying financial statements. The amounts of total investments and related income and distributions are not determinable.

In addition, as a result of the above merger, the Plan has not maintained sufficient accounting records and supporting documents relating to the Genesis TSA Plan's annuity and custodial accounts issued to current and former employees. Accordingly, the Plan's net assets available for benefits as of December 31, 2023 and 2022, and changes in net assets available for benefits for the years then ended, may not be complete.
