## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Advanced ENT and Allergy, PLLC Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits in liquidation as of August 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2024 to August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Advanced ENT and Allergy, PLLC Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 7, 2024 and December 31, 2023 and for the period January 1, 2024 to March 7, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Advanced ENT and Allergy, PLLC Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter—Basis of Accounting**

As discussed in Note 6 to the financial statements, the governing body of Advanced ENT and Allergy, PLLC Profit Sharing Plan approved a plan of liquidation on September 18, 2023, and, accordingly, the Plan's financial statements are prepared on the liquidation basis of accounting. Generally accepted accounting principles require financial statements to be prepared on the liquidation basis of accounting when an entity is in liquidation or when liquidation is imminent. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. **NOTES TO FINANCIAL STATEMENTS**

Note 1. Plan Description

The following description of the Advanced ENT and Allergy, PLLC Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering substantially all full-time employees of Advanced ENT and Allergy, PLLC (the Employer) with one year of service who are age twenty-one (21) or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions

Each year, participants were able to elect to contribute up to the maximum legal limit, as determined by the Internal Revenue Service (IRS), of annual compensation as defined in the Plan. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or contribution plans. A participant's elective contribution shall be non-forfeitable at all times. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds as investment options to participants. In addition, participants have the option of utilizing a self-directed brokerage account, through which those participants are able to invest in a variety of securities including mutual funds, exchange traded funds, equities, alternative investments, or certain fixed income securities, in accordance with the Plan document.

The Employer made a safe-harbor matching contribution on behalf of each participant in an amount equal to the 100% of the first 3% of a participant's elective contribution plus 50% of a participant's elective contribution between 3% and 5%. This safe-harbor matching contribution is 100% vested. During the period from January 1, 2024 to August 31, 2024, there was no safe-harbor matching contribution.

In addition, the Employer had the discretion to make profit-sharing contributions to the Plan. The amount, if any, would be allocated as a percentage of compensation among various classifications of employees. During the period from January 1, 2024 to August 31, 2024, there was no profit-sharing contribution.

Contributions are subject to certain IRS limitations.

## NOTES TO FINANCIAL STATEMENTS

### Note 1. Plan Description (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution and Employer's safe-harbor matching contribution, and an allocation of (a) the Employer's profit-sharing contributions and (b) plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan and administrative expenses attributable to the use of specific participant transactions. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions and the Employer's safe-harbor matching contribution plus actual earnings thereon. Vesting in the Employer's discretionary profit-sharing contribution and actual earnings thereon is based on years of continuous service unless a participant has obtained normal retirement age, at which time the participant is 100% vested. A participant is 100% vested after six years of credited service as described in the following schedule:

6 years or more	100%

Upon termination, the amount of a participant's account not vested is forfeited. Upon termination of the Plan effective September 18, 2023, all participants became 100% vested in any amounts held under the Plan.

#### Notes Receivable from Participants

Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant was only able to initiate two loans in one calendar year and could only have two loans outstanding at any given time. Generally, loans were taken from all investment funds on a pro-rata basis, and loan repayments were credited to investment funds on the same basis as contributions. Loan terms ranged from 1-5 years or up to ten years for the purchase of a principal residence. The loans were secured by the balance in the participant's account and bore market interest rates. The rate remained fixed until the loan was paid in full. Principal and interest were paid ratably through payroll deductions.

## NOTES TO FINANCIAL STATEMENTS

### Note 1. Plan Description (Continued)

#### Payment of Benefits

Upon a participant's separation from service, the value of the participant's vested interest is payable by a lump-sum amount if the vested account is \$1,000 or less. If the vested amount is greater than \$1,000, but less than \$5,000, and the participant does not provide the Plan with an affirmative distribution election, the distribution must be rolled over to an individual retirement account set up in the name of the participant. Distributions of account balances exceeding \$5,000 are subject to participant consent and distribution elections. Distributions are payable in a lump sum. Participants who terminate service due to disability or death become 100% vested in their account balance. The Plan permits hardship withdrawals from participant contributions and actual earnings thereon. Participants who are at least 59 ½ may also withdraw their vested account balance.

#### Roth Transfer

Current employees may elect to have all or a portion of the pre-tax amounts in the participant's account to be converted to Roth tax treatment by electing a Roth Transfer. Participants may elect a Roth Transfer from any vested amounts in the Plan, provided that any such transfer must be a minimum of \$1,000. Participants may only elect one Roth Transfer per calendar year.

#### Forfeited Accounts

At August 31, 2024 and December 31, 2023, forfeited nonvested accounts totaled zero and \$17, respectively. These accounts were used to reduce employer contributions. Forfeitures could be reallocated to reduce Plan expenses or the Employer's contribution as decided by the Plan trustees.

### Note 2. Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting on the liquidation basis.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

## NOTES TO FINANCIAL STATEMENTS

### Note 2. Significant Accounting Policies (Continued)

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of August 31, 2024 and December 31, 2023.

#### Payment of Benefits

Benefit payments are recorded when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to year-end, and who had requested a distribution which was approved but not yet paid at year-end, if any. There were no unpaid distributions at August 31, 2024 and unpaid distributions of \$2,313,884 at December 31, 2023.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. The Employer does not intend to request a reimbursement from the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through September 3, 2024, the date the financial statements were available to be issued.

## NOTES TO FINANCIAL STATEMENTS

### Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements, including mutual fund investments and notes receivable from participants held at March 7, 2024 and December 31, 2023, and net appreciation in fair value of mutual fund investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 to March 7, 2024, was obtained from information supplied to the plan administrator and certified as complete and accurate by Ascensus Trust Company, the custodian of the Plan. All plan activity subsequent to March 7, 2024 was related to the self-directed brokerage accounts and does not impact the information covered by the certification. ### Note 4. Fair Value Measurements

U.S. GAAP provides a framework for fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The methodology for measuring fair value specifies a three-tier hierarchy of valuation techniques based upon whether the inputs to those valuation techniques are based on quoted prices of identical assets or liabilities (Level 1), significant other observable inputs (Level 2), or significant other unobservable inputs that reflect the Plan's own assumptions of market participant valuation (Level 3).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All financial assets and liabilities as of August 31, 2024 and December 31, 2023 are measured at fair value on a recurring basis (at least annually) into the most appropriate level within the fair value hierarchy based on the inputs used to determine the fair value at the measurement date. There have been no changes in the methodologies used at August 31, 2024 and December 31, 2023.

## NOTES TO FINANCIAL STATEMENTS

### Note 4. Fair Value Measurements (Continued)

Investments in mutual funds are recorded at unit value. Unit value is determined daily using publicly traded net asset value or share prices (Level 1). The self-directed brokerage accounts are measured at Level 1 since they have quoted market prices (or have similar market prices) in active markets. The self-directed brokerage accounts include cash, money market funds, equities, exchange traded funds, and mutual funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5. Related Party Transactions

Parties-in-interest are defined under Department of Labor regulations as a fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others.

Plan investments are managed by Ascensus, LLC and Hafele Investments, and are held by Ascensus Trust Company, who is the custodian of the Plan. Each of these service providers are a party-in-interest to the Plan. Fees paid by the Plan to the custodian were \$12,409 for the period from January 1, 2024 to August 31, 2024.

Jones, Nale & Mattingly PLC is the independent auditor of the Plan. Fees paid by the Employer for administrative, investment advisory, and audit services are excluded from these financial statements.

### Note 6. Plan Termination

On September 18, 2023, the Company's Board of Directors, subject to the provisions of ERISA, elected to amend and terminate the Plan effective September 18, 2023, due to the Employer's acquisition by SCP ENT & Allergy Services, LLC. Upon termination, no further contributions will be made to the Plan, and all participants became 100% vested in any amounts held under the Plan. All investments were distributed from the Plan during 2024.

### Note 7. Tax Status

The Plan is based on a preapproved plan which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator has not separately applied for a determination letter from the IRS. Although the plan has been amended since receiving the determination letter, the plan administrator and the Plan's legal counsel believe the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

## NOTES TO FINANCIAL STATEMENTS

### Note 7. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note 9. Reconciliation to Form 5500

The Employer has elected to not show the detail of the underlying investments of the self-directed brokerage accounts on Schedule H of Form 5500. Therefore, instead of showing the underlying investments of the self-directed brokerage accounts, which include cash, money market funds, equities, exchange traded funds, and mutual funds, on Schedule H, line 1C(1), line 1C(4)(B), and line 1C(13), the total amount of underlying investments of the self-directed brokerage accounts are included on line 1C(15). Likewise, the investment income net of expenses is shown on Schedule H, line 2C instead of line 2B(1)(A), line 2B(2)(C), line 2B(10), and 2I(4).
