Note 1 - Description of Plan:

The following description of the Phoenix Tube Co., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of Phoenix Tube Co., Inc. and Subsidiary (the Company) who have six months of service and are age twenty-one or older.

On July 2022, the Plan was restated to adopt the Principal Financial Group Non-Standardized Pre-Approved Profit Sharing Plan. The Internal Revenue Service determined by a letter dated June 30, 2020 that this Pre-approved Profit Sharing Plan is acceptable under the Internal Revenue Service Code (IRC) for use by employers.

Contributions - Each year, participants may contribute up to the permissible dollar limit by law for that plan year of pretax annual compensation, as defined in the Plan. Participants may elect to designate their contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans, provided that all legal requirements are satisfied. The Company may make discretionary matching contributions equal to a discretionary amount or percentage, to be determined by the Company, of the participants' contributions. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions (if any), and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their pre-tax contributions and rollover contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of service. Vesting in employer contributions and related earnings is determined as follows:

Investment Options - Upon enrollment in the Plan, a participant may direct employee contributions and company discretionary matching contributions in investment accounts of varying risk maintained by Principal Financial Group. The Plan has no non-participant directed investments.

Notes Receivable from Participants - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loan repayments must be within five years, other than principal residence loans. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid by deductions from the participant's pay each payroll period.

Note 1 - Description of Plan (continued):

Payment of Benefits - Upon death, disability, retirement or other termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or under installment payments. Advance distributions may be made for certain hardship situations as permitted by the Plan. Distributions during employment may also be made under certain situations as permitted by the Plan.

Forfeitures - A Plan amendment effective January 1, 2020 stated the plan can allocate forfeitures as additional matching contributions or use forfeitures as a reduction of plan expenses. Allocation conditions apply when allocating forfeitures and discretionary contributions in which the participant must be employed on the last day of the plan year and have 1,000 hours in the plan year.

Effective July 15, 2022, the restated plan stated forfeitures may first be used to pay administrative expenses. Remaining forfeitures, if any, may then be used to reduce Employer Contributions.

Forfeiture of terminated employees' nonvested accounts totaled \$1,135 and \$3,983 for the years ended December 31, 2023 and 2022, respectively. For year ended December 31, 2023, forfeitures of \$5,020 were used to reduce Employer Contributions.

Note 2 - Summary of Accounting Policies:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because the contract value is the amount the participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants - Participants' notes receivable are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the plan document. Outstanding notes receivables at December 31, 2023 carry an interest rate ranging from 4.25% to 9.50%.

Payment of Benefits - Benefits are recorded when paid.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Net appreciation/(depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well as investments held at the end of the year.

Operating Expenses - Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Administrative expenses of the plan are allocated to participant accounts.

Subsequent Events - Subsequent events were evaluated through September 23, 2024, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis at December 31, 2023 and 2022:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* A fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value ("NAV") of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Withdrawals from the Fund may be subject to certain restrictions and may be subject to a market value adjustment. The Plan administrator believes the occurrence of events that would limit the Plan's ability to transact at contract value with Plan participants for the above fund is not probable.

Transfers Between Levels

The availability of observable market data is monitored to access the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2023 and 2022, there were no transfers in or out of levels 1, 2, or 3.

Note 4 – Stable Return Funds:

Certain investment options offered by the Plan are stable return funds through SEI Trust Company (the “Stable Return Funds”). The contract holdings for the Plan were in Wells Fargo Stable Return Fund N and in Wells Fargo Stable Return Fund TR in 2021. As of April 1, 2022, Wells Fargo resigned as Trustee, and SEI Trust Company assumed trusteeship of the Trust which became Allspring Collective Investment Trust. The Funds changed the respective names to Galliard Stable Return Fund PN and Galliard Stable Return Fund PNTR, respectively.

The Stable Return Funds' investment contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Note 4 – Stable Return Funds (continued):

There are no reserves against contract value for credit risk of a contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a periodic basis for resetting. At December 31, 2023 and 2022, the average yields were approximately 2.64% and 1.90%, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

Note 5 - Guaranteed Investment Contract

The Principal Fixed Income Guaranteed Option is a fully benefit-responsive guaranteed general-account backed group annuity contract, issued by Principal Life Insurance Company (Principal Life) to Principal Trust Company as custodian. Principal Life guaranteed interest accounts are reported at contract value which is the aggregation of contributions, plus interest, less withdrawals and administrative expenses. A rate of interest contractually guaranteed by Principal Life is credited to participant account balances and the minimum guaranteed rate will range between 0.15% and 3%.

Certain events limit the Plan's ability to transact at contract value with Principal Life. Such events include the following: amendments to the Plan documents (including complete or partial plan termination or merger with another plan), termination of any record-keeping arrangement, service agreement or other agreement between Principal and the Plan, or termination of the investment contract. No redemption fees, early withdrawal charges, or market value adjustments are charged on a participant transfers of assets into or out of the contract. A surrender of the Plan's interest or initiated transfer in this contract is subject to either a 12-month advance notice or a 5% surrender charge. Notification of the Plan's intent to terminate its interest may be revoked within 90 days of Principal's receipt of such notice, after which time, the notice becomes irrevocable. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The balance in the Principal Fixed Income Guaranteed Option contract was \$115,287 as of December 31, 2023.

Note 6 - Investment Certification:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2023 and 2022, net appreciation/(depreciation) in fair value of investments, and interest and dividends for the years ended December 31, 2023 and 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company, the custodian/trustee of the plan.

Note 7 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 8 - Tax Status:

The Plan is a Volume Submitter Plan sponsored by Principal Financial Group. The Internal Revenue Service has determined by a letter dated June 30, 2020 that the Volume Submitter Plan is acceptable under the Internal Revenue Service Code (IRC) for use by employers. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

There are currently no income tax examinations in progress for any tax periods. The Plan's administrator believes that the Plan is no longer subject to income tax examinations for the years prior to 2020.

Note 9 - Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Party-in-Interest Transactions:

Principal Financial Group, the custodian of the Plan as of December 31, 2023 and for the year then ended, thus party-in-interest, holds the Plan's investments.

Note 11 - Prohibited Transactions:

During 2023, the Plan Sponsor excluded certain compensation as ineligible for employee deferral when this compensation should have been included, as defined by the plan document. Management is in the process of correcting this error.

During 2022, the Plan Sponsor failed to remit certain participant contributions into the Plan in a timely manner. Management has corrected this error during 2024.
