INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the

Opinion

We have audited the accompanying financial statements of Firemen and Oilers Local 3 SEIU and Subscribing Employers Group Legal Services Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits and benefit obligations as of December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits and benefit obligations for the year then ended (in liquidation), and the statement of net assets available for benefits and benefit obligations as of December 31, 2022 (ongoing) and the related statement of changes in net assets available for benefits and benefit obligations for the year then ended (ongoing), and the related notes to the financial statements.

In our opinion, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits and benefit obligations of Firemen and Oilers Local 3 SEIU and Subscribing Employers Group Legal Services Fund as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the changes in its net assets available for benefits and benefit obligations for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 5 to the financial statements, the governing body of the Plan approved a plan of liquidation in August 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2023 AND 2022

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements are prepared using the accrual basis of accounting.

Contributions Receivable - Employer contributions due but not paid at year end are recorded as contributions receivable. Allowance for credit losses is not considered necessary and is not provided.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Payments of Benefits - Benefit payments to the Legal Services Provider are recorded when paid. Amounts due to the Legal Services Provider that have yet to be recorded by the Plan are recorded as benefit obligations.

Benefit Obligations - The due to legal services provider is estimated by the Plan's management based on payments made after year end and applicable to the year then ended.

Revenue Recognition - The Plan is funded by contributions from participating employers under the terms of collective bargaining agreements (CBA). Employer contributions are accounted for as exchange transactions. The contributions are due on a monthly basis. It is the policy of the Trustees to pursue monies due.

NOTE 2. DESCRIPTION OF THE PLAN

The Plan is a multiemployer welfare plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The administrator of the Plan is its Board of Trustees. The Plan was established pursuant to various collective bargaining agreements between the Local 3 SEIU/NCFO and Subscribing Employers Group Legal Plan. Reference should be made to the summary plan description for specific details on benefits provided.

NOTE 2. DESCRIPTION OF THE PLAN (continued)

The Plan provides comprehensive legal services for participants in connection with personal legal problems covering eligible employees and dependents. An employee becomes eligible effective as of the first day of the month following a period of three consecutive months during which no less than two hundred fifty hours of contributions have been made on such employees' behalf to the Plan by participating employers. The above referenced requirement is applied uniformly and consistently among all employees covered under any Collective Bargaining Agreements pursuant to which contributions are being made to the Plan. An employee will cease to be eligible effective immediately upon a termination of employment, whether such termination is voluntary or involuntary.

The Plan also provides continued coverage to participants during periods of separation, at a stated monthly rate of contributions.

By definition, an employee is any regular employee of the employer who is covered by the Collective Bargaining Agreement. An employer is any employer who has a Collective Bargaining Agreement with the Union requiring contributions and who accepts in writing the provisions of the Plan (as it may be revised from time to time by the parties).

Benefits are funded through employer contributions. The hourly contribution rates in effect for the years ended December 31, 2023 and 2022 were as follows:

NOTE 3. TAX STATUS

The Plan obtained its latest determination letter in May 22, 1998, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 501(c)(9) of the Internal Revenue Code and was, therefore, exempt from Federal income taxes. The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, and local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 4. LEGAL SERVICES AGREEMENT WITH BENEFIT PROVIDER

The Trustees have entered into an agreement with a law firm to provide legal services to eligible Plan participants in accordance with the Plan document. The agreement calls for the legal firm to be paid the number of qualifying hours at the rate of 13 cents per hour.

Amounts paid to the provider are reported on the Statement of Changes in Net Assets Available for Benefits and Benefit Obligations. Any amounts owed to the provider are reported on the Statements of Net Assets Available for Benefits and Benefit Obligations.

NOTE 5. PLAN TERMINATION

On August 31, 2023, the Board of Trustees approved the termination of the Plan. Subsequent to August 31, 2023, no contributions or benefits were processed. The remaining assets of \$10,204 will be distributed to participants or for the participants behalf, as in accordance with the Plan document. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 6. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 25, 2024, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
