Notes to the Financial Statements

Note 1: Description of Plan

The following description of the *Schaefer Autobody Centers, Inc. 401(k) Profit Sharing Plan* (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan, which was adopted on January 1, 1995, by Schaefer Autobody Centers, Inc. (the "Plan Sponsor"), is a defined contribution plan covering all employees of the Plan Sponsor who have completed one year of service (at least 1,000 hours) and are age 18 or older. The Plan was restated on December 22, 2014, to no longer be a safe-harbor plan, effective January 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective December 29, 2023, the plan assets related to the Plan were transferred to Aon Pooled Employer Plan.

Contributions

Participants may contribute pre-tax deferrals and after-tax Roth deferrals of eligible compensation up to the Internal Revenue Service (IRS) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The total of participant and employer contributions for a given year cannot exceed the IRS limits. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employees can rollover any balance from a qualified retirement plan from another employer to this Plan. Such rollover contributions are kept in a separate rollover contribution account established on the employee's behalf. Participants direct the investment of their contributions into various investment options offered by the Plan. The employee will have a 100% vested interest in all amounts credited to the rollover contribution account.

The Plan Sponsor may make discretionary matching contributions which are determined by the participant's eligible compensation and deferrals. In 2023, participant contributions are matched at 100% up to 5% of compensation and subject to a vesting schedule. For the period ended December 29, 2023, the Plan Sponsor made matching contributions totaling \$865,682 after forfeitures.

The Plan Sponsor may also make discretionary profit-sharing contributions using a pro rata formula as determined by the Plan Sponsor. There was no profit sharing contribution for the period ended December 29, 2023.

Participant Accounts

Each participant account is credited with the participant's contribution, the Plan Sponsor's discretionary matching and profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in discretionary employer matching contributions is based on years of continuous service. Participants vest in their employer matching and profit-sharing contributions plus actual earnings thereon at a rate of 20% per year after two years of credited service and are fully vested after six years of credited service.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued interest. Notes receivable are made in any amount greater than \$1,000, but less than 50% of the participant's vested account balance. In no event can the participant borrow more than \$50,000. Participants can have only one loan outstanding at any point in time. Notes receivable transactions are treated as transfers from the investment funds to the participant loan accounts. Notes receivable must be paid over a period not extending beyond five years from the date of the loan. The notes receivable are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Interest rates range from 4.25% to 9.5% for loans outstanding during 2023. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The Plan provides for retirement benefits to be distributed in a lump sum payment. Normal retirement age for the Plan is 65. Upon death, disability, or attainment of normal retirement age of a participant while employed, the account balance becomes fully vested.

Upon termination of service, the Plan Sponsor reserves the right to distribute accounts with balances of less than \$5,000 in the form of a lump-sum distribution. Participants with account balances exceeding \$5,000 will have their funds maintained in the Plan until a written request is submitted to the Plan Sponsor for payment.

Participants previously began taking required minimum distributions at age 70½. The Setting Every Community Up for Retirement Enhancement Act (SECURE Act), passed on December 20, 2019, states that anyone reaching age 70½ in 2020 or later must take required minimum distributions by April 1 of the year after they reach age 72.

The Plan does not allow for hardship distributions.

Investment Options

Upon enrollment in the Plan, participants may direct contributions to any of the applicable investment options available to Plan participants.

Forfeitures

Participants who terminate their employment and are less than 100% vested in their employer account will forfeit their non-vested portion. The following description of the *Schaefer Autobody Centers, Inc. 401(k) Profit Sharing Plan* (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The employee will have a 100% vested interest in all amounts credited to the rollover contribution account.

The Plan Sponsor may make discretionary matching contributions which are determined by the participant's eligible compensation and deferrals. In 2023, participant contributions are matched at 100% up to 5% of compensation and subject to a vesting schedule. For the period ended December 29, 2023, the Plan Sponsor made matching contributions totaling \$865,682 after forfeitures.

The Plan Sponsor may also make discretionary profit-sharing contributions using a pro rata formula as determined by the Plan Sponsor. There was no profit sharing contribution for the period ended December 29, 2023.

Participant Accounts

Each participant account is credited with the participant's contribution, the Plan Sponsor's discretionary matching and profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued interest.
