Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alsana 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 28, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of the Alsana 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan’s provisions, which are available from the Plan Administrator. The plan was terminated on December 28, 2023.

General

The Plan was a defined contribution plan sponsored by Castlewood Treatment Center, LLC d/b/a Alsana (the “Center”) for the benefit of its nonunion employees who were age 21 that had completed one month of service. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Voya Retirement Insurance and Annuity Company served as the custodian of the Plan. The Plan was amended effective January 1, 2022 to rename the Plan to the Alsana 401(k) Profit Sharing Plan. The Plan was previously named Castlewood Treatment Center, LLC 401(k) Profit Sharing Plan.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Center make annual contributions, subject to maximum allowable limits. Employee Roth and rollover contributions were also permitted. Employer matching and profit-sharing plan contributions were discretionary as determined by the Center’s Board of Directors. There were no employer matching or profit-sharing contributions during the periods ended December 28, 2023 or December 31, 2022. Contributions were subject to certain limitations.

The Plan Document also included an automatic deferral feature whereby a participant was treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. Participants were automatically enrolled at a default salary deferral of 3% of compensation.

Participant Investment Account Options

Investment account options available included various funds. Each participant had the option of directing their contributions into any of the separate investment accounts and could change the allocation daily.

Participant Accounts

Each participant’s account was credited with the participant’s contribution, the Center’s contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefits to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Vesting

Participants were immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Center’s contribution portion of their accounts plus earnings thereon was based on years of continuous service. Participants were fully vested after three years of continuous service. The nonvested balance was forfeited upon termination of service. Forfeitures could be used to reduce Center contributions or pay Plan expenses.

Payment of Benefits

Upon termination of service, a participant could elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Annuity distributions were available to participants to the extent that such distribution had been elected by the participant through investments in guaranteed income for life or similar investment products. At December 28, 2023 and December 31, 2022, there were no participants that elected to withdraw from the Plan but had not yet been paid.

Notes Receivable from Participants

The Plan Document included provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan was \$1,000. Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. All loans were covered by demand notes and were repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans was based on local prevailing rates as determined by the Plan Administrator.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants before March 15, 2023. There were no excess contributions payable at December 28, 2023.

Plan Termination

The Center had the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

On November 13, 2023, the Board of Directors of the Center approved termination of the Plan. Eligible employees were transitioned and allowed to participate in the SaveWise Pooled Employer Plan. A transfer out of \$3,884,208 was made to the SaveWise Pooled Employer Plan during 2023. The Plan was fully liquidated on December 28, 2023. At Plan termination, participants became 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments were reported at fair value except for the fully benefit-responsive investment contract, which was reported at contract value.

Pooled separate accounts were valued at estimated fair value as provided by the custodian.

Purchases and sales of securities were recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

Plan Tax Status

The Plan operated under a non-standardized adoption agreement in connection with a prototype Defined Contribution Plan sponsored by Goldleaf Partners. Goldleaf Partners was acquired in late 2019 and is now FuturePlan by Ascensus. This prototype plan document has been filed with the appropriate agency and has obtained a determination letter dated March 31, 2014, in which the Internal Revenue Service stated that the prototype and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. Although the Plan had been amended since adopting the prototype, the Plan Administrator believes the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses were paid by the Center or the Plan, at the Center's discretion.

Note 3. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying Statements of Net Assets Available for Benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the periods ended December 28, 2023 and December 31, 2022. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values were estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to yield curves, interest rates and cash flows. Such investments are classified in Level 2 of the valuation hierarchy and include pooled separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan had no Level 1 or 3 investments.

Note 4. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, a qualified institution, has certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 28, 2023 and December 31, 2022.
- Investment income (loss) and interest income on notes receivable from participants as shown in the Statements of Changes in Net Assets Available for Benefits for the periods ended December 28, 2023 and December 31, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees were covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons.

The Plan incurred expenses related to general administration and record keeping. The Center provided certain administrative services at no cost to the Plan. The Plan invested in certain funds of the Plan custodian.

The Plan held certain investments managed by Voya Retirement Insurance and Annuity Company, the custodian.

Note 6. Investment Contract with Insurance Company

In 2018, the Plan entered into a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract was fully benefit responsive; therefore, contract value was the relevant measurement. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, limited the Plan's ability to transact at contract value with participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 7. Subsequent Events

Subsequent events have been evaluated through September 27, 2024, which is the date the financial statements were available to be issued.
