1. Plan Description

The following description of Pharmaceutic Litho and Label Company Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan, originally effective April 1, 1995, and restated January 1, 2022, is a defined contribution plan covering all employees of Pharmaceutic Litho and Label Company Inc. and related participating employers (the Company) who have completed 3 months of service and attained the age of 18, excluding certain classes of employees as set forth in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Plan Termination and Liquidation

Effective June 13, 2023, a resolution was adopted by the governing board to terminate the Plan. Contributions to the Plan were suspended and the assets of the Plan began to be distributed to participants. Pursuant to the Plan's termination, all participants became 100 percent vested in their accounts. All of the Plan's net assets were liquidated as of December 18, 2023.

c. Contributions

Participants may contribute up to 90 percent of annual compensation in pre-tax or Roth deferrals, as defined in the plan document and allowed by law. Participants may also roll over amounts representing distributions from other qualified plans. The Plan permits catch-up contributions for participants who have attained age 50 by the end of the plan year. The Plan provides for automatic election of participant contributions at a rate of 4 percent of compensation with an increase of 1 percent each year up to a maximum of 10 percent. Participants may affirmatively elect a different deferral percentage or elect not to defer into the Plan. The Company provides for matching contributions equal to 25 percent of participant deferrals up to 4 percent of compensation, as defined in the plan document. During 2023, the Company contributed \$35,009 to the Plan.

Pursuant to plan termination and liquidation, contributions to the Plan were suspended after June 13, 2023.

d. Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, if applicable, and the Plan's earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

e. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company contribution portion of their accounts plus actual earnings thereon is based on years of credited service as follows:

| 2 years | 67% |
| 3 years | 100% |

Pursuant to the Plan's termination, all participants became 100 percent vested in their accounts.

f. Distribution of Benefits

Upon termination of employment due to termination of service, death, disability, or retirement, participants may elect to receive the value of their vested account balance in a lump-sum distribution, installments, or partial withdrawals. In-service withdrawal options are available to participants under certain circumstances.

g. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 (reduced by the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan) or 50 percent of their vested account balance. Loan terms range up to five years but may be extended if the proceeds are to be used for the purchase of a primary residence. The loans are secured by the balance in the participant's account. There were no loans outstanding at December 18, 2023.

h. Forfeited Accounts

At December 31, 2022, forfeited non-vested accounts totaled \$10,039. Forfeitures are be used to pay plan expenses or reduce future company contributions. During 2023, forfeited non-vested accounts were used to pay for \$14,765 of the Plan's administrative expenses.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

As discussed in Note 1b, effective June 13, 2023, the Company formally resolved to terminate the Plan and determined that liquidation was imminent, as such concepts are defined in the applicable accounting standards, as of that date. As a result, the Plan changed its basis of accounting from an ongoing basis to the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America.

a. Basis of Accounting (Continued)

The Statement of Net Assets Available for Benefits (Ongoing) as of December 31, 2022, was prepared under the accrual basis as an ongoing basis of accounting. The Statement of Net Assets in Liquidation as of December 18, 2023, was prepared under the liquidation basis of accounting. Although the date that liquidation was deemed imminent was June 13, 2023, the Plan followed nonauthoritative guidance issued by the AICPA Financial Reporting Center under Technical Questions and Answers (TIS) Section 6931, *Financial Statement Reporting and Disclosure—Employee Benefit Plans*. In accordance with the guidance provided under TIS sections 6931.18-.30, the change in net assets for the period from January 1 to December 18, 2023, is reflected on a liquidation basis for the entire period.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Except as described below, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are generally recorded on a trade-date basis. As permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962-325, *Plan Accounting—Defined Contribution Plans: Investments—Other*, settlement-date basis may be used when (a) the settlement date is after the financial statement date, (b) the fair value of the securities purchased or sold did not change significantly from the trade date to the financial statement date, and (c) the purchases or sales do not significantly affect the composition of the plan's net assets.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value, also referred to as book value, is equal to total contributions allocated to the investment, less withdrawals and expenses, plus accrued interest.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. These are referred to as participant loans in Form 5500. Delinquent loans are treated as distributions based upon the terms of the plan document.

e. Payment of Benefits

Benefits are recorded when paid.

f. Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses include fees for certain participant-initiated transactions that are charged directly to the account of the participant who incurred them. Investment-related expenses are included in net realized and unrealized appreciation in fair value of investments.

g. Subsequent Events

The Plan has evaluated the subsequent events through September 23, 2024, the date the financial statements were available to be issued.

3. Party-in-Interest Transactions

Reliance Trust Company and Transamerica Financial Life Insurance Company are the Trustee and Insurer of the Plan, respectively, and hold and manage investments. Transactions with the Trustee and Insurer are exempt party-in-interest transactions, as defined by ERISA.

4. Fair Value Measurement

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 18, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Exempt Status

The Company has adopted a pre-approved plan document subject to a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 18, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Certified Investment Information

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company and Transamerica Financial Life Insurance Company, the Trustee and Insurer of the Plan, respectively, have certified that the following investment information is complete and accurate:

- Fair value and contract value of investments and the carrying amount of notes receivable from participants as reflected in the Statement of Net Assets in Liquidation and Statement of Net Assets Available for Benefits (Ongoing) as of December 18, 2023 and December 31, 2022, respectively.
- Investment income and interest income on notes receivable from participants as reflected in the Statement of Changes in Net Assets in Liquidation for the Period From January 1 to December 18, 2023.
- Investment information as reflected in Note 4 to these financial statements.

As permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to the certified investment information.

7. Fully Benefit-Responsive Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive investment contract with Transamerica Financial Life Insurance Company. Transamerica Life Insurance Company maintains the contributions in a general account. The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets attributable to the investment contract. Contract value, as reported to the Plan by Transamerica Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Subject to contract termination clauses, the contract was settled at an amount materially similar to the contract value of the investment.
