## Note 1 - Plan Description

The following description of Dürr, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering substantially all full-time employees of Dürr Systems, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

All employees, with the exception of members of the Depere Union for whom eligibility requirements are outlined below, become eligible to participate in the Plan when hired and upon attaining age 19. New employees are automatically enrolled as soon as administratively feasible. If no deferral election is made by the participant, the deferral defaults to 3 percent of eligible compensation and is increased 1 percent in each subsequent year until the deferral reaches 6 percent. Participants may elect to opt out of the automatic employee deferral.

Prior to April 2023, certain employees who are also members of the Depere Union became eligible to participate in the Plan after attaining three months of service and 21 years of age. In April 2023, the eligibility age requirement for members of the Depere Union was changed to 18 years of age. If no deferral election is made by the participant, the deferral defaults to 5 percent of eligible compensation.

### **Administration**

The Company is the sponsor of the Plan. The compensation and benefits committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Fidelity Management Trust Company (the "Trustee") functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

### **Contributions**

Participants may defer up to 60 percent of eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan also allows participants to make Roth 401(k) after-tax contributions to the Plan. The Plan will not accept rollovers of after-tax contributions.

Nondiscretionary matching contributions are 100 percent of employee contributions, up to 5 percent of eligible compensation.

Prior to April 2023, certain employees who are also members of the Depere Union received an employer contribution calculated as \$1.80 per hour worked if hired before March 1, 2010. Members of the Depere Union hired after March 1, 2010 received 50 percent of employee contributions, up to 6 percent of eligible compensation. In April 2023, the employer contribution for members of the Depere Union was changed to \$2.00 per hour worked for members hired before March 1, 2010, and 100 percent of employee contributions, up to 5 percent of eligible compensation, for members hired after March 1, 2010.

The Company may make discretionary profit-sharing contributions to be determined annually by the Company. There were no discretionary profit-sharing contributions in 2023.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan and may change their elections or transfer between investment options at any time.

## Note 1 - Plan Description (Continued)

### *Vesting*

Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Participants are also immediately vested in nondiscretionary company matching contributions and discretionary profit-sharing contributions plus actual earnings thereon.

Certain participants who are also members of the Depere Union are immediately vested in their contributions plus actual earnings thereon. Participants vest at 20 percent per year and become fully vested in their employer match portion of their accounts after five years of credited service.

### *Participant Notes Receivable*

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Participant notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

### *Benefit Payments*

Upon termination of service due to death, disability, or retirement, participants may elect to receive a lump-sum distribution. Upon termination of service for other reasons, a participant may receive a lump-sum amount equal to the vested value of his or her account.

The Plan allows participants to elect distributions under an installment plan.

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

### *Termination*

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, Fidelity Management Trust Company, as the Trustee, shall distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination.

### *Party-in-interest Transactions*

Certain plan assets are in investment funds managed by the Trustee; therefore, these transactions qualify as nonprohibited party-in-interest transactions, as defined under ERISA guidelines.

## Note 2 - Summary of Significant Accounting Policies

### *Investment Valuation and Income Recognition*

The Plan measures investments at fair value on a recurring basis. The fair value of the investments in mutual funds and publicly traded investments held in the self-directed brokerage accounts is based primarily on Level 1 inputs, as described in Note 5. The money market fund held in the self-directed brokerage accounts approximates fair value based on its outstanding balance and is based primarily on Level 2 inputs, as described in Note 5. Life insurance policies are stated at cash surrender value, as provided in the policies, which approximates fair value, and are based primarily on Level 2 inputs, as described in Note 5. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

### *Participant Notes Receivable*

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

## Note 2 - Summary of Significant Accounting Policies (Continued)

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Risks and Uncertainties***

The Plan invests in investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 1, 2024, which is the date the financial statements were available to be issued.

## Note 3 - Certified Information

Fidelity Management Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information provided by the Trustee.

## Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

## Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 5 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
