Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Northwest Community Healthcare Employees' Retirement Plan (the Plan) provides only general information. The description of Plan referenced below reflects the provisions of the Plan during 2023, prior to the merger with and into the NS-EEH 401(k) Plan (see "Plan Merger" in Note 2). Subsequent to the merger, the NS-EEH 401(k) Plan was renamed the Endeavor Health 401(k) Plan. Interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering eligible employees of Northwest Community Healthcare (the Hospital) and related adopting employers. All employees, except bargaining unit employees (unless the collective bargaining agreement requires the employees to be included under the Plan) and leased employees, are eligible to participate immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Endeavor Health (formerly known as NS-EE Holdings) is the parent company of the Hospital.

Contributions

For the 2023 Plan year, the Plan is funded by voluntary contributions of participants and matching contributions of the Hospital. Participants may contribute to the Plan, through regular payroll deductions, an amount subject to limitations imposed by the Internal Revenue Code (the Code). Participants may also roll over amounts representing distributions from other qualified employee benefit retirement plans and individual retirement accounts. The Hospital made and/or accrued matching contributions of \$9,582 to the Plan for the year ended December 31, 2023.

For the 2023 Plan year, subject to certain eligibility requirements, an employee becomes automatically enrolled in the Plan at a 1% pre-tax contribution rate beginning on the first day of the month following 30 days of service, unless the employee elects otherwise. For the 2023 Plan year, participants who contribute to the Plan and meet certain requirements, as defined in the Plan document, are eligible to receive matching contributions each payroll period equal to 100% of the first 3% of the participant's eligible compensation contributed to the Plan, and then 50% of the next 3% of the participant's eligible compensation contributed to the Plan, as defined in the Plan document.

Investment Options

Participants must direct their salary deferral contributions and the Hospital's contributions into permissible investments within individually directed brokerage accounts and/or a variety of investment options made available and determined by the Endeavor Health Retirement Plan Committee (Committee). Participants may change their investment options at any time.

Participant Accounts

For the 2023 plan year, each participant's account is credited with the participant's contributions, the Hospital matching contributions, and an allocation of any Plan earnings (or losses). Plan earnings (or losses) are allocated to participants' accounts in direct proportion to their respective account balances based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately fully vested in participant and rollover contributions. The Hospital matching contribution is subject to a three-year cliff vesting schedule. In the event of death or attainment of age 65 while actively employed by the Hospital or a related entity during the 2023 plan year, participants become fully vested.

Payment of Benefits

On termination of service, for the 2023 Plan year, a participant may elect to receive a single, lump-sum payment equal to the value of his or her vested account balance, installments over a specified period of time, or a direct rollover distribution. Hardship withdrawals and in-service withdrawals (for those participants aged 59.5 or older) are also permitted by the Plan.

If a participant is on active military duty for more than 30 days, as defined in the Heroes Earnings Assistance and Relief Tax Act of 2008, the participant may withdraw all or a portion of their account attributable to employee elective deferrals, provided; however, the participant may not make any employee elective deferrals or other employee contributions for six months following such a withdrawal.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants are permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balances. The loans are collateralized by the borrowers' respective vested account balances and bear interest at rates ranging from 4.25% to 7.25%. Principal and interest are paid over a period not to exceed five years, unless for the purchase of a primary residence.

Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Hospital and are excluded from these financial statements. NCH 401(k) Plan participants incur a per-participant administrative fee each quarter. Investment-related expenses are included in net appreciation of fair value of investments. Other miscellaneous administrative expenses are paid by the Plan.

Forfeitures

At December 31, 2023 and 2022, unallocated Plan assets resulting from forfeited nonvested accounts totaled \$0 and \$114, respectively. These accounts are used to reduce future Hospital contributions and to pay any Plan administrative expenses. Forfeitures of approximately \$199 were used during the year ended December 31, 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisers.

Investment Valuation and Income Recognition *(continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Cash and Cash Equivalents

The Plan considers all highly liquid investments purchased with an original maturity of three months or less to be cash equivalents.

Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of net assets, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Accounting for Uncertainty in Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Plan Merger

Effective 11:59:59 p.m. Central Time on December 31, 2023 (the Merger Date), the Plan was merged with and into the NS-EEH 401(k) Plan, with the NS-EEH 401(k) Plan being the surviving plan following the merger. The Plan's assets were transferred to the NS-EEH 401(k) Plan's Trust as soon as administratively practicable on or after the Merger Date. Also, effective on the Merger Date, eligible participants, beneficiaries and alternate payees covered by the Plan became participants in the NS-EEH 401(k) Plan. Effective January 1, 2024, the NS-EEH 401(k) Plan was renamed the Endeavor Health 401(k) Plan.

NOTE 3 FAIR VALUE MEASUREMENTS

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Separately managed accounts: Accounts managed by an investment advisor specifically for the Plan. These accounts consist of mutual funds and common/collective trust funds and are valued using the methods indicated below.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds that are valued on the basis of readily determinable market prices.

Common/collective trust funds: Valued based on the NAV of units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities.

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Stable value collective trust fund: A stable value fund that is fully benefit-responsive and is composed primarily of government agency securities, corporate debt instruments, and other fixed-income securities that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan did not have any financial assets as of December 31, 2023.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 5 INCOME TAX STATUS

Effective January 1, 2016, the Plan adopted a standardized form of a prototype plan sponsored by Fidelity Management & Research Company. The volume submitter plan has received an opinion letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The submitter plan opinion letter has been relied upon by this Plan. The Plan Administrator believed that the Plan was designed and being operated in compliance with the applicable provisions of the Code as of December 31, 2023 (Merger Date).

NOTE 6 PLAN TERMINATION

Although it has not expressed any such intent, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their respective account balances.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to several risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issues loans to participants, which are secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Hospital. These transactions qualify as party-in-interest. Employees of the Hospital provide administrative services to the Plan for which no fees are charged.

NOTE 9 SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through September 27, 2024, the date that these financial statements were available to be issued.
