We have performed an audit of the accompanying financial statements of Green Mechanical Construction, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of June 26, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2023 to June 26, 2023, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Other Matters**

### *Basis of Accounting*

As discussed in Note 1 to the financial statements, the Plan merged into AGC of Kentucky Construction Industry 401(k) Plan effective June 26, 2023. Our opinion is not modified with respect to this matter.

### *Auditors' Report on the 2022 Financial Statements*

The financial statements of the Plan as of December 31, 2022, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated September 27, 2023 indicated that in their opinion (a) the amounts and disclosures in the 2022 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the of Green Mechanical Construction, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan covering all eligible employees of Green Mechanical Construction, Inc. (the "Employer") and HVAC Services, Inc., a related company. A participant is eligible to participate in the plan upon attainment of age eighteen, coinciding with or immediately following completion of sixty days of continuous service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors of the Plan Sponsor is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

*Merger* – During 2023, the Board of Directors of the Employer, approved the merger of this Plan into the AGC of Kentucky Construction Industry 401(k) Plan, and effective June 26, 2023, all Plan assets were transferred from the Plan into the AGC of Kentucky Construction Industry 401(k) Plan.

*Contributions* - Each year, participants may contribute up to 100% of their eligible pre-tax annual compensation, after-tax Roth deferrals, or a combination of both as defined in the Plan, subject to Internal Revenue Service limitations. Participants may also make rollover contributions from amounts representing distributions from other qualified plans. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer contributes up to 50% of the first 3% of a participant's contribution. The Employer contribution amount is a discretionary amount determined by the Employer on an annual basis. The Employer may also make a profit-sharing contribution to the Plan on behalf of each Participant at the option of the Employer's board of directors. During the period ended June 26, 2023, there were no profit-sharing contributions made to the Plan. Participants direct the investment of both their and the Employer's contributions into various investment options offered by the Plan. The Plan offers mutual funds and a collective trust fund as investment options for participants. Contributions are subject to certain statutory limitations.

*Participant Accounts* - Each participant's account is credited with the participant's contributions and allocations of the (a) Employer's contribution and, (b) plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their account plus actual earnings thereon is based on years of service. A participant becomes 20% vested after two years of service, increasing by 20% per additional year, with full vesting after six years of credited service.

*Notes Receivable from Participants* - Participants may borrow from their account a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment terms of the notes cannot exceed five years except for the purchase of the participant's principal residence, in which case a reasonable repayment period is determined at the time of the loan. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through regular payroll deductions.

NOTE 1 - DESCRIPTION OF PLAN - continued

*Payment of Benefits* - Upon the occurrence of a distributable event due to separation from service by termination, death, disability, or retirement, as defined by the Plan Agreement, a participant may elect to receive a lump sum cash distribution equal to the value of the participant's vested interest in his or her account or installments over a certain period. In-service withdrawals, as defined in the Plan Agreement, are also permitted from a participant's account. The Plan allows participants who have attained age 59 1/2 to withdraw any part of their vested accounts, including elective deferral, matching, and qualified nonelective and discretionary contributions.

*Administrative Expenses* - Certain administrative expenses of maintaining the Plan are paid by the Employer and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in the fair value of investments. Fees for the administration of notes receivable from participants are included in agency fees and are charged directly to the participant's account.

*Forfeited Accounts* - At June 26, 2023, forfeited nonvested accounts available to reduce future employer contributions and pay plan expenses totaled \$0. During the period ended June 26, 2023, of forfeitures were utilized to reduce Plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Trustee. All Plan assets were transferred to AGC of Kentucky Construction Industry 401(k) Plan before close of business on June 26, 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of June 26, 2023. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions - Participants' contributions are recorded by the Plan as of the date such participants' elected contributions are withheld by the Employer. Sponsor contributions are recorded by the Plan when committed by the Employer.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Employer and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are included in administration expenses and charged directly to the participant's account.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY TRUSTEE

Substantially all information pertaining to the Plan's investments included in the financial statements, including the associated investment income (loss), was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan. This information has not been audited by independent accountants.

NOTE 4 - FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: The fair value of the collective trust value fund is valued at the NAV of units held. Units of each share of the fund are valued each day on when the New York Stock Exchange is open for trading. The NAV per unit is computed by dividing the total assets of the fund, less its liabilities, by the number of units outstanding at the time of such computation. Investment income (loss) earned is reinvested in the fund and included in the determination of unit values.

All assets totaling were transferred out of the Plan and merged into AGC of Kentucky Construction Industry 401(k) Plan on June 26, 2023.

NOTE 5 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are managed by Reliance Trust Company and certain administrative expenses, indirect fees, and costs of the Plan are paid to Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 - INCOME TAX STATUS OF THE PLAN

The Plan has elected to adopt the EPIC Advisors, Inc. Volume Submitter Profit Sharing Plan with CODA. This prototype plan has a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated the prototype plan is acceptable for use by employers under Section 401 of the Internal Revenue Code ("IRC"). The Plan itself has not requested a determination letter. The Plan has been amended since the prototype plan received the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan has analyzed its tax positions taken and has concluded that there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

NOTE 7 - PLAN TERMINATION

During 2023, the governing body of the Plan approved a plan to merge the Plan with AGC of Kentucky Construction Industry 401(k) Plan. The merger required the assets of active participants to be transferred to AGC of Kentucky Construction Industry 401(k) Plan and assets of inactive employees to be distributed thereafter. Final distributions were determined based on all participants 100% vested and were made as soon as possible after the termination date. As of June 26, 2023, all remaining assets of the Plan totaling \$4,773,392 were transferred to AGC of Kentucky Construction Industry 401(k) Plan and the Plan was terminated.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various participant-directed investment options, which are exposed to various risks, such as interest rate, credit risks and market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.
