## INDEPENDENT AUDITORS' REPORT

TO THE INVESTMENT COMMITTEE

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Ted Baker Limited 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Termination**

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 9 to the financial statements, the Plan sponsor has elected to terminate the Plan effective September 30, 2024, which indicates that the Plan is not a going concern. The financial statements do not include any adjustment that might be necessary upon termination. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental Schedule H – Line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Ted Baker Limited 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

As discussed in Note 9, on April 24, 2024, the Plan Sponsor filed for bankruptcy protection with the Southern District of New York under Chapter 15 of the Bankruptcy Code. As a result, on September 18, 2024, the Plan Sponsor instructed Fidelity Management Trust Company (“Fidelity”), the trustee of the Plan to terminate the Plan effective September 30, 2024. Participants will continue to be 100% vested in their account balances.

General – The Plan was established to provide retirement benefits for the employees of Ted Baker Limited. The Plan is sponsored by Ted Baker Limited (the “Sponsor” or the “Company”). Employees who have completed six months of service and are at least 21 years of age may participate. Employees who are members of a collective bargaining agreement, and non-resident aliens who do not receive any compensation from sources within the United States are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and subsequent amendments and certain provisions of the Internal Revenue Code (“IRC”). The Plan is a defined contribution 401(k) plan, under which participants may elect to have the employer defer a portion of their compensation to the Plan.

The Plan provides for a plan administrator who is responsible for keeping accurate and complete records of the Plan’s operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and to government regulations, and providing participants with any reports and documents required by law. The Company has appointed an Investment Committee which is responsible for the oversight and administration of the Plan as well as determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Participant Contributions – Each Plan year, participants may contribute up to 100% of their annual compensation, as defined by the Plan, subject to annual dollar limits as imposed under the IRC (\$22,500 in 2023). Participants may voluntarily make pre-tax and/or after tax (“Roth”) contributions to the Plan. Additionally, participants who are age 50 or older during the Plan year are allowed to make additional catch-up contributions subject to annual limits (\$7,500 in 2023). Participants may also make rollover contributions from other qualified defined benefit or defined contribution plans.

Employer Contributions – The Company makes “Safe Harbor” matching contributions equal to 100% of employee contributions up to 5% of each participant’s eligible pre-tax compensation on a per plan year basis. The Company made total matching contributions of \$384,881 for the year ended December 31, 2023.

On July 29, 2022, the Plan was amended such that the Company’s Safe Harbor matching contributions will be computed on a per plan year basis rather than on a per payroll period basis. The effective date of this amendment is January 1, 2023.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions (Continued) – The Company may also make discretionary profit sharing contributions. These contributions, if any, are allocated to eligible participants based on total pre-tax compensation, regardless of the employee's contributions. Participants must be employed on the last day of the plan year and have completed 1,000 hours of service within the plan year to be eligible to receive an allocation of the profit sharing contribution. The Company made no discretionary profit sharing contributions for year ended December 31, 2023.

Participant Accounts – The Plan maintains an account for each participant which is credited or charged with the participant's contributions and Company matching contributions, as well as allocations of any discretionary profit sharing contributions, plan earnings or losses, and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are always 100% vested in all their plan accounts.

Notes Receivable from Participants – Participants may borrow from their vested account balances provided they meet the Plan's eligibility requirements. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000. The term of the loan is not to exceed five years, except for loans used to finance the purchase of a primary residence for which longer terms are permitted. Interest rates are based on the prevailing interest rate charged by persons in the business of lending money for loans which would be made under similar circumstances and remain fixed throughout the life of the loan. Principal and interest are paid ratably through payroll deductions and are generally due within 60 days following the date of termination of employment. Amounts not repaid are treated as taxable distributions.

Payment of Benefits – Upon termination of service, death, disability or retirement, a participant may elect to receive a distribution in a lump-sum payment, other amount of distribution or a rollover distribution. A participant may also elect to receive a pre-retirement distribution if the participant is 100% vested in the amount being distributed and has reached 59½ years of age. Benefit payments to the participant generally must begin no later than April 1<sup>st</sup> following the later of the end of the year after the participant attains age 73 or the year in which the participant terminates employment. A participant may also be eligible for withdrawal due to hardship in certain circumstances. Terminated participants with account balances of \$5,000 or greater may delay receipt of distribution. If the vested balance of a terminated participant's account is \$5,000 or less, the balance will be directly rolled over into an individual retirement account ("IRA"), as designated by the plan administrator, if no distribution instructions are received.

Investment Options – Upon enrollment in the Plan, participants may direct contributions in percentage increments into a series of mutual funds offered by the Plan. Each fund option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Forfeited Accounts – As participants are always 100% vested, there are no forfeited accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan’s financial statements are prepared using the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants, matching contributions, and profit sharing contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants – Notes receivable from participants represent participant loans that are measured at their unpaid principal balance plus any accrued but unpaid interest. A participant may have two loans outstanding at any time. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Most of the expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to certain participant transactions such as the administration of notes receivable and distributions are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Concentrations – As of December 31, 2023 and 2022, four investments accounted for approximately 56% and 62% of total investments, respectively. Additionally, the target date family of funds offered by the Plan, in the aggregate, accounted for approximately 69% and 73% of total investments as of December 31, 2023 and 2022, respectively.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

This valuation method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants presented on the statements of net assets available for benefits as of December 31, 2023 and 2022, and the supplemental Schedule H, Line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2023, and the related investment income and interest income on notes receivable from participants presented in the statement of changes in net assets available for benefits for the year ended December 31, 2023.

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Plan has adopted a pre-approved defined contribution plan of Fidelity Management Trust Company, which received a favorable determination letter from the Internal Revenue Service (“IRS”) on June 30, 2020 regarding the qualified status of this pre-approved plan. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

NOTE 5 – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – PLAN TERMINATION

As discussed in Note 9, on September 18, 2024, the Plan Sponsor instructed Fidelity to terminate the Plan effective September 30, 2024. Participants will continue to be 100% vested in their account balances.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are managed by affiliates of Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

An affiliate of Fidelity provides certain administrative services to the Plan pursuant to a service agreement between the Plan and Fidelity. Fidelity and affiliates receive revenue from most of the mutual fund service providers for services Fidelity and affiliates provide to the funds. This revenue is used to offset certain amounts owed to Fidelity and affiliates for its administrative services to the Plan and to pay the investment advisor. Because these fees are paid through this revenue sharing arrangement, rather than a direct payment, they are netted against (included in) the net appreciation (depreciation) in fair value of investments.

NOTE 9 – SUBSEQUENT EVENTS

In accordance with SECURE 2.0 Act, effective January 1, 2024, if a terminated participant's account balance is between \$1,000 and \$7,000, and no instructions have been received from such participant, the amount will be rolled over to an individual retirement account as designated by the plan administrator. As disclosed in Note 1, the previous upper limit was \$5,000.

On April 24, 2024, the Plan Sponsor filed for bankruptcy protection with the Southern District of New York under Chapter 15 of the Bankruptcy Code. On September 18, 2024, the Plan Sponsor instructed Fidelity to terminate the Plan effective September 30, 2024. Participants will continue to be 100% vested in their account balances. Participants have been given until November 28, 2024 to take distributions of their account balances. All participants remaining in the Plan after November 28, 2024 will be deemed to have elected to rollover their account balance to an IRA as designated by the plan administrator.

The Plan's Management has evaluated subsequent events through September 26, 2024, the date the financial statements were available to be issued.
