We have performed audits of the financial statements of Katena Products, Inc. Employees Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of February 28, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to February 28, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Katena Products, Inc. **1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting**

The accompanying financial statements of Katena Products, Inc. Employees Retirement Plan (the “Plan”) are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation, Transactions, and Income Recognition**

*General*

Investments are carried at fair value, which is determined, presented, and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

*Level 1* - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

*Level 2* - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets, or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

*Level 3* - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

*Inputs and Valuation Methods:* In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes are presented below.

*Mutual Funds:* The fair value of mutual funds is generally based on quoted prices in active markets (Level 1).

*Guaranteed Investment Contract and Stable Value Fund:* The fair value of the units in the guaranteed investment contract and the stable value fund is estimated based on the net asset value per unit of the investments, which is calculated based on quoted market prices or other observable inputs. These investments are valued utilizing the net asset valuation, which approximates contract value. Net asset value is being used as a practical expedient to estimate fair value. The guaranteed investment contract is classified as interest bearing cash for Form 5500 reporting purposes. The stable value fund is classified as a common collective trust for Form 5500 reporting purposes.

*Valuation Methods, Consistency:* The valuation techniques used in the accompanying financial statements have been consistently applied.

*Transactions and Income Recognition:* Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Participant withdrawals and termination payments are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 28, 2023 and December 31, 2022.

**Administrative Expenses**

Certain expenses incurred for administering the Plan are paid by the Plan's sponsor, Katena Products, Inc. (the "Company") and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in mutual funds, a guaranteed investment contract, and a stable value fund. Such investments are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**2. DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of the Company who have at least three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**Plan Merger**

Effective December 2, 2021, the Company was acquired by Corza Medical. Effective January 1, 2023, the Company became an adopting employer within the Corza Medical 401(k) Plan. As of March 1, 2023, the net assets of the Plan were merged into the Corza Medical 401(k) Plan.

#### **Participant Contributions**

Prior to January 1, 2023, the Plan allowed participants to contribute up to 90% of pretax annual compensation, as defined in the Plan, not to exceed the limit established by law. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective January 1, 2023, contributions are made into the Corza Medical 401(k) Plan.

#### **Employer Contributions**

Prior to January 1, 2023, the Company made a safe harbor matching contribution. The safe harbor match was 100% of the first 3% of deferrals and 50% of the next 3% of deferrals into the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, rollover, and the Company's contribution and earnings and is charged with an allocation of administrative expenses based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Vesting**

A participant is 100% vested in his or her rollover contributions, employer matching contributions, deferral contributions, and any earnings upon participation and thereon.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participant notes are secured by the participant's account balance. All loans must be repaid in level payments on at least a quarterly basis over no more than a five-year period unless it is for the purchase of a principal residence, in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Participant note terms may not extend beyond 10 years from the date of the loan. All loans shall bear a reasonable rate of interest, as determined by the Plan administrator, based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. Interest rates were 4.25-8.00% at December 31, 2022. There were no outstanding loan balances at February 28, 2023 due to the Plan merger (see Note 2 – Plan Merger). Principal and interest are paid ratably through payroll deductions. The Plan allows only one outstanding loan at a time.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions and employer contributions to any of the investment options offered by the Plan. Participants may change their investment options daily. Participants may also reallocate contributions among investment funds at any time.

#### **Benefits**

Upon retirement, disability, death, or termination of service, a participant will receive either a lump sum or a rollover amount equal to the value of the vested portion of his or her account. Distributions are subject to the applicable provisions of the Plan agreement. The Plan allows in-service withdrawals under certain conditions.

#### **Forfeited Accounts**

At February 28, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$715, respectively. These accounts will be used to reduce future employer contributions.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Company to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved by the Company. Termination shall not permit any part of the Plan's assets to be used for, or diverted to, purposes other than the exclusive benefit of the participants and beneficiaries. In the event of termination, participants will become 100% vested in their accounts, and the Company will direct the trustee to distribute each participant's account in a single sum, as soon as administratively practicable after the termination of the Plan, irrespective of the present value of the participant's account and whether or not the participant consents to that distribution. As discussed in Note 2, the Plan has merged into the Corza Medical 401(k) Plan as of March 1, 2023.

**4. TAX STATUS**

The Company has adopted a volume submitter profit-sharing plan document that received an opinion letter from the Internal Revenue Service, dated June 30, 2020, indicating that the prototype plan is designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended, the Company and the Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of February 28, 2023 and December 31, 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. INVESTMENTS AT FAIR VALUE HIERARCHY**

Due to the Plan merger (see Note 2), there were no assets held at February 28, 2023. Assets measured at fair value on a recurring basis, based on their fair value hierarchy at December 31, 2022, are as follows:
