### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Navigate360, LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE A - DESCRIPTION OF PLAN**

The following description of the Navigate360, LLC ("Company") 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan covering substantially all employees of the Company who have reached age twenty-one and have 90 days of service. The Plan is subject to the provisions of ERISA.

Effective December 19, 2023, the Plan merged and transferred the plan assets to the SaveWise Pooled Employer Plan. All participant account balances were transferred over to the SaveWise plan as of that date.

*Contributions.* Upon meeting eligibility requirements, employees are automatically enrolled in the Plan at 3% of the employee's compensation. Employees may elect a different percentage, elect Roth or elect not to participate. Participants may contribute up to 100% of annual compensation, as defined in the Plan, on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan provides for a discretionary matching contribution to eligible employees equal to 50% of the first 6% of eligible compensation. For the period ended December 19, 2023, the matching contribution made to the Plan was \$410,749.

Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

*Participant Accounts.* Each participant's account is credited with the participant's contributions, and Company matching and non-elective contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's matching and non-elective contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of service.

*Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. Loan terms range from one to five years, longer for a personal residence. The loan interest rate for the Plan is based on Prime plus one percent. Principal and interest are paid ratably through payroll deductions.

*Forfeited Accounts.* At December 19, 2023 and December 31, 2022, forfeited accounts totaled \$0 and \$65,374, respectively. These accounts will be used to pay plan expenses and reduce future employer contributions. Forfeited amounts of \$61,323 were used to offset employer contributions for the period ended December 19, 2023.

*Payment of Benefits.* On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or a direct rollover to a qualified retirement account equal to the value of the participant's vested interest in his or her account. Upon proof, to the satisfaction of the plan administrator and trustee, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes. The Plan allows for in-service distributions for those participants reaching age 59 ½.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Contract value is the relevant measure attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought or sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 19, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participant initiated transaction fees are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE C - INVESTMENTS**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, the certifying entity, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 19, 2023 and December 31, 2022 and the related investment activity reflected in the statement of changes in net assets available for benefits for the period ended December 19, 2023.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measure. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 19, 2023 and December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at NAV, which is not publicly quoted but is available to current investments via the website or where participants access their account balances, therefore it is determined to have a readily determinable value and NAV is equal to fair value.

*Collective trusts:* Invests in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the collective trust and the separate accounts are not publicly quoted pricing inputs. The fair values of mutual funds are publicly quoted pricing inputs (level 1). The fair value of all these investments are used in determining the net asset value ("NAV") of the collective trust, which is not publicly quoted but is available to current investors via the website or where plan participants access their account values. The annual reports with underlying asset information is available. The NAV is the basis for current transactions and the collective trust can be redeemed at NAV as of the measurement date. Therefore it is determined to have a readily determinable value and NAV is equal to fair value.

**NOTE E - GUARANTEED INTEREST CONTRACT**

The Voya Fixed Account is a fully benefit-responsive contract. Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions made under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

There are no unfunded commitments. Under the terms of the contract, the Plan sponsor must provide a minimum of 90 days' notice to Voya prior to redemption of the contract. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (a) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (b) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (c) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**NOTE F - PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are pooled separate accounts and collective trusts held by Voya. Voya is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE G - PLAN TERMINATION**

On November 13, 2023, the plan sponsor adopted a resolution to merge and transfer plan assets to the SaveWise Pooled Employer Plan effective December 19, 2023, this merger effectively terminates for purposes of IRS annual reporting purposes the Navigate360, LLC 401(k) Profit Sharing Plan and Trust.

**NOTE H - TAX STATUS**

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself and the Plan has been amended subsequent to the date of the opinion letter however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE J – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 11, 2024, the date the financial statements were available to be issued.
