Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the NSONE, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the NSONE, Inc. 401(k) Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of the NSONE, Inc. 401(k) Plan (the "Plan") of NSONE, Inc. (the "Company") provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions.

The Plan is a defined-contribution plan established January 1, 2020, in accordance with the provisions of Internal Revenue Code ("IRC") Section 401. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Merger

On March 1, 2023, the Company entered into a merger agreement with IBM, whereby IBM acquired the Company. During 2023, a formal course of action was enacted that resulted in the merger of the Plan with the IBM 401(k) Plus Plan. On December 7, 2023, the Plan's assets were liquidated as a result of the Plan merger process and net assets of approximately \$5.7 million were transferred to the IBM 401(k) Plus Plan.

Administration of the Plan

The Company is the Plan administrator and is responsible for providing the participants and their beneficiaries with information about their rights and benefits under the Plan. Millennium Trust Company, LLC serves as the Plan's trustee ("Trustee"). Betterment for Business LLC serves as the Plan's recordkeeper.

Eligibility

All employees of the Company, other than nonresident aliens and employees covered by a collective bargaining agreement as defined, are eligible to participate in the Plan provided they have reached 18 years of age. The Plan allows participants to enter the plan once the eligibility criteria is met.

Contributions

Participants are allowed to make pre-tax and Roth contributions up to 100% of their compensation up to the limitation specified in the IRC in effect for each taxable year. For 2023, participants were permitted to contribute up to a maximum of \$20,500, with an additional \$6,500 for catch-up contributions for employees over 50 years of age. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may, in its discretion, make qualified non-elective contributions or qualified matching contributions. No such contributions were made for the year ended December 31, 2023.

Vesting

Participants' contributions and earnings or losses thereon are immediately vested.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions to any of the investment options offered by the Plan. Additionally, participants may redirect their investment balances among these various investment options.

Participant Accounts

Each participant's account is credited with the participant's contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

In the event of retirement, disability, death or termination of employment, participants may elect a lump-sum distribution equal to the value of the participant's vested balance. Participants may also request in-service distributions upon attaining age 59 ½ or due to certain hardships.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Payment of Benefits

Benefit payments are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. See Note 4, Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on the ex-dividend date. Realized gains and losses are calculated as the difference between the proceeds from sales and the related investment's fair market value at the beginning of the year, or acquisition cost if acquired during the year. Unrealized appreciation and depreciation are calculated as the difference between the fair value of investments at the end of the year less their fair values at the beginning of the year, or acquisition cost, if acquired during the year.

Plan Expenses

Plan expenses may be paid directly by the Company or by the Plan. Administrative expenses paid by the Plan amounted to \$25,026 for the year ended December 31, 2023. Certain investment related expenses are presented net within net appreciation in fair value of investments and are not readily determinable.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Company to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein at the date of the financial statements and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Millennium Trust Company, LLC, the Trustee of the Plan has certified the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, statement of changes in net assets available for benefits for the year ended December 31, 2023. No auditing procedures were performed with respect to information certified by the Trustees as complete and accurate.

4. FAIR VALUE MEASUREMENTS

The Plan’s investments are recorded in accordance with Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, which established a framework for measuring fair value and clarifies that fair value is an estimate of the exit price, representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (i.e., the exit price at the measurement date). That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology for registered investment companies, which represent Plan assets measured at fair value:

Registered investment companies are valued at the daily closing price as reported by the fund and include exchange-traded funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan adopted a prototype 401(k) plan document which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in these financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

As described above, in 2023 the Company formally approved a resolution to merge Plan participants’ account balances into the IBM 401(k) Plus Plan effective December 7, 2023. IBM 401(k) Plus Plan shall be the surviving plan and the Plan shall cease to exist as a separate stand-alone retirement plan.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants’ account balances and the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through September 11, 2024, the date the financial statements were available to be issued. Based on this evaluation, the Plan administrator has determined that no subsequent events require recognition or disclosure in these financial statements.
