Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Galephar Pharmaceutical Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits for the nine-months period ended December 31, 2023, and the related notes to the financial statements.

1. Description of Plan

The following description of Galephar Pharmaceutical Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary of the Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering all eligible employees of Galephar Pharmaceutical Research Inc. (the Company) who have completed three consecutive months of service and are aged 21 years or older. The original effective date of the Plan was January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company serves as the Plan Administrator. The Plan's Trustee is Plan's Sponsor Vice-President and the Human Resources Manager. The Plan's recordkeeper and custodian is Empower Retirement LLC.

Participants accounts

Each participant's account is credited with the participant's and Company contributions and a pro-rata allocation of the Plan's earnings, net of administrative expenses. The pro-rata allocation is based upon the proportion of individual account balances to total participants' accounts balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Contributions

A participant may contribute not less than 1% of pre-tax annual compensation as defined in the Plan and shall not exceed the pre-tax contribution limit allowed under Puerto Rico Internal Revenue Code section 1081.01(d) (\$15,000). The participants may contribute after-tax contributions and may not be less than 1% nor exceed 10% of compensation. Participants who have attained age 50 or over are eligible to make catch-up contributions up to \$1,500 per Plan Year. Participants direct the investment of their total contributions into various investments options offered by the Plan.

The Employer may make a discretionary matching contribution to the Plan. The matching contributions are currently equal to \$0.25 per each dollar of the participant's elective deferrals up to 4% of participant's eligible compensation. The Employer matching contributions are funded during each pay period.

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants become 100% vested in the matching contributions after three years of credited service. Non-vested portions of participant accounts that are forfeited upon payment of benefits are retained in the Plan and used to reduce future employer contributions or administrative expenses.

Investment Options

Upon enrollment in the Plan, participants may direct their contributions into various investment options offered by the Plan. Participants may change their investment elections daily. If a participant does not have an investment election on file, contributions will be made to one of the Target Funds, that has a target retirement date closest to your anticipated retirement year, based on the participant's date of birth.

Payment of Benefits

Upon a participant's retirement, death, disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed in the form of a lump sum distribution equal to the value of the participant's vested interest in his/her account or monthly, quarterly, or annual installments over a certain period of years. Also, the participant can choose to purchase a straight life annuity or an annuity contract from an insurance company selected by the Plan Administrator.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of his retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Forfeited Accounts

When certain terminations of participants in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, is forfeited. At the discretion of the Company, forfeitures may be used to reduce future employer contributions or plan administrative expenses.

Plan Termination

Although the Company has not expressed any current intent to terminate the Plan, the Company has the authorization to terminate or modify the Plan and suspend contributions to the Plan in accordance with ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of Galephar Pharmaceutical Retirement Plan have been prepared on the accrual basis and have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investments Valuation and Income Recognition (continued)

The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in the fair value of its investments which consist of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Contributions

Participant contributions and employer matching contributions are recorded on an accrual basis in the period during which the Company makes payroll deductions from the Plan participants' earnings.

Benefit Payments

Benefit payments are recorded when paid. For the year ended on December 31, 2023, the benefits paid amounted to \$884.

Administrative Expenses

The Company provides certain administrative and accounting services to the Plan at no cost. Administrative expenses including audit fees and legal fees are paid directly by the Company. Other administrative expenses directly incurred by the Plan include investment management fees, and distributions fees are charged directly to the participant's accounts. These administrative expenses are presented as a deduction to net assets on the Statement of Changes in net Assets Available for Benefits.

Risk and Uncertainties

The Plan provides for various investment options that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

3. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

Financial Accounting Standard Board (FASB) established the Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which provides a framework for defining and measuring fair value under generally accepted accounting principles. This codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. In some cases where market prices are not available, observable market-based inputs are used to calculate fair value, in which case the measurements are classified within Level 2. If quoted or observable market prices are not available, fair value is based upon internally developed models that use, where possible, current market-based parameters such as interest rates, yield curves and currency rates. These measurements are classified within Level 3.

Mutual Funds are valued at quoted market prices, which represent net asset value (“NAV”) of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded.

5. Tax Status

On December 29, 2022, it was requested to the Treasury Department of Puerto Rico a determination letter to qualify the Plan under Puerto Rico Internal Revenue Code of 2011, Section 1081.01(d) with effective date of January 1, 2023.

On March 17, 2023, the Plan Administrator received the determination letter approving the participation on the new prototype retirement plan and establishing that the established new Trust is exempt under Section 1081.01(d) of Puerto Rico Internal Revenue Code of 2011.

Accounting principles generally accepted in the United States of America requires to the management of the Plan to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. Related-Party Transactions and Party in Interest Transactions

Certain administrative expenses are paid by the employer on behalf of the Plan. Certain administrative functions of the Plan are performed by employees of the Company. No such employee receives compensation from the Plan. The Trustees of the plan are employees of the Company.

Empower Retirement LLC and certain subsidiaries provide administration and recordkeeping services to the Plan while another serves as Plan custodian. Transactions with these parties qualified as a party-in-interest transaction.

7. Subsequent events

Subsequent events were evaluated through August 28, 2024, which is the date of the financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefits date, and the date the financial statements were available to be issued that would require additional adjustment to or disclosure in the financial statements.

8. Prohibited Transactions

As required by ERISA Section 2510.3-102, the Company is required to segregate employee contributions to the Plan from its general assets as soon as practicable but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. During the year 2023, the Company did not remit some employee contributions as soon as they are able to remit the contributions to the custodian. The Company is able to remit in an average of 1 to 2 days immediately after payroll payment and they remitted in three non-consecutive periods the participant contributions within an average of 10 days. Total participant contributions considered late amount to \$26,458 in 2023. No correction has been made as of the issuance of this report.
