## Independent Auditors' Report

The Participants and Plan Administrator  
Comprehensive Medical Profit Sharing Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Comprehensive Medical Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 29, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits the period from January 1, 2023 to December 29, 2023, and for the year ended December 31, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 29, 2023 and for the period from January 1, 2023 to December 29, 2023 and as of and for the year ended December 31, 2022 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### (1) Description of plan

The following description of the Comprehensive Medical Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Effective December 29, 2023, the Plan merged into the Quorum Health Resources Retirement Savings Plan ("Quorum Plan"). As a result of the merger, \$2,844,021 of plan assets were transferred to the Quorum Plan and received on January 2, 2024.

#### (a) General

The Plan was a defined contribution plan adopted on January 1, 2000 covering substantially all employees ("participants") of Comprehensive Medical Management, LTD. (the "Company" or "Plan Sponsor") and a related affiliate as defined in the plan document, who average at least 20 hours per week or after one year of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) Contributions

Participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth 401(k) contribution. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined contribution plans. Participant contributions are permitted up to 100% of compensation.

The Plan also provided that the Plan Sponsor could contribute each year a discretionary matching and/or profit-sharing contribution; however, discretionary contributions by the Plan Sponsor were not required. Plan Sponsor contributions totaled \$78,558 and \$79,124 for the period and year ending 2023 and 2022, respectively. Plan Sponsor and participant contributions may not exceed the maximum amount deductible for income tax purposes.

#### (c) Participant accounts

Individual accounts were maintained for each Plan participant. Each participant's account is credited (charged) with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings (losses) and administrative expenses. Allocations were based on each participant's Plan compensation or account balance, as defined in the plan agreement. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants were immediately vested in their elective deferrals plus actual earnings or losses thereon. Vesting in Plan Sponsor discretionary contributions is based on years of service. Participants were 20% vested after two years of service and vest 20% each year thereafter until fully vested after six years of service.

(e) Notes receivable from participants

Participants could borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balances in the participants' accounts and bore interest which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are collected ratably through payroll deductions.

(f) Payment of benefits

Upon termination of service due to death, a participant or their beneficiary was entitled to receive a lump-sum distribution, installment payments, or partial distributions equal to the value of the participant's entire account balance. Upon termination of service due to reasons other than death, a participant was entitled to receive their vested account balance.

(g) Forfeited accounts

Forfeitures were created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures could be used to reduce Plan Sponsor contributions or pay administrative expenses. Forfeited nonvested accounts totaled \$15,433 as of December 31, 2022. Forfeitures of \$11,000 were used to pay administrative expenses during the period from January 1, 2023 to December 29, 2023.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Expenses of maintaining the Plan and expenses related to the administration of notes receivable from participants were paid from Plan assets and are included in administrative expenses. Certain fees incurred by the Plan for the investment management services were netted within net appreciation (depreciation) in the fair value and contract value of investments.

### (2) Summary of significant accounting policies

#### (a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### (b) Investment valuation and income recognition

Investments were stated at fair value or contract value as reported by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively "Empower"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for discussion of investment valuation.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### (c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the plan agreement.

#### (d) Payment of benefits

Benefits were recorded when paid.

#### (e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### (f) Events occurring after reporting date

Plan management has evaluated events and transactions that occurred between December 29, 2023 and September 30, 2024, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

### (3) Certified information

Certain information related to investments and notes receivable from participants presented and disclosed in the accompanying financial statements, including the fair value of investments and the contract value of the investment contract held and notes receivable from participants at December 31, 2022, and net appreciation (depreciation) in fair value and contract value of investments, interest and dividend income and interest income on notes receivable from participants for the period from January 1, 2023 to December 29, 2023 and for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower as of December 29, 2023 and 2022 and for the period January 15, 2022 through December 29, 2023 and Newport Trust Company, LLC for the period January 1, 2022 through January 14, 2022.

### (4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 and Level 3 are not applicable to the Plan.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset values of shares held by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Investment contract with insurance company

The Plan had a benefit-responsive investment contract with an insurance company. The insurance company maintained the Plan's contributions in a pooled account which was credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates were reviewed on a semi-annual basis for resetting.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit-sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved profit-sharing plan was designed in accordance with the applicable sections of the IRC. The Plan itself had not received a determination letter from the IRS stating that the Plan was qualified under Section 401(a) of the IRC. However, the plan administrator believed that the adopted non-standardized pre-approved profit-sharing plan was designed and was being operated in compliance with the applicable requirements of the IRC and was therefore qualified and exempt from taxation.

(7) Related party and party-in-interest transactions

Certain Plan investments included an investment contract managed by Empower and, therefore, these transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and held notes receivable from participants which also qualified as party-in-interest transactions.
