### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Cancer Center of Kansas, P.A. 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1. Description of the Plan**

***General***

The following description of Cancer Center of Kansas, P.A. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Cancer Center of Kansas, P.A. (Company) for the benefit of its employees who have at least six months of service and are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). INTRUST Bank, N.A. is the trustee of the Plan and also serves as plan custodian.

Effective September 1, 2023, the Company's administrative employees became employees of US Oncology Corporate, Inc. (USOC) due to an affiliation agreement. This resulted in a partial plan termination and impacted participants became 100% vested in their account balances. The clinical employees remained employees of the Company. Effective September 1, 2023, the Company's administrative employees began participating in The US Oncology 401k and the Company's clinical employees began participating in The US Oncology Clinical Practice 401k Plan. There were not any additional contributions to the Plan after September 6, 2023. Effective December 15, 2023, the Plan merged the net assets of the Plan into The US Oncology Clinical Practice 401k Plan.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 50 percent of eligible compensation with a minimum deferral of 1 percent. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for voluntary after-tax employee contributions limited to the lesser of 10 percent of the employee's compensation or \$6,000. The Company makes discretionary matching contributions of 50 percent of employees' salary deferral amounts on the first 6 percent of employees' compensation. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Participants have the option of directing their contributions into any of the separate investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus earnings (losses) thereon is based on years of continuous service. A participant is fully vested after six years of credited service.

***Notes Receivable From Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account. Interest rates are set at the time of borrowing and are equal to the *Wall Street* prime rate plus 1 percent. Principal and interest is paid ratably through monthly payroll deductions. Participants may not have more than two notes outstanding at any time.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, benefits shall be paid in a lump-sum amount equal to the value of the participant's vested interest in his or her account as soon as administratively feasible, following the date on which a distribution is requested or is otherwise payable. Upon termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution as soon as administratively feasible or, provided the vested benefit exceeds \$5,000, leave the funds in the Plan to provide benefits at a later date. The Plan also provides for in-service withdrawals, including financial hardships, as defined by the Plan Document.

***Forfeited Accounts***

At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0 and \$15,970, respectively. These accounts will be used to offset administrative expenses or reduce employer contributions. Also, in 2023 and 2022, forfeitures of \$27,244 and \$3,796, respectively, were used to offset administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in the stable value common trust fund is valued based on information reported by the investment advisor using the audited financial statements of the stable value common trust fund at year-end.

Self-directed brokerage accounts primarily consist of mutual funds, common stock, and exchange traded funds that are valued on the basis of readily determinable market prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, INTRUST Bank, N.A., a qualified institution, has certified the following information included in the accompanying financial statement is complete and accurate:

- Investments, notes receivable from participants and accrued interest and dividends as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

#### **Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Fees incurred by the Plan for the investment management services are netted against administrative expenses, as they are paid through revenue sharing, rather than a direct payment. The Company directly pays certain other fees related to the Plan's operations.

INTRUST Bank, N.A., the trustee as defined by the Plan, provides investment advice and recordkeeping services for the Plan through its NestEgg division. Therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$51,021 and \$17,292 of recordkeeping fees, net of revenue sharing credits, to INTRUST Bank, N.A. during 2023 and 2022, respectively. The Company provides certain administrative services at no cost to the Plan.

#### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets

**Note 6. Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

Although the Plan did not terminate, it was elected by the Company to merge the Plan into The US Oncology Clinical Practice 401(k) Plan effective December 15, 2023. During 2023, the Plan incurred a partial plan termination as described in *Note 1*. Affected employees became 100% vested in employer contributions.

**Note 7. Tax Status**

The Plan operates under an adoption agreement in connection with a prototype retirement plan and trust/custodian document sponsored by INTRUST Bank, N.A. This prototype plan document has been filed with the appropriate agency. The Plan itself has not obtained or requested a determination letter. Although the Plan has been amended since the prototype received an opinion letter, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified and the related trust is tax exempt as of the financial statement date.

**Note 8. Reconciliation of Financial Statements to Form 5500**

For financial statements reporting, revenue sharing credits are netted against administrative expenses. For Form 5500 purposes, administrative expenses are shown gross of revenue sharing for the year ended December 31, 2022.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through September 27, 2024, which is the date the financial statements were available to be issued.
