Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements

We have performed an audit of the financial statements of Geocomp 401(k) Profit Sharing Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2023 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of Geocomp 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Responsibilities of Management for the 2023 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Geocomp 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Their report also indicated that the form and content of the supplemental schedule, other than the information in the 2022 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2022 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Description of the Plan and Merger

The following description of Geocomp 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan was a defined-contribution plan covering substantially all eligible employees of Geocomp Corporation (Company or Plan Sponsor). The Plan was adopted on November 1, 1997. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*. The Plan Sponsor was responsible for oversight of the Plan and determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan's Board of Directors. Fidelity Management Trust Company was the trustee and custodian of the Plan.

Effective December 31, 2023, Plan management approved the merger of the Plan into the CGG 401(k) Retirement Plan. See Note 8.

Eligibility

Employees were required to be 18 years of age or older and have completed at least one month of service to participate in the Plan. Entry dates for eligible participants occurred on the first day of each month.

Contributions

Participants could elect to contribute up to the maximum amount allowable under the provision of the Internal Revenue Code (IRC) but not to exceed 85% of compensation. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans or individual retirement accounts, if the contributions satisfied federal and state regulations for qualified rollovers. Participants could also make Roth contributions into the Plan, in addition to pre-tax contributions. Participants directed the investments of their contributions and Company's discretionary match contributions to various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation.

Company matching contributions were made at the discretion of the Company's Board of Directors to participants. For the year ended December 31, 2023, the Company contributed an amount equal to 50% of the first 4% of the participant's contribution per pay period.

The Company was authorized to make a discretionary non-elective contribution, as determined annually by the Company's Board of Directors. For the year ended December 31, 2023, the Company did not make any additional discretionary non-elective contributions.

Participant Accounts

Each participant's account was credited with the participant's contributions, employer contributions as well as allocations of (a) the Company's discretionary non-elective contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations of earnings (losses) were based on account balances, as defined. Employer discretionary non-elective contributions were allocated based on employee compensation amounts. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Vesting

Participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s discretionary matching and non-elective contributions and any earnings thereon was based on years of continuous service as follows:

Less than 2 years	25%

4 years or more	100%

Amounts credited to a Member’s Geocomp Matching Contributions Account or Geocomp Nonelective Contributions Account that are not fully vested as of the date that such amounts were transferred to the Plan from the Geocomp 401(k) Profit Sharing Plan shall continue to vest in accordance with the aforementioned four-year graded vesting schedule.

Notes Receivable from Participants

Except for the CARES Act provisions, participants were permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Notes receivable repayment terms ranged from one to five years or up to ten years for the purchase of a primary residence. Loans were secured by the balances in the participants’ accounts and bore interest at rates based on the prevailing interest rates charged by persons in the business of lending money for loans that were made under similar circumstances. Only one loan outstanding was allowed at any given time. Principal and interest was paid ratably, usually through monthly payroll deductions, but had to be paid on at least a quarterly basis.

Payment of Benefits

The Plan allowed for distributions due to death, disability, retirement, termination or upon attaining the age of 59 1/2. Participants could elect to receive either a lump sum equal to the value of the participant’s vested interest in his or her account, or partial distributions. The Plan allowed for hardship withdrawals subject to a minimum of \$500. The Plan required a lump-sum distribution if a participant terminated employment, and the vested account balance was less than \$5,000.

Forfeitures Accounts

For the years ended December 31, 2023, and 2022, forfeited non-vested accounts totaled \$0 and \$5,006, respectively. These accounts were used to reduce future employer contributions and pay administrative expenses. Employer contributions were paid from forfeited non-vested accounts in the amount of \$16,558 and \$44,699 for the years ended December 31, 2023, and 2022, respectively. Forfeitures were used to pay administrative expenses in the amount of \$13,260 and \$0 for the years ended December 31, 2023 and 2022, respectively.

Note 2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses (realized and unrealized) on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on an accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred.

Payments of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation of fair value of investments.

Note 3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has

certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 4. Fair Value Measurements of Plan Investments

The Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurements and Disclosure* (ASC Topic 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets; and
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Self-directed brokerage accounts: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies for the years ended December 31, 2023 and 2022.

Note 5. Related Party Transactions and Party-In-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan's investments included shares of mutual funds managed by Fidelity Management & Research Company (FMR), an affiliate of Fidelity Management Trust Company (FMTTC), the trustee as defined by the Plan. Fidelity Investments Institutional Operations Company, the Plan's recordkeeper, was also an affiliate of FMR and FMTTC. Transactions with these entities qualified as party-in-interest transactions. Fees paid by the Plan to these entities for services in connection with the Plan were reported as administrative expenses in the statement of changes in net assets available for benefits. Total expenses paid by the Plan to these entities for the year ended December 31, 2023, amounted to approximately \$1,000. The Plan extended loans to participants who were considered parties-in-interest. These party-in-interest transactions were exempt from prohibitive transaction rules.

Strategic Advisors Inc. provided investment advisory services for the Plan and the Plan's auditor provided attest services for the Plan. The administrative expense paid to Strategic Advisors Inc. and the Plan's auditor was approximately \$1,100 and \$13,300, respectively, for the year ended December 31, 2023. The Company provided certain services at no cost to the Plan.

Note 6. Tax Status

In an opinion letter dated June 30, 2020, the Internal Revenue Service stated that the prototype plan adopted by the Plan qualified under Section 501(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the opinion letter; however, the plan sponsor believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7. Risk and Uncertainties

The Plan utilized various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Transfer of Plan Assets

Effective December 31, 2023, the Plan was merged into the CGG 401(k) Retirement Plan. All participants in the Geocomp 401(k) Profit Sharing Plan who were not fully vested at the time of the transfer had their vesting continue in accordance with the graded vesting schedule in Note 1. Participant account balances were transferred in accordance with the plan amendment for the merger. An aggregate of \$12,015,683 was transferred out of the Plan in 2023 and is presented as transfers to CGG 401(k) Retirement Plan on the statement of changes in net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through September 26, 2024, which is the date the financial statements were available to be issued.
