Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of The Systems Group 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audits opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audits does not affect management’s responsibility for the financial statements.

Notes to Financial Statements

December 31, 2023 and 2022

1. Summary of Significant Plan Provisions

The following description of The Systems Group 401(k) and Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Systems Plant Services, Inc. and Affiliates d/b/a The Systems Group (the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Each employee who is not a member of a union or a nonresident alien shall be eligible to participate in the Plan at the next entry date provided that the employee has completed 60 days of service and has obtained a minimum age of 21. Entry dates are the day eligibility requirements are satisfied.
- c. **Contributions** – Participants may contribute to the Plan through payroll deductions and rollover contributions. Employees may defer up to 100% of their eligible compensation up to the Internal Revenue Service (“IRS”) 401(k) elective deferral limitations on a pre-tax or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Each new participant entering the Plan shall automatically contribute 4% of eligible compensation unless an election is made not to participate or to defer a different percentage of eligible compensation. Employee deferrals will automatically increase by 1% each January 1, up to a maximum of 10%. The Employer may make a matching contribution for each eligible participant to be determined annually by the Employer. Participant contributions over 4% of eligible compensation are not matched. For the years ended December 31, 2023 and 2022, the Employer made matching contributions of 50% of participant contributions up to 4% of eligible compensation. The Employer may also make a discretionary profit sharing contribution. No such contribution was made during 2023 or 2022. The Plan contains provisions as to the maximum annual additions to a participant’s account that can be made.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – A participant is fully vested, at all times, in their own contributions and earnings/losses thereon. A participant shall be fully vested in contributions made by the Employer plus earnings/losses thereon if the participant reaches normal retirement age (65), becomes totally disabled or dies. If a participant terminates employment other than because of their retirement, death, or disability, they are entitled to a vested percentage of contributions made by the Employer and earnings/losses thereon.

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered by the Plan and may change their investment selections at any time.
- g. **Forfeitures** – The portion of the participant’s account to which they are not entitled upon termination of participation is deemed a forfeiture. Forfeitures are used to offset future Employer contributions to the Plan and are allocated to participant accounts in the same manner as the contributions they offset. Forfeitures of approximately \$140,000 and \$145,000 were utilized to reduce Employer contributions for the years ended December 31, 2023 and 2022, respectively. Forfeitures available for future use amounted to approximately \$3,500 and \$1,800 as of December 31, 2023 and 2022, respectively.
- h. **Payment of benefits** – Upon termination of service, a participant may elect to receive the value of their vested account balance in either an annuity, an installment, or a lump sum payment. Participants may elect upon termination of employment to defer payment of their account balance if it exceeds \$5,000. If a participant’s account balance is equal to or less than \$5,000, the account will be automatically distributed. In-service withdrawals are available to participants who meet certain hardship requirements. In addition, the portion of a participant’s account resulting from rollover contributions may be withdrawn at any time.
- i. **Corrective distributions** – The Plan failed the actual deferral percentage test for the years ended December 31, 2023 and 2022. Corrective distributions in the amount of \$157,117 and \$92,847 are recorded as a liability on the accompanying statement of net assets available for benefits and as a reduction of participant contributions on the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2023 and 2022, respectively. These corrective distributions were refunded to the applicable participants in February 2024 and March 2023, respectively.
- j. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Notes to Financial Statements**December 31, 2023 and 2022****2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Administrative expenses** – Administrative expenses paid by the Plan are allocated to the participants’ accounts. Fees related to distributions are charged directly to the participants’ accounts. Any administrative expenses of the Plan that are voluntarily paid by the Employer are excluded from these financial statements.

3. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information that was certified by Principal Trust Company (“PTC”), the trustee of the Plan, and was not subjected to any audit procedures, except for comparing such information with the related information included in the financial statements and supplemental schedules:

- a. Investments at fair value as shown on the accompanying statement of net assets available for benefits of \$21,409,306 and \$17,482,819 as of December 31, 2023 and 2022, respectively.
- b. Dividends as shown on the accompanying statement of changes in net assets available for benefits of \$5,591 and \$3,951 for the years ended December 31, 2023 and 2022, respectively.
- c. Net change in fair value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$2,917,898 and \$(4,029,790) for the years ended December 31, 2023 and 2022, respectively.
- d. All investment transactions that occurred during the years ended December 31, 2023 and 2022.
- e. All the information included in the supplemental schedules.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 or 2022.

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

Pooled separate accounts: These investments are valued based on the net assets value ("NAV") of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments, adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

December 31, 2023 and 2022

4. Fair Value Measurements (cont.)

Common collective trust funds: These investments are stated at fair value based on the NAV of units held by the Plan at year-end, as calculated by the issuer. The NAV is calculated based on the fair value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. **Tax Status**

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. **Parties-in-Interest Transactions**

Principal Life Insurance Company (“Principal Life”) is the third-party administrator of the Plan. The Plan pays fees to Principal Life for their services. A portion of the Plan’s funds are invested in pooled separate accounts with Principal Life. A portion of the Plan’s funds are invested in common collective trust funds issued by PTC. Principal Financial Group (“Principal Financial”) owns the entity that is the trustee of these funds. PTC is affiliated with Principal Financial and Principal Life through related ownership. PTC holds the Plan’s investment assets and executes investment transactions. Inasmuch as PTC serves as trustee and Principal Life as the third-party administrator, they are by definition parties-in-interest and, as a result, the Plan’s investments and transactions pertaining to these investments were with parties-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.
