Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Leal Management 401k Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Termination and Use of Liquidation Basis of Accounting

As discussed in Note F to the financial statements, the Board of Trustees made the decision to terminate the Leal Management 401k Plan upon the sale of the assets of the Plan sponsor Lmc Property Management Co Inc. As a result, in accordance with accounting principles generally accepted in the United States of America, the Leal Management 401k Plan has used the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Leal Management 401k Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2022

NOTE A - DESCRIPTION OF PLAN

The following brief description of the Leal Management 401k Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) established on January 1, 2022 covering substantially all employees of Lmc Property Management Co Inc and its affiliated companies (collectively referred to as “the Company”) who have met the age requirement of 18 years old and the service requirement of six months of service excluding nonresident aliens and residents of Puerto Rico. Effective December 20, 2022, the Board of Trustees made the decision to terminate the Plan as a result of the asset purchase of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may make pre-tax or after-tax (Roth) contributions from 1% up to 90% of compensation subject to the limits of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a matching contribution equal to 100% of participant contributions up to 2% of compensation each pay period. The Company may also make nonelective contributions to the Plan. For the year ended December 31, 2022, the Company did not make any nonelective contributions. Participants direct the investment of their Company contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company matching contributions, Company nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses, if any. Allocations are based on earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and Company nonelective contributions, if any, plus actual earnings thereon. Participants vest in the Company matching contributions portion of their account based on years of service, as follows.

If a participant dies or is disabled prior to attaining the normal retirement age, the participant becomes 100% vested.

Effective December 20, 2022, upon the decision to terminate the Plan, participants became 100% vested in their balances in accordance with regulations.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant, or their beneficiary, may elect to receive a lump sum distribution, equal installments, or partial withdrawals, subject to a \$500 minimum, up to the value of the participant's vested interest. A participant may also request an in-service withdrawal from their vested account balance if the participant has attained age 59.5. Hardship withdrawals are also permitted. If a participant's vested balance is less than \$5,000, but more than \$1,000, the participant's balance will automatically be distributed and rolled over into an individual retirement account unless the participant elects otherwise. If a participant's vested balance is less than \$1,000, the participant's balance will automatically be distributed in the form of a lump sum to the participant.

Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. As of December 31, 2022, there was a forfeiture balance of \$617. During the year ended December 31, 2022, forfeitures of \$158 were used to fund Company matching contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expenses. As of and during the year ended December 31, 2022, there were no notes receivable from participants. As of December 31, 2022, no allowance for credit losses has been recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund: The Invesco Stable Asset fund is a collective investment trust fund. The fund is composed primarily of guaranteed investment contracts. The investment is valued at the NAV of units of the collective investment trust. The NAV is used as a practical expedient to estimate fair value. The fund is not registered with the Securities and Exchange Commission. There are no unfunded commitments. The redemption notice period is 90 days and redemption frequency is daily. The Plan will receive the lesser of book value or market value if it chooses to terminate the fund as an investment option and the issuer reserves the right to require a 12-month written notice.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ADP Retirement Services is the third-party administrator and recordkeeper for the Plan. Fees paid to ADP Retirement Services have been included in administrative expenses. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Reliance Trust Company is the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE F - PLAN TERMINATION

Effective December 20, 2022, the Company made the decision to terminate the Leal Management 401k Plan due to the purchase of the assets of Lmc Property Management Co Inc. As a result of the decision to terminate the Plan during the year ended December 31, 2022, the financial statements have been presented on the liquidation basis of accounting. The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. All participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of service, on December 20, 2022.

NOTE G - TAX STATUS

The Plan operates under a non-standardized pre-approved profit sharing plan. The IRS has opined and informed the plan administrator by a letter dated October 6, 2020, that the volume submitter plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan as of December 31, 2022, and is not aware of any uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market rate, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain amounts included on Schedule H Part I and II on the Annual Return/Report of Employee Benefit Plans (Form 5500) have been grouped differently for purposes of presentation in the financial statements.

NOTE J – INCOMPLETE AND LATE 2022 FORM 5500 FILING

The 2022 Form 5500 was filed late and was incomplete due to the failure to attach the required Accountant's Opinion, audited financial statements, accompanying footnotes, and supplemental schedule. The Company will amend the 2022 Form 5500 and include the required Accountant's Opinion, audited financial statements, accompanying footnotes, and supplemental schedule as soon as administratively feasible. Penalties assessed by the Department of Labor and the Internal Revenue Service, if any, will be paid by the Company.

NOTE K – PLAN CORRECTION DUE TO OPERATIONAL FAILURE

During the initial Plan audit for the year ended December 31, 2022, operational errors were discovered. The operational errors were due to missed deferrals on manual paychecks which also resulted in missed employer matching contributions. An analysis was performed by the Company to identify all instances of the errors, and a corrective contribution was quantified in accordance with IRS regulations. The corrective contribution owed to Plan participants totaled \$84 and is presented as other employer contributions receivable on the statement of net assets available for benefits as of December 31, 2022 and as other employer contributions on the statement of changes in net assets available for benefits for the year ended December 31, 2022. The Company is working with ADP Retirement Services to determine the appropriate way to fund the correction due to the termination and full liquidation of the Plan. The Company will correct the operational failure as soon as administratively feasible.
