Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The ESCO Group 401(k) Plan (The Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The ESCO Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We are required to be independent of The ESCO Group 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS
December 31, 2023 and 2022

1. Description of the plan

The following brief description of The ESCO Group 401(k) Plan (“the Plan”), is provided for general information purposes only. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

The Plan is a defined contribution 401(k) plan covering any employee of ESCO Electric Service, Inc. (the “Company” or “Plan Sponsor”) who is at least twenty-one years of age, is not covered by a collective bargaining agreement, and is not an intern, part-time or seasonal employee as defined by the Plan Agreement or a non-resident alien. Employees become participants on the first day of the month immediately following meeting the age requirements. The Plan allows participants to designate all or a portion of their elective deferrals as ROTH elective deferrals. ROTH elective deferrals are accounted for separately in the respective participant’s account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan is funded by pretax and ROTH contributions from participants in amounts up to 100% of eligible compensation, limited to the maximum amount deductible by salary reduction under the Internal Revenue Code (“IRC”). The Plan is also funded by Company discretionary matching contributions. For the year ended December 31, 2022, the discretionary match was equal to 50% of the first 4% of employee deferrals with a maximum matching contribution not to exceed 2% of eligible compensation for the Plan year. Elective deferrals and Company discretionary matching contributions begin immediately upon completion of eligibility requirements. Participants may also roll over or transfer amounts representing distributions from other qualified retirement plans. Effective January 1, 2023, the Plan was amended to become a safe-harbor plan which changed the employer match to equal 100% of the first 3% of employee deferrals. In addition, the amendment also allows for a discretionary employer match up to 4% of employee deferrals in addition to the safe-harbor match. There was no discretionary match made in 2023.

Participant accounts

Each participant’s account is credited with the participant’s contributions, Company discretionary matching contributions, an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant’s compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the plan, continued

Vesting

Participants are immediately vested in their salary deferrals, rollover contributions, and actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their account plus actual earnings thereon is based on years of continuous service. Participants vest on a graduated basis with 100% vesting after five years of credited service, or upon the participant's death, disability, or attainment of early or normal retirement age, as defined in the Plan Agreement. Effective January 1, 2023, participants are immediately 100% vested in employer safe harbor matching contributions.

Investment options

Upon enrollment in the Plan, participants direct the investment of their contributions and the Company's discretionary matching contributions into various investment options offered by the Plan. Participants may change their investment options at their discretion and changes become effective on the next business day. Investment options offered by the Plan are reviewed by an advisory committee comprised of Company employees and a professional investment advisor. During 2023 and 2022, the Plan made changes to the investment lineup in order to achieve better returns and lower fees.

Forfeited accounts

During 2023 and 2022, forfeited nonvested accounts totaled \$6,802 and \$3,260, respectively. Forfeitures are used to offset discretionary matching contributions or pay plan expenses. Forfeitures in the amount of \$-0- and \$4,567 were used to offset Company discretionary matching contributions during 2023 and 2022, respectively. Forfeitures totaling \$-0- and \$11,438 were used to pay Plan expenses during 2023 and 2022, respectively. In addition, during 2022, the Plan transferred \$12,079 from various participant accounts to the forfeiture account related to excess matching contributions made in error in prior years. As of December 31, 2023 and 2022, there were unallocated forfeitures of \$15,411 and \$8,609, respectively, available for use.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years, or ten years if used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate equal to 2% over the Wall Street Journal prime rate as defined in the Plan Agreement. Interest rates range from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon retirement, death, disability or termination of service, participants receive an amount equal to the value of their vested benefit. The Plan provides for lump-sum and installment distributions. If no benefit election form is completed, participants receive automatic lump-sum distributions for accounts with a value of \$1,000 or less. In addition, participants automatically have balances rolled into an individual retirement account in their name for accounts with balances between \$1,000 and \$5,000, if no election form is completed. Distributions of balances of less than \$5,000 are made as soon as administratively feasible. Distributions of balances of greater than \$5,000 are made at the election of the participants.

1. Description of the plan, continued

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of investment risk

As of December 31, 2023 and 2022, approximately 32% and 22% of the Plan's investments were held by two individual mutual funds and one mutual fund, respectively. As of December 31, 2023 and 2022, approximately 64% and 60%, respectively, of the Plan's investments were held by one mutual fund family. This mutual fund family, and the individual mutual funds, held in excess of 10% of the Plan's total investments at December 31, 2023 and 2022.

2. Summary of significant accounting policies, continued

Notes receivable from participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

Payment of benefits

Benefits are recorded when paid.

Income tax status

The Plan is a nonstandardized prototype plan. The Internal Revenue Service (“IRS”) has determined and informed the custodian by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended and restated since the date of this opinion letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events

Plan management has evaluated subsequent events through September 17, 2024, the date the financial statements were available to be issued.

3. Information prepared and certified by Newport Trust Company, LLC and Ascensus Trust Company, LLC (“Newport Trust” and “Ascensus Trust”), parties-in-interest

All assets of the Plan were held by Ascensus Trust and Newport Trust, parties-in-interest, as of December 31, 2023 and 2022, respectively. Newport Trust and Ascensus Trust merged on June 26, 2023, with Ascensus Trust being the surviving entity. All investment transactions during the years ended December 31, 2023 and 2022 were executed under formal custody agreements between the Plan and Newport Trust and Ascensus Trust. All securities bought, sold, or exchanged were executed under these agreements. Such financial information has not been audited by independent auditors.

3. Information prepared and certified by Newport Trust Company and Ascensus Trust Company, LLC (“Newport Trust” and “Ascensus Trust”), parties-in-interest, continued

In accordance with the provisions of Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, Newport Trust and Ascensus Trust, have certified the following unaudited financial information to be complete and accurate with respect to the Plan’s assets held by them as of December 31, 2023 and 2022, and activity for the years then ended:

4. Risks and uncertainties

The Plan provides for investments in various securities, which, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the net asset value ("NAV") of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust, less its liabilities. The practical expedient is not used when it is determined to be probable that the trust will sell the investments for an amount different than the reported NAV. Investments in the trust can be redeemed immediately at the current net asset value per share. There are no unfunded commitments or significant restrictions on redemptions.

5. Fair value measurements, continued

Interest-bearing cash: Valued at historical cost which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held no investment in Level 2 or 3 of the fair value hierarchy as of December 31, 2023 and 2022.

The Plan's policy is to recognize transfers between Levels as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2023 and 2022, there were no transfers between Levels.

6. Administrative expenses

Administrative fees for the maintenance of investments, contribution and distribution records and the processing of related transactions are paid by the Plan to Newport Trust and Ascensus Trust, parties-in-interest. Total fees paid by the Plan were reduced by 12b-1 payments and similar compensation ("revenue-sharing credits") received by Newport Trust. During 2023 and 2022, the Plan Sponsor applied \$271 and \$22,404, respectively, of revenue sharing credits to pay administrative fees. Net administrative expenses, including audit fees, of \$92,208 and \$96,328 were paid by the Plan for the years ended December 31, 2023 and 2022, respectively.

Loan set-up and distribution fees are deducted from the respective loan or distribution. In 2023, audit fees to BGHN Associates, P.C., a party-in-interest, were paid by the Plan Sponsor in the amount of \$11,500. In 2022, audit fees were paid using forfeitures of \$10,500.

7. Related party and party-in-interest transactions

The Company has an agreement with Newport Trust and Ascensus Trust to provide record-keeping, administrative, custodial, and transaction processing services for the Plan's investments. Other party-in-interest transactions are described in Notes 3 and 6.
