Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of All Holdings, LLC 401(k) Plan and Trust, f/k/a All Tile, Inc. Employees' Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

1. DESCRIPTION OF PLAN

The following description of the All Holdings, LLC 401(k) Plan and Trust, f/k/a All Tile, Inc. Employees' Profit Sharing Plan and Trust (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established effective June 1, 1978, as restated January 1, 2021. The Plan covers all employees, excluding those who are members of a union, non-resident aliens, and leased employees, of All Tile, LLC, All Surfaces, Inc., All Carpet Cushion & Supplies, Inc., All Logistics, Inc., and All Holdings, Inc. (collectively, the Company) who have completed one month of service and are age 18 or older. An employee must have completed one year of service to be eligible for profit sharing contributions and one month of service to be eligible for discretionary employer matching contributions. The Plan requires a participant to be employed as of year end to be eligible to receive profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The plan administrator is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's plan administrator.

Effective January 25, 2023, the name of the Plan was changed to All Holdings, LLC 401(k) Plan and Trust. The Plan Sponsor changed its name to All Tile, LLC.

Contributions - Each year, participants, other than highly compensated participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The plan limits highly compensated participants to a deferral amount no more than \$12,000 in a plan year. Highly compensated participants may contribute up to 100 percent of annual compensation up to \$12,000. "Highly compensated participants" are defined as (1) five percent owner during the plan year or prior year, or (2) have compensation in the prior year in excess of \$135,000 (if the preceding year is 2022) or \$150,000 (if the preceding year is 2023). Participants direct the investment of their contributions into various investment options offered by the Plan.

Additional profit sharing amounts may be contributed at the option of the Plan Sponsor. For the year ended December 31, 2023, there were no profit sharing contributions to the Plan. Additional discretionary amounts may be contributed by the Company at the option of the Plan Sponsor. The Plan sponsor made discretionary matching contributions for the year ended December 31, 2023, equal to the lesser of 50% of contributions or 50% of the first 3% of eligible compensation. For the year ended December 31, 2023, the Company made matching contributions equal to \$177,285. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts - Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary contributions, (profit sharing and employer match), and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20 percent vested after one year of credited service and continues to vest in increments of 20 percent until 100 percent vested after five years of credited service. In addition, upon death, disability or attainment of normal retirement age, as defined by the plan document, a participant will become 100 percent vested.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

Payment of benefits - On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of lump sum cash payment. For vested account balances greater than \$1,000 and less than \$5,000, if a participant does not submit the election form, the vested balance is automatically rolled into an IRA set up in the participant's name. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited accounts - At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0 and \$344, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2023, plan administrative expenses were reduced by \$1,111, from forfeited nonvested accounts, in accordance with plan provisions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent events - Subsequent events were evaluated through October 1, 2024, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at net asset value: Consisting of a common-collective trust, valued at the net asset value of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are managed by the Custodian, and therefore, these transactions qualify as party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Counsel Trust Company dba Mid Atlantic Trust Company receives revenue from investment fund service providers for services Counsel Trust Company dba Mid Atlantic Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Counsel Trust Company dba Mid Atlantic Trust Company for its administrative services to the Plan. If the revenue received by Counsel Trust Company dba Mid Atlantic Trust Company from such investment fund service providers exceeds the amount owed for its services, Counsel Trust Company dba Mid Atlantic Trust Company remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to Counsel Trust Company dba Mid Atlantic Trust Company for administrative expenses not covered by revenue sharing. Fees of \$5,921 were incurred for the year ended December 31, 2023.

The Weiss Group, Inc. provides administrative services to the Plan. Therefore, these are party in interest transactions. Fees of \$49,179 were incurred for services provided by The Weiss Group, Inc. for the year ended December 31, 2023.

LPL Financial provides investment advisory services to the Plan. Therefore, any fees paid to them are party in interest transactions. Fees of \$40,883 were incurred for these services for the year ended December 31, 2023.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

6. TAX STATUS

The Plan adopted a pre-approved plan offered by FIS Business Systems, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. INFORMATION CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, Counsel Trust Company dba Mid Atlantic Trust Company, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2023 and 2022, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2023, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023.

9. SUBSEQUENT EVENTS

The Plan was amended and restated on January 1, 2024. The Plan merged the Blakely Products Company Profit Sharing 401(k) Plan and the Walcro, LLC 401(k) Retirement Plan effective January 1, 2024. As amended and restated, the Plan granted additional employers credit for service including Walcro, LLC and Blakely Products Company. The related employers that participate in the Plan include All Tile Holdings, LLC; Cartwright Distributing, LLC; and Tri-State Wholesale Flooring, LLC.

Effective January 1, 2024, participants are 100 percent vested in all employer matching contributions while participants vest over a three-year period for nonelective profit sharing employer contributions. Certain participants of the former Walcro, LLC 401(k) Retirement Plan with any safe harbor match contributions in their account balances were immediately vested in those contributions.

Additionally, those participants who merged with an employer match or profit-sharing contribution in their account balances vest evenly over a five-year period.

The Plan was amended to include an early retirement age of 55.

The Plan was amended to redefine eligible compensation to exclude reimbursements or other expense allowances. The Plan was amended to remove the elective deferral limit associated with participants who are highly compensated employees of \$12,000. The deferral limit for all participants as amended is 100 percent of eligible Plan compensation.

In-service withdrawals were amended to be permitted once the participant reaches normal retirement age of 60 rather than at age 59 ½ as previously permitted.

The Plan was amended to allow installment payments as a form of distributions.

Upon restatement and amendment, the Plan was renamed the All Surfaces, Inc. 401(k) Plan effective January 1, 2024. All other plan provisions remained the same.
