**1. Description of Plan**

The following description of the Gateway Supply Company, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants may refer to the Plan’s documents for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering employees of Gateway Supply Company, Inc. (the “Company”), who are at least eighteen years of age and have completed six months of service. Union employees, non-resident aliens, and certain other employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In August 2023, the Company was acquired by another company. The Plan administrator passed a resolution to freeze contributions for employees of the Company beginning September 18, 2023, and began the process of terminating the Plan. In accordance with accounting principles generally accepted in the United States (“US GAAP”), the Plan changed its basis of accounting from the going concern basis to the liquidation basis effective September 18, 2023. Effective September 18, 2023, contributions were discontinued and participants became fully vested in their accounts.

**Contributions**

Once they meet the eligibility requirements, participants may choose to contribute up to 92% of their pretax compensation to the Plan. Participants who do not choose a specific deferral rate are automatically enrolled into the Plan at a deferral rate of 6% of their pretax compensation. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans.

The Company makes matching contributions to each participant’s account equal to 50% of the participant’s contributions, up to 6% of the participant’s eligible compensation. For the years ended December 31, 2023 and 2022, there were matching contributions of approximately \$297,000 and \$359,000, respectively. The Company may also make discretionary profit sharing contributions to the Plan. No discretionary profit sharing contributions were made for the years ended December 31, 2023 and 2022.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, allocations of Plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Company profit sharing contributions are allocated based on the ratio of each participant's compensation, as defined, to the total compensation of all plan participants for the plan year. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a collective trust as investment options for participants. Earnings or losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately vested in their salary deferrals plus actual earnings or losses thereon. Through September 17, 2023, vesting in the Company's contributions and actual earnings or losses thereon was based on years of continuous service. Participants vested in Company contributions at a rate of 20% per year beginning with the first year through the fifth year of service, at which time they were fully vested. Effective September 18, 2023, participants became fully vested in the Company's contributions as a result of the Plan termination.

**Participant Notes Receivable**

Participants may borrow from their accounts, subject to certain restrictions. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are required to be repaid within five years, except for loans made for the purchase of a primary residence. A participant may have no more than one note due to the Plan at any time. The notes are collateralized by the balance in the participant's account and bear interest at the prime rate plus 1% (determined at the time of issuance of each loan). Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement or termination, a participant may elect to receive their vested portion of Plan assets under several payout options specified by the Plan. If a participant's vested account balance does not exceed \$5,000, the Plan may automatically distribute the participant's vested account balance in a lump sum. Also subject to certain conditions, participants are permitted to make hardship withdrawals from their vested account balances in the Plan while employed.

**Payment of Benefits (continued)**

Participants who have attained 59½ years of age are also permitted to withdraw all or part of their vested accounts as in-service distributions.

**Forfeitures**

Through September 17, 2023, participants withdrawing from the Plan with nonvested employer contributions in their account forfeited their share of the nonvested contributions and earnings thereon. Those amounts are used to reduce future employer contributions or to pay Plan expenses.

**Administrative Expenses**

Expenses of maintaining the Plan are paid by the Plan or by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Plan Termination**

The Plan was formally terminated effective September 18, 2023. As of June 2024, all remaining plan assets had been distributed from the Plan.

Plan management is in the process of completing the administrative tasks associated with the 2024 short plan year.

**2. Basis of Presentation and Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared in accordance with US GAAP.

**Estimates**

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Participant Notes Receivable**

Participant notes receivable are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and is in default, the loan balance is reduced as a distribution to the participant.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan invests in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

**Payment of Benefits**

Benefits paid to participants are recorded when paid.

**3. Custodian Certifications**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2023 and 2022 related to investments, net appreciation (depreciation) in fair value of investments, and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's custodian, American Trust Company (formerly Mid Atlantic Trust Company).

**4. Fair Value Measurements**

The methods used to measure fair value may produce amounts that are not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. All of the Plan's mutual fund investments were valued using Level 1 inputs, based on quoted market prices of the shares held by the Plan.

The Plan invests in a collective trust whereby the underlying investments primarily consist of stable value contracts and security backed contracts. The collective trust is valued at the net asset value ("NAV") of units of the accounts. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held less the account's liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

**5. Income Tax Status**

The plan operates under a pre-approved non-standardized profit sharing plan designed to be in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan obtained its latest determination letter on August 31, 2020, in which the Internal Revenue Service (“IRS”) determined that the pre-approved plan document and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities are identified at December 31, 2023 and 2022. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Party-in-Interest Transactions**

Fees paid by the Plan for custodial, recordkeeping, and investment advisory services amounted to approximately \$59,000 and \$53,000 for the years ended December 31, 2023 and 2022, respectively. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**7. Subsequent Events**

Management evaluated events and transactions after December 31, 2023 through September 5, 2024, the date the financial statements were available to be issued, for subsequent events. Other than the full liquidation of the Plan assets discussed in Note 1, Plan management determined that there were no events to report.
