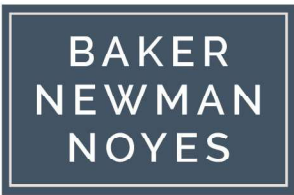

## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Trustees and Participants

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

### **Emphasis of Matter – Plan Termination**

As disclosed in Note 1 to the financial statements, on August 11, 2023, Salisbury Bank and Trust Company (the Plan Sponsor) merged with and into NBT Bank. Coinciding with the merger, the Plan was terminated. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

### 1. Plan Description and Summary of Significant Accounting Policies

The Salisbury Bank & Trust Co. 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan that is available to all employees of Salisbury Bank & Trust Company (the Bank or Plan Sponsor). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The original Plan was established on January 1, 2000.

The Bank is the administrator of the Plan. The Plan has engaged Fidelity Management Trust Company (Fidelity) as a trustee, recordkeeper and investment provider.

The following description provides only general information about the Plan. Participants should refer to the Plan Document and Adoption Agreement for a more complete description of the Plan.

On August 11, 2023, the Plan Sponsor merged with and into NBT Bank. Coinciding with the merger, the Plan was terminated. All remaining participant account balances were distributed to participants, with final distributions made on December 11, 2023.

#### Eligibility and Entry Dates

The age requirement is 18.

#### Contributions

Participants may elect to contribute a pre-tax or after-tax (Roth) salary deferral of 1% to 100% of eligible compensation, subject to IRS limits. Employees are not required to contribute in order to participate in the Plan. Participants receive an employer Safe Harbor Non-Elective Contribution of 3% of eligible compensation, regardless of employee contribution amount. In 2023, such contributions totaled \$347,810.

Participants can direct the allocation of their accounts to any of the stipulated mutual fund or money market alternatives offered by the Plan. Participants may change their investment options at any time during the year.

The Plan allows rollover contributions of eligible rollover distributions from any other IRS qualified retirement plan or IRA.

In 2023, the Bank's discretionary matching contribution was 100% of the first 6% of employee contributions. The total 2023 discretionary matching contribution funded to participants accounts in 2023 is \$368,184. In 2022, the discretionary contribution of \$799,534 was funded to participant accounts in 2023 and was recorded as employer contributions receivable on the December 31, 2022 statement of net assets available for benefits.

In 2022, the Bank provided a discretionary match to several employees that were not eligible. The estimated amount of \$37,165 is recorded as a payable at December 31, 2022. In 2023, \$17,303 was returned to participants; the remaining \$19,862 is reflected as employer contributions in 2023.

The Plan has a discretionary profit-sharing contribution formula under which each qualifying participant's individual account will receive a pro rata allocation based on the qualifying participant's compensation in relation to the total compensation of all qualifying participants. There was a profit sharing contribution of \$54,522 in 2023.

#### Vesting

Participants are always 100% vested in employee salary deferrals, rollover, employer matching, safe harbor non-elective and profit-sharing contributions.

#### Participant Withdrawals

The Plan provides for participants to withdraw their funds at any time after reaching normal retirement age (65) or early retirement age (59.5) and certain employment requirements. Such withdrawals are based on the amount in the participant's account as of the valuation date coinciding with or immediately after the participant's retirement date. The Plan also provides for withdrawal in the event of death, disability, hardship or termination.

#### Notes Receivable From Participants

Loans are allowed in accordance with rules and regulations outlined in a written loan disclosure and basic loan agreement. Participant loans are limited to no more than 50% of a participant's vested account balance, or \$50,000, if less.

#### Participant Account

Each participant's account is credited with the participant's contribution and a proportionate allocation of any Bank contribution and Plan earnings or loss. The benefit to which a participant was entitled is the benefit that was provided from the participant's vested account.

#### Administrative Expenses

Certain expenses, including trustee and recordkeeping services, are paid from participants' investment funds and reduce participant investment returns. Other administrative expenses relating to the Plan are paid by the Bank.

#### Basis of Accounting

The 2023 financial statements have been prepared on the liquidation basis of accounting as prescribed by accounting principles generally accepted in the United States of America (U.S. GAAP) for a terminating plan. The 2022 financial statements were prepared on the accrual or ongoing basis of accounting.

#### Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

There are no investments held at December 31, 2023. All investments in the 2022 Statement of Net Assets Available for Benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation/depreciation of fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Benefit Payments

Benefits were recorded when paid.

#### Notes Receivable From Participants

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

#### Contributions

Contributions from participants are recorded in the period in which payroll deductions are made. Employer matching contributions are recorded in the same period as the corresponding participant contributions. Other employer contributions are recorded when the Bank commits to making the contribution.

#### Subsequent Events

The Plan has evaluated subsequent events through September 26, 2024, the date the financial statements were available to be issued.

### 2. **Tax Status**

The Plan is operating under a prototype plan document sponsored by Fidelity Management & Research Company. Fidelity Management & Research Company has obtained a letter from the Internal Revenue Service (IRS) dated June 30, 2020, specifying that the form of the Plan is acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 11, 2023 and December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 3. **Fair Value Measurements**

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 11, 2023 and December 31, 2022.

#### 5. **Related-Party Transactions and Party-In-Interest Transactions**

Fidelity is trustee, recordkeeper and investment provider for the Plan. Certain mutual fund investments are Fidelity mutual funds and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan pays for fees to the Plan's investment advisors, RBC Wealth Management. Notes receivable from participants and interest on notes receivable from participants also qualify as party-in-interest transactions. Direct administrative expenses charged to the Plan paid to these parties during 2023 totaled \$122,243 and qualify as party-in-interest transactions.

#### 6. **Reconciliation of Form 5500 to Financial Statements**

Notes receivable from participants are reflected as a receivable on the statements of net assets available for benefits, which differs from the Form 5500 presentation. On the Form 5500, notes receivable from participants are classified as investments under the caption "participant loans."
