### Opinion

We have audited the accompanying financial statements of Fred C. Church, Inc. Employees' Stock Ownership Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets in liquidation as of December 31, 2023 and 2022, and the related statement of changes in net assets in liquidation for the year ended December 31, 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets in liquidation of Fred C. Church, Inc. ### **NOTES TO FINANCIAL STATEMENTS IN LIQUIDATION DECEMBER 31, 2023 AND 2022**

---

#### **1. SALE OF FRED C. CHURCH, INC.'S COMMON STOCK AND PLAN TERMINATION**

The Trust owned 262,065 shares of Fred C. Church Inc.'s (the Company) outstanding common stock, which represented a 46.62% interest in the Company. On December 30, 2021, the Company was sold, and the shares held by the Trust were transferred to the purchaser. Proceeds from the sale of \$67,161,682 were received by the Trust on December 30, 2021 and allocated to participants. The resulting realized gain of \$31,968,973 was recorded in the year ended December 31, 2021. In 2022, the Trust received additional proceeds of \$946,208 from the sale that was recorded as a realized gain in the year ended December 31, 2022. In 2023, the Trust received final proceeds of \$2,489,279 from the sale that was recorded as a realized gain on the accompanying statement of changes in net assets in liquidation as of December 31, 2023.

The Board of Directors of the Company, voted on December 30, 2021 to terminate the Plan, and filed an application with the Internal Revenue Service (IRS) for approval. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested. Approximately 95% of the Plan's assets were distributed in 2022. The remaining Plan assets were distributed in 2023.

#### **2. DESCRIPTION OF PLAN**

The following description of the Fred C. Church, Inc. Employees' Stock Ownership Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

Prior to termination, the Plan was a qualified, defined contribution retirement plan adopted by the Company on January 1, 1975. The Plan was designed to be an employee stock ownership plan within the meaning of Section 4975(e)(7) of the Internal Revenue Code of 1986, as amended (the "Code") and was designed to invest primarily in qualifying employer securities within the meaning of Sections 409(1) and 4975(e)(8) of the Code. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Three members of the Company's Board of Directors served as Trustees of the Plan through November 2021. Effective November 30, 2021, an independent third party was appointed Trustee of the Plan. The Company was the plan administrator.

## 2. DESCRIPTION OF PLAN (Continued)

### Eligibility

Prior to termination, employees of the Company were generally eligible to participate in the Plan upon the attainment of 1,000 hours of service, completion of a minimum of six months of service and were age 21 and over. Participants who did not have at least 1,000 hours of service during such plan year were generally not eligible for an allocation of Company contributions for such year.

### Contributions

Prior to termination, under the Plan, the Fred C. Church, Inc. Employees' Stock Ownership Trust (the Trust), invested primarily in securities of the Company and made distribution of such securities or cash to participants in the Plan. Under the terms of the Plan, the Board of Directors of the Company determined annually the amount of the contribution and whether the payment would be made in cash or securities of the Company. There were no contributions during the year ended December 31, 2023.

### Participant Accounts

Separate individual accounts were maintained for each participant. Each participant's account was credited as of the last day of each plan year with an allocation of the Company's contribution and plan earnings. Prior to termination, only those participants who were eligible employees of the Company as of the last day of the plan year would receive an allocation. Allocations were based on a participant's eligible compensation, relative to total eligible compensation.

### Vesting

Prior to termination, vesting was based on years of service. Participants vested 25% per year of credited service and were 100% vested after four years of credited service. Credited service was earned for each plan year in which the participant completed at least 1,000 hours of service beginning with the plan year in which participant's eighteenth birthday occurred.

Upon termination of the Plan, all participants became fully vested in their accounts.

### Forfeitures

Prior to termination, the balance in a participant's account which was less than 100% vested was forfeited when the participant incurred a one year break in service. Break in service was defined as a participant not completing more than 500 hours of service in the plan year. Forfeitures were allocated to the same persons and in the same manner as contributions.

### Payment of Benefits

Prior to termination, benefit payments could be made in a lump sum upon the participant's termination of employment, death, disability, normal retirement. A participant could elect to receive his or her distributions in either cash or shares. Participant payments were required to commence no later than the attainment age 72, with the exception that the participant was not a

5% owner and had not yet retired.

## 2. DESCRIPTION OF PLAN (Continued)

### Diversification

Prior to termination, diversification was offered to participants close to retirement so that they could have the opportunity to move part of the value of their investment in Company stock into investments which were more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan could elect to diversify a portion of their account.

Diversification was offered to each eligible participant over a six-year period. In each of the first five years, a participant could diversify up to 25% of the number shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changed to 50%. Participants who elected to diversify could receive a cash distribution.

### Withdrawals

No in-service withdrawals were permitted.

### Voting Rights

Prior to termination, the Trustees voted all shares of common stock of the Company be held as part of the Plan Assets. However, each participant or beneficiary in the Plan was entitled to direct the Trustees how to vote their allocated shares of common stock with respect to matters involving a corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction as prescribed in regulations.

### Put Option

Prior to termination, the Plan had the right of first refusal to repurchase shares from terminated employees. In the event that it did not, the Plan provided for a put option which required the Company to repurchase the vested shares of the terminated participants at the current appraised value at the time of repurchase.

## 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan as of and for the years ended December 31, 2023 and 2022 are prepared on the liquidation basis of accounting.

### Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### Subsequent Events Review

In preparing its financial statements, the plan administrator has evaluated events and transactions for potential recognition or disclosure through October 3, 2024, the date the financial statements were available to be issued.

#### Investment Valuation and Income Recognition

As of December 31, 2023, the Plan had no assets or liabilities.

The Plan's interest-bearing cash included cash in money market accounts as of December 31, 2022.

Interest was recorded on the accrual basis as earned.

#### Benefit Payments

Benefit payments were recorded when paid.

#### Administration of Plan Assets

Prior to termination, the Plan's assets, consisted principally of the Company's common shares, which were held by the Trustees of the Plan.

Prior to termination, Company contributions were held and managed by the Trustees, which invested cash received, interest, and dividend income and made distributions to participants.

Certain administrative functions were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

### 4. INCOME TAX STATUS

The Plan obtained its latest determination letter on October 22, 2013, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Subsequent to this determination letter by the IRS, the Plan was amended. The plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Prior to termination, the stockholders of the Company, including the Plan, elected to be taxed under the provision of Subchapter S of the Internal Revenue Code. Accordingly, no provision for federal income taxes and certain state income taxes was recorded in the financial statements of the Company for the years ended December 31, 2023 and 2022, because the stockholders were generally liable for such taxes on their income tax returns. However, the Plan, as qualified by the IRS, was exempt from income tax and not liable for its proportionate share of such taxes as a stockholder of the Company.

#### 4. INCOME TAX STATUS (Continued)

Accounting standards require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.


