INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the accompanying financial statements of Sparkle Maintenance, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 8, 2022 (in liquidation) and December 31, 2021 (in liquidation) and the related statements of changes in net assets available for benefits for the periods then ended (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's 2021 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended March 8, 2022 and December 31, 2021, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Opinion (Continued)

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Sparkle Maintenance, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 2 to the financial statements, the governing body of Sparkle Maintenance, Inc. 401(k) Profit Sharing Plan approved a plan of liquidation on October 19, 2021, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis to the liquidation basis used in presenting the March 8, 2022, and December 31, 2021 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sparkle Maintenance, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Sparkle Maintenance, Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN

The following description of the Sparkle Maintenance, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan, covering substantially all employees of Sparkle Maintenance, Inc. (the Company, Sponsor, Employer, or Plan Administrator). The Plan was subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

Some administrative functions were performed by employees of the Company. No compensation was remitted to the Company for these services.

Plan assets were held and managed by Ascensus Trust Company, which invested contributions and Plan earnings, made investment transactions as directed by the Plan Administrator. Ascensus, LLC provided certain recordkeeping services and acted as the third-party administrator for the Plan.

Eligibility

Employees became a participant of the Plan when they were twenty-one and completed six consecutive months of eligibility service and worked at least 500 hours. Entry to the Plan was monthly on the first day of each month of the plan year for all contribution types.

Contributions

Each year, participants could contribute up to 100% of pretax annual compensation and allowed for Roth elective deferrals, as defined by the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan.

Employer Profit Sharing Contributions

Each year the Company may contribute to the Plan a discretionary amount designated by the Board of Directors. The profit-sharing contribution is allocated to each participant's account based on pre-determined allocation groups as specified in the Plan document. A Plan participant is qualified to receive an allocation of the employer profit sharing contribution if the participant has satisfied all of the eligibility requirements on at least one day of the Plan year, is employed on the last day of the Plan year, and has completed six months of service and at least 500 hours with the employer.

Sparkle Maintenance, Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN (Continued)

Safe Harbor Non-Elective Contributions

The employer safe harbor matching contribution equals 100% of each participant's elective deferrals up to 4% of compensation for the Plan year. For ACP safe harbor match contributions, the Company will decide from year to year whether to make any ACP safe harbor 401(k) matching contributions. The ACP safe harbor matching contributions are based on the percentage of compensation that the participant contributes to the plan.

Qualified Nonelective Contributions (QNEC)

The Company may make a qualified nonelective contribution (QNEC) to all eligible Plan participants who are not highly compensated employees using a pro rata formula. Under the formula, employer contributions are divided among all eligible plan participants who are not highly compensated based on their compensation compared to the compensation of all eligible participants.

Participant Accounts

Each participant's account is credited with the participant's salary reduction contribution, an allocation of the Company's matching contribution, an allocation of the nonelective contribution, an allocation of the Company's profit sharing contribution, and the actual earnings on the participants account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and safe harbor contributions, plus actual earnings thereon. Vesting in profit sharing and matching contributions is based on a six- year graded vesting schedule depending upon years of service, as shown below. A participant must work at least 1,000 hours during each Plan year to earn a year of vesting service.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal installments. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution.

At age 59 ½, active participants could receive an in-service withdrawal of all or portion of their accrued benefits. Participants could request a distribution of their rollover contribution accounts at any time and any age.

Forfeitures

Forfeited non vested accounts totaled \$0 and \$518 for the Plan period ended March 8, 2022 and December 31, 2021, respectively. No forfeitures were used to reduce employer contributions during 2022. In 2021 \$12,634 of forfeitures were used to reduce employer profit sharing and safe harbor contributions.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant could request a financial hardship withdrawal if they experienced a severe financial hardship. The participant had to meet the condition that they cannot relieve the amount of the need by stopping the elective contributions to the Plan. The financial hardship withdrawal could not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever was less.

Plan Termination

During the 2021 Plan year, the Company and Plan Sponsor was sold to a third party. As part of this sale, the Company terminated substantially all employees effective July 31, 2021 and no further contributions were made to the Plan. The Plan formally authorized the termination of the Plan on October 19, 2021. All participants were made 100% vested in Plan benefits due to the termination.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Due to the sale of the Company and the effective termination of the Plan during the Plan year as described in Note 1 to the financial statements, the financial statements have been prepared using the liquidation basis of accounting.

Basis of Accounting (Continued)

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the investment advisers, and custodians.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Distributions to participants were recorded when paid.

Administrative Expenses

Certain expenses attributable to the general Plan administration are paid directly by the Company and are excluded from these financial statements. These expenses are displayed as administrative fees on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

Administrative expenses paid by the Plan may include distribution fees charged to participants' accounts and administrative Plan fees. During the period ended March 8, 2022, expenses of \$2,100 were paid by participants for distribution fees. During the year ended December 31, 2021 expenses of \$14,161 were paid by the Plan.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, June 9, 2023, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: PLAN TERMINATION

As described in Note 1, the decision to terminate the Plan was made on October 19, 2021 due to the sale of the Plan Sponsor. No further contributions were made to the Plan after this date and all participants were made 100% vested in Plan benefits due to the termination. In accordance with U.S. GAAP, the Plan has changed its basis of accounting used from the ongoing basis of accounting to the liquidation basis of accounting as of and for the year ended December 31, 2021.

As of December 31, 2021 the Plan accrued for expected costs and losses related to the termination of the Plan. Based on estimates, the Plan accrued expected costs of \$2,575 and investment losses of \$99,807 for the year ended December 31, 2021. There were no revisions in these estimates as of the period ended March 8, 2022.

All Plan benefits were paid out to participants effective March 8, 2022.

Note 4: INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan Administrator elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements has been derived from information certified to be complete and accurate by Ascensus LLC (an affiliate of Ascensus Trust Company), the custodians of the Plan, under such regulation:

- a) Total investments, at fair value, included in the statement of net assets available for benefits at March 8, 2022 (in liquidation) and December 31, 2021 (in liquidation).
- b) Investment income information included in the statement of changes in net assets available for benefits for the period ended March 8, 2022 (in liquidation).

NOTE 5: FAIR VALUE MEASUREMENTS (UNAUDITED)

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 8, 2022 and December 31, 2021.

Money Market Fund: Money market funds are open-ended funds that sell and redeem the shares at a price equivalent to the net asset value (NAV), which is calculated daily. The money managers aim to keep the NAV fixed at \$1 per share using special pricing and valuation conventions. The money market fund held by the Plan is deemed to be actively traded.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 6: TAX STATUS

The Plan document is a prototype non-standardized profit sharing plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the prototype Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
